*This Prayer to be used after the Prayer for the Royal Family in the Morning and Evening Service; or, when the Litany is read, after the Prayer "We humbly beseech Thee, &c."*

Almighty God, from whom all power is derived, we humbly beseech Thee to bless Thy Servant, His Excellency the Governor of this Territory; and grant that he may use the authority which Our Sovereign Lord the King hath committed into his hand, with Justice and Mercy according to Thy Blessed Will. Enlighten him with Thy Grace; preserve him by Thy Providence; and encompass him with Thy favor; that he may do all things for the advancement of Thy Glory; the good of Thy Church; the Honor of His Sacred Majesty; and the welfare of this Territory and People. **H**IS Excellency the GOVERNOR has been pleased to direct that the general objects of the following Bills about to be brought under

the consideration of the Legislative Council, be published for general information.

*By His Excellency's Command,  
ALEXANDER M'LEAY,*

*A Bill for repealing the Rate of Duty now imposed upon Foreign Oil imported into the Colony of New South Wales, and for imposing a higher Rate of Duty thereon.*

**T**HE Proclamation of the 16th October, 1828, imposing a rate of Duty at £5 sterling for every £100 in value, and so in proportion for any greater or less value upon all Goods, Wares, or Merchandise not being the growth, produce, or manufacture of the United Kingdom imported into the said Colony or its Dependencies, it has been considered that Foreign Oil may be imported under that Proclamation upon payment of that Duty; and it being desirable to protect the Colonial Fishery, it is proposed to increase the Rate of Duty upon Foreign Oil to £15 for every £100 of the value thereof, and so in proportion for any greater or less value.

*2. A Bill for the amendment of the Law respecting Pilots and Pilotage.*

It being desirable that the Pilots employed in Port Jackson should be encouraged to proceed further to sea, for the purpose of taking charge of ships and vessels about to enter Port Jackson, it is proposed that when a Pilot boards a Ship or Vessel at the distance of Six Miles from the Heads, and within Ten Miles, he shall be paid in addition to the usual Rates £3.

At Ten Miles distance and within Fifteen £5.  
At Fifteen Miles distance and within Twenty £8.

The Commander or Master of the Ship or Vessel to have the option of engaging or refusing to engage such Pilot except within the present Pilot distance.

*3. A Bill to enable the Proprietors of a certain Company carried on in the town of Sydney, in the Colony of New South Wales, under the name, style, and firm of "The Union Assurance Company of Sydney," to sue and be sued in the name of the Chairman of the said Company for the time being, and for other purposes therein mentioned.*

IV. intituled "An Act to continue for a limited time an Act of the Governor and Council of New South Wales, intituled 'An Act for regulating the Constitution of Juries, and for the Trial of Issues in certain cases, in the Supreme Court of New South Wales'; and to make further provision for Trial by Jury in criminal cases, in the said Colony," continued until the thirtieth day of June, One thousand eight hundred and thirty-five; and whereas the said first recited Act was, by a certain other Act of the said Governor and Council, passed in the fifth year of 5 Gul. IV. the Reign of His said Majesty, intituled "An Act to continue for a limited time An Act of the Governor and Council of New South Wales, intituled 'An Act for regulating the Constitution of Juries, and for the Trial of Issues in certain cases, in the Supreme Court of New South Wales; and to make further provision for Trial by Jury,'" further continued until the thirtieth day of June, One thousand eight hundred and thirty-six; and it is expedient further to continue the said first recited Act as hereinafter provided: Be it therefore enacted, by His Excellency the Governor of New South Wales, with the advice of the Legislative Council 2 Gul. IV. thereof, That the said first recited Act No. 3, continued until 30th June, 1837.

he, and the same is hereby continued in force from and after the said thirtieth day of June next, until the thirtieth day of June, One thousand eight hundred and thirty-seven.

II. And whereas it is expedient to remove all doubts concerning the power of the Justices assembled in Petty Sessions, for examining and correcting the Jury Lists, under the provisions of the said recited Acts respectively, to omit, or strike out of such Lists, the names of Men of bad fame and reputation:—Be it therefore declared and enacted, That the name of every Man

be struck out of bad fame, or of dishonest life, or of the Jury conduct, or of immoral character, or Lists. repute, shall, at the discretion of a majority of such Justices, be omitted or struck out of such lists accordingly.

By His Excellency Major General Sir Richard Bourke, K.C.B. Captain General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, with the Advice of the Legislative Council.

*"An Act to remove doubts concerning the validity of Grants to Land in New South Wales."*

**W**HEREAS, the Governors, Lieutenant Governors, and Persons administering the **Preamble.** Government of New South Wales, have from time to time, been authorised and empowered by His present Majesty, and His Majesty's two last Royal Predecessors, by Commission under the Great Seal, to grant and dispose of the waste Lands of New South Wales:—And whereas, in exercise of the power and authority in them so vested as aforesaid, the respective Governors Lieutenant Governors, or Persons administering the Government of New South Wales, have from time to time, made and issued Grants, or Conveyances of Lands, situated in the said Colony, to divers of His Majesty's Subjects; but such Grants, or Conveyances, have been made in the names of the said Governors, Lieutenant-Governors, or Persons administering the Government for the time-being, and not in the name of His Majesty, or of either of His Majesty's Royal Predecessors:—And whereas doubts have been entertained whether such Grants, or Conveyances, made and issued as aforesaid, by reason of the informality thereof, are valid in the law, or binding upon His Majesty, His Heirs and Successors:—And whereas, to remove such doubts, and to quiet the titles of all His Majesty's Subjects holding or entitled to hold any Lands in New South Wales, so granted or conveyed as aforesaid, His Majesty hath, through the Right Honorable Charles Viscount Glenelg, one of His Majesty's Principal Secretaries of State, graciously signified His Royal will and pleasure, that all Grants, or Conveyances of Lands, made by any such Governor, Lieutenant Governor, or Person lawfully administering the Government for the time-being, in the exercise, or supposed exercise, of the powers and authorities in them so vested as aforesaid, should be declared to be valid in the law, and binding upon His Majesty, His Heirs and Successors:—Be it therefore enacted, by His Excellency the Governor of New South Wales, with the advice and consent of the Legislative Council thereof, That all Grants, Deeds, or Conveyances at any time heretofore made and issued by or in

the name of any Governor, Lieutenant-Governor, or Person lawfully administering the Government of New South Wales, of any Lands situated in the said Colony, and notwithstanding such Grants, Deeds or Conveyances, shall not be in the name of His Majesty, or of either of His Majesty's two last Royal Predecessors, shall be, and shall be deemed, taken, and held to be, and to have been, from the respective dates thereof, as valid and effectual in the law to grant and convey such Lands, and shall be as binding upon His said Majesty, His Heirs and Successors, to all intents and purposes, as if such Grants, Deeds, or Conveyances, had been made and issued in the name of His Majesty, or of either of His Majesty's two last Royal Predecessors, and had passed and been executed under the Public Seal of the said Colony, and had been recorded, in the most regular form of law, anything in any Act, Law, Custom or Usage to the contrary in anywise notwithstanding.
