"An Act for ascertaining the Number of the Inhabitants of the Colony of New South Wales, in the Year One thousand eight hundred and thirty-six."

WHEREAS, it is expedient that provision should be made for ascertaining the Number, of Inhabitants within the Colony Preamble: of New South Wales, as well those who are free as those who are serving under sentence of transportation: Be it therefore en- Justices to acted, by His Excellency the Gover- cause notices nor of New South Wales, with the to be fixed in advice and consent of the Legislative conspicuous advice and consent of the Legislative places calling Council thereof, That on or before the first day of August, in this present year, One thousand eight hungive the indred and thirty-six, the Justices of formation rethe Peace, of the said Colony, in their quired by this respective districts, shall, and they Act. are hereby required and directed to cause general notices to be affixed on the several Churches, Chapels, Market Houses, and Court Houses, and on such other conspicuous places as they shall deem proper, within the said Colony, requiring every householder, employer of servants, and proprietor or occupier of land therein, to be prepared, upon the second day of September next ensuing, or on the days immediately subsequent thereto, to give all such information as is required by the Schedule hereunto annexed, marked A, to such persons as shall be appointed by the said Justices to collect the same.

(Justices to appoint persons to collect the information hereby required.)

II. And be it further enacted, That the Justices of the Peace, assembled in Petty Sessions, in the several districts of the said Colony, and in places where no Petty Sessions are held, any Justice of the Peace, acting singly, shall, on or before the fifteenth day of August next, appoint one or more fit and proper person or persons for each district, to collect the information hereby required, and the said persons shall, on the said second day of September next, and on the days immediately subsequent thereto, if one day shall not be sufficient, proceed to take an account in writing, of the number of persons at that time being within the limits of their respective districts, the aboriginal natives alone excepted, and inform themselves of

the several particulars specified in the said Schedule, distinguishing the County or reputed County, as well as the parish in the County of Cumberland, in which each such person shall be or reside, or whether beyond the boundaries prescribed for location to settlers; And the better to enable such persons to take such accounts, they are hereby authorised and empowered to ask such questions of the persons residing or being within their respective districts, concerning themselves and the number and quality of the persons constituting their respective families, and the trade or calling of every person above the age of twelve years, as shall be necessary to fill up the said Schedule, and every such person refusing or neglecting to answer or wilfully giving a false answer to any such question, shall for every such refusal or neglect, or false answer, forfeit and pay a sum not exceeding five pounds, nor less than forty shillings, at the discretion of the Justice or Justices before whom complaint thereof shall be made.

Persons so appointed, to deliver over to the Justices their accounts of inhabitants within a certain time.)

III. And be it further enacted, That the persons so to be appointed by the Justices or Justice as aforesaid, shall, within fourteen days after the said second day of September next, deposit with the Justices of the respective Petty Sessions, or with the Justice acting singly as aforesaid, the several original accounts so taken in writing and subscribed by them, and shall make affidavit to the same in the form contained in the Schedule hereunto annexed, marked B, before the said Justices or Justice, who are, and is, hereby authorised to take such affidavit, and shall answer all such questions as shall be put to them concerning such accounts by the said Justices or Justice, and if any such person shall fail or neglect to take such accounts, or shall knowingly make any false statements therein, or shall omit to deposit the same with the Justices or Justice as aforesaid, in manner hereby required, or shall refuse to answer, or wilfully give a false answer to any such question, he shall, on conviction, forfeit and pay for every such offence, a sum not exceeding five pounds nor less than forty shillings.

(Justices to examine the accounts and to transmit an abstract thereof to the Colonial Secretary.)

IV. And be it further enacted, That the said Justices or Justice as aforesaid shall, as soon after the receipt of such original accounts as may be, appoint a convenient day for examining the same, at which the persons so appointed as aforesaid shall attend. to answer all such questions as shall be put to them touching such accounts, and the correctness thereof, and such Justices or Justice shall make a note of any apparent error therein, and shall cause an abstract of such accounts to be made according to the Form contained in the Schedule hereunto annexed, marked C, and shall subscribe a certificate in the terms therein set forth; and if the District for which such Justices or Justice shall act shall compromise more than one county, or parish in the county of Cumberland, such Justices or Justice shall transmit a separate abstract in the Form before mentioned of the persons residing or being in each such county, reputed county, or parish in the County of Cumberland, as well as for such as reside beyond the boundaries prescribed for location to settlers, and shall subscribe the same in manner aforesaid, and such Justices or Justice shall, on or before the first day of November next, transmit to the Colonial Secretary, the said abstracts, together with the said original accounts and the notes of apparent error, if any, as aforesaid; and if any Justice shall fail or neglect to perform the duties required in the premises, or any of them, he shall forfeit and pay the sum of fifty pounds, to be sued for and recovered in the Supreme Court.

(Justices of the Peace to communicate with the Justices of adjoining districts, and fix boundaries.)

V. And be it further enacted, That the Justices of the Peace in each district shall, and they are hereby required to communicate with the Justices of the nearest district, and with any Justice acting singly in every direction around them, to fix the boundaries of their respective districts, in order to prevent any omission or repetition of the number of inhabitants in any district, and the Justices of the Peace of the most remote districts shall, and they are hereby required to consider all the country occupied by settlers or stock-keepers beyond them, as forming a part of their respective districts, whether the same be within the boundaries of the Colony prescribed for location to settlers or not, and to take an account of the population thereof accordingly.

(Allowance to the persons appointed by the Justices.)

VI. And be it further enacted, That it shall be lawful for the Justices in Petty Sessions, or any single Justice as aforesaid, to cause an allowance for the number of days which any such person shall be actually employed in taking such account as aforesaid, at a rate not exceeding seven shillings and six pence a day, to be paid to the persons so to be appointed as aforesaid.

(Fines to be recovered in a summary way.)

VII. And be it further enacted, That all the fines imposed under and by virtue of this Act, shall be recovered in a summary manner before any one or more Justice or Justices of the Peace, unless hereinbefore otherwise provided, and if not immediately paid, shall be levied by distress and sale of the offenders' goods and chattles, by virtue of a warrant under the hand or hands and seal or seals of such Justice or Justices, rendering to the said Offender the overplus (if any) after the charge of such distress and sale shall be deducted; and in case sufficient distress shall not be found, then it shall be lawful for such Justice or Justices to commit such offender to the common gaol, there to remain without bail or mainprize for a term not exceeding three months, unless the said fine and charges shall be sooner paid; and all Appropriafines imposed by this Act, when re- tion of fines. covered, shall be paid one half to the informer or person who shall sue for the same, and the other to the Treasurer of the said Colony, to be applied towards defraying the expense of carrying this Act into execution.

HIS Excellency the Governor has been pleased to direct the publication of the general objects of the following Bill, about to be brought under the consideration of the Legislative Council.

By His Excellency's Command,
ALEXANDER M'LEAY.

"A Bill to promote the Building of Churches and Chapels, and to provide for the maintenance of Ministers of Religion in New South Wales."

N conformity to the principles upon which His Majesty's Government have been pleased to sanction contributions from the Colonial Revenue towards the support of public religion in this Colony, it is proposed to enact as follows:—

1. That whenever a sum not less than £300 shall have been raised by private contributions towards the building of a Church or Chapel, and Minister's dwelling, the Governor, with the advice of the Executive Council, to be authorised to issue from the Colonial Treasury any sum not exceeding the amount of such private contributions, to the extent of £1,000, in aid of the undertaking.

2. The Governor, with the advice of the Executive Council, to issue stipends to officiating Ministers

at the following rates, namely :-

If there be a resident population of 100 adults, subscribing a declaration of their desire to attend the Church or Chapel of such Minister, £100 per annum.

If 200 adults, £150 per annum. If 500 adults, £200 per annum.

 If notwithstanding there be less than 100 adults the Governor and Executive Council to be authorised to issue, under special circumstances, a stipend of £100 per annum.

4. In places where there is no Church or Chapel, and there is reasonable ground for delaying the erection of the same, the Governor, with the advice of the Executive Council, to be authorised to issue any sum not exceeding £100 towards the stipend of a Minister, in aid of private contributions to the same amount, such contributions not being less than £50.

5. Trustees not less than three in number, to be appointed for every Church or Chapel by the private contributors towards the same; to which Trustees the real estate therein shall be conveyed, and who shall receive and account for sums issued in pursuance of this Act.

Free sittings to be reserved in every Church or Chapel, to the extent of one fourth of the whole, for the use of poor persons.

7. Trustees to be appointed for Churches or Chapels already erected.
