Case No. 126 .- HENRY M. BAGSTER, Gentleman. One hundred and thirty-five perches, more or less, in the county of Cumberland, town of Sydney, parish of Saint Phillip, allotment No. 2 in section No. 85; bounded on the east side by the street, bearing south 4 degree, east 60 feet; west 1 degree, north 16 feet; and south 1 and two-thirds degree, west 83 feet; on the south side by a line bearing west 101 degrees, north 348 feet; on the west side by Gloucester-street, bearing north 331 degrees, east 94 feet; and on the north side by Cornwall Lane, bearing east 304 feet.

This allotment was originally leased to William Gaudry, by Governor Macquarie, for twenty-one years from the 1st January, 1810. It has been for many years in the possession of Mr. Garling, who has assigned it to claimant, as the representative of certain parties resident in London.

Case No. 127.—George Howell, Miller, of Partamatta.

Forty perches. County of Cumberland, parish of St. John, town of Parramatta, allotment numbered 49 in section No. 18; bounded on the west by a line 2 chains, 55 links; on the south by a line 91 links; on the east by a line to Georgestreet 2 chains 55 links; and on the north by that street 91 links.

This allotment was leased by Sir Thomas Brisbane to John Bishop, deceased, for twenty-one years from the 30th June, 1823. Bishop, it is alleged, bequeathed to his wife, Rebecca Bishop, on certain conditions, which were not fulfilled, and the allotment became the property of claimant.

Case No. 128.—Henry Harvey, Parramatta, Gentleman.

Forty-eight perches, County of Cumberland, parish of the Field of Mars, town of Parramatta, allotment numbered 4 in section No. 8; bounded on the north by Burgin's allotment 185 links; on the west by a line 150 links; on the south by Pennant-street 215 links to the Windsor Road; and on the east by that road 145 links.

This allotment is leased by Sir Thomas Brisbane to Sarah Harvey, the wife of claimant, for twentyone years, from the 30th June, 1823. Claimant alleges that this was done in mistake, during his absense from the Colony. One Rose Kennedy is mentioned in the Surveyer General's map as the occupant. Harvey claims a Deed of Grant on the expenditure of upwards of £1000.

Case No. 129.—HENRY HARVEY, of Parramatta, Gentleman.

Three hundred and seven perches, in the County of Cumberland, parish of the Field of Mars, town of Parramatta, allotment No. 1 of section No. 11; bounded on the south by Ross-street, east 354 links from the corner of John Duck's allotment; on the east 473 links; on the north by Grose-street, east the 200 acres, so as to give this claimant a Deed

named, bearing south 6 degrees, east 238 links to the corner of John Duck's allotment, west 107 links; and south 6 degrees, east 238 links.

This land was advertised with a view to the preparation of a Deed of Grant (in the Gazette of 12th January, 1832), in the name of John Hill Blanchard, deceased. Claimant alleges, that it was sold to him by Edward Blanchard, the administrator of the said deceased. It appears that this land comprehends six allotments—one promised to Blanchurd, and the other five purchased by him from various individuals

The Deed is claimed on the expenditure of upwards of £1000.

Case No. 130.—Henry Harvey, of Parramatta, Gentleman.

Sixty-nine perches, in the County of Cumberland, parish of the Field of Mars, town of Parramatta, allotment numbered 8, in section No. 9; bounded on the north by part of William Cox's and John Staff's allotments south 851 degrees east 103 links; on the east by Ann Curtis, allotment south 6 degrees west 226 links; on the south by Pennantstreet west 107 links; and on the west by Robert Gooch's allotment north 6 degrees east 260 links.

This allotment was advertised in the Gazette of 12th January, 1832, with a view to the preparation of a Reed of Grant in the name of William Smith, whose title, it is alleged, was sold by the Sheriff to claimant, who requests a Deed on the expenditure of upwards of £1,000 on this and the adjoining allotment, purchased by him of Gooch.

Case No. 131.—John Thorn, of Parramatta, Gentleman.

Fifty-seven perches, in the County of Cumberland, parish of St. John, town of Parramatta, allotment numbered 83, in section No. 16; bounded on the west by Church-street 1 chain 63 links; on the north by a line 2 chains 50 links; on the east by a line 1 chain 70 links to Macquarie-street; and on the south by that street, 26 chains 50 links.

This allotment is leased by Sir Thomas Brisbane for twenty-one years, from the 30th June, 1823, to James Wright, who, it is alleged, sold to Raine and Ramsay, who assigned to Randolph D'Acre, who sold to claimant, who proposes to obtain the deed by paying twenty-one years quit-rent.

Case No. 132.—Robert Potts, of Richmond,

One hundred acres, in the County of Cumberland, parish unnamed, situated at the Terrace, Kurrajong, or North Richmond; bounded on the south-east by the Hawkesbury River; on the south-west by William Bowman's 160 acres, now Rouse's, east, 40 degrees south 43 chains and 74 links; on the north-west by Puddefoot's land; and on the north-east by a line dividing it from the 100 acres of Jonathan Griffiths.

The land claimed is the south-western half of 200 acres promised to Jonathan Griffiths, (now absent from the Colony,) by Governor Macquarie, on two several orders for 100 acres each, dated 30th October, 1813. Claimant alleges that it was purchased by his wife, formerly Ann Griffiths, from one Elizabeth Kirby, to whom it was given by Jonathan Griffiths; reserving, however, two acres for a stock-yard, as well as a right of way for certain parties, viz.—Parnell, Plummer, and east by Villier's-street, bearing north 6 degrees, Thawly. The propriety of making a division of

Grant of his 100 acres, will be considered of by the Government, when the Commissioners have reported.

Case No. 133.—SARAH LOWE, Widow.

Twelve hundred and eighty acres, in the County of Philip, parish unnamed, at Wilbetree, near Mudgee, commencing at the south-west corner, and bounded on the west by a line north 184 chains; on the north by a line east 80 chains; on the east by a line south 150 chains to the Cudgegong River; and on the south by that River to the south-west corner aforesaid.

On the 10th January, 1829, an order for 1280 acres of land was issued by Governor Darling in favor of Miss Blachford, now Mrs. Beddek. Mr. and Mrs. Beddek, it is alleged, sold to Mr. Robert Lowe, deceased; who, before his death, made over the same to Mr. William Wentworth in trust for

claimant for ever.

Case No. 134.—George Loder.

Two thousand acres, County of Durham, parish of Darlington, commencing at the eastern extreme of the north boundary line of Nowland's land, at the River Hunter, and bounded on the south by a west line (bounding small farms on the north) of 175 chains to the Hunter; on the west and part of the north by the Hunter upwards to a point directly east of the eastern extreme of the north boundary line of Hoddle's land; on part of the north by an east line from that point on the River of 21 chains to the northern extreme of the west boundary line of Alexander M'Dougall's grant; on the east by that boundary line bearing south 80 chains; by the south boundary line of M'Dougall's grant, bearing east 25 chains to the River Hunter; and by the River Hunter upwards to the eastern extreme of the north boundary line of Nowland's

On the 15th October, 1824, an order for 2,000 acres of land was issued by Sir Thomas Brisbane, in favor of George Galway Mills, deceased, whose Executors, it is alleged, have sold to claimant.

Case No. 135 .- MARY THOMPSON, of Churchstreet, Parramatta.

One rood and eleven perches, in the County of Camberland, parish of St. John, town of Parramatta, part of allotment numbered 31, in section No. 3, commencing at the south-east corner, and bounded on the south by Campbell-street, bearing west 5 degrees north 244 links; on the west by the allotment claimed by Emanuel Marvin, bearing north 7 degrees east 105 links; on the north by Marvin's allotment, bearing east 12 degrees north 193 links; and on the east by the Sydney Road, bearing south 161 degrees east to the south-east corner aforesaid.

The Allotment, of which a portion is now claimed, is recorded as having been leased by Sir Thomas Brisbane for twenty-one years, from the 30th June, 1823, to John Thompson, the husband of claimant. It is alleged, that he, being a prisoner of the Crown, the lease was cancelled. This does not appear. Claimant purchased of one John Morgan, in 1819, who derived through several Individuals. The remainder of the Allotment was awarded to Emanuel Marvin, by Memorial No. 777.

Case No. 136.—HENRY FRANCIS SEYMOUR, Surgeon, of Richmond.

Two acres and twenty-nine perches, in the County of Cumberland, parish of Ham Common, and Witnesses, as the Cases will be heard con-

ney, Wheelwright, opposed by Mrs. Sharp, of Richmond, (formerly Mrs. Onus) and by Edward Lewis.

One acre, three roods, and three perches, County of Cumberland, parish of Ham Common, town of Richmond, allotments Nos. 1 and 2, of section No. 13; bounded on the north-east by a line dividing it from March-street, bearing west 19 degrees north 1 chain and 94 links; on the north-west by a line dividing it from east Market-street, bearing south 18 degrees west 8 chains and 34 links; on the south-west by a line dividing it from Lennoxstreet east 181 degrees south 2 chains and 9 links; and on the south-east by a line north 181 degrees east 8 chains and 43 links.

This allotment was originally No. 1, ana was located to Joseph Baylis, senior, deceased, who died intestate; claimant is his eldest son and heir at law. At present this allotment is divided into two portions, Nos. 1 and 2, and Mrs. Sharp claims No. 1. Baylis, the claimant, alleges that one John Baylis was allowed by Joseph Baylis, senior, a temporary occupancy only of No. 1; but Mrs. Sharp alleges that Mr. Cox located No. 1 to John Baylis, who sold to his son Edward Baylis, who sold to Joseph Onus, deceased. Mrs. Sharp, however, is in possession of one-half only of the present allotment, No. 1, the other half is in possession of Edward Lewis, who, it appears, purchased from one Richardson, who purchased from John Baylis.
