"An Act to continue until the 31st day of December, one thousand eight hundred and thirty-nine, and from thence to the end of the then next Session of Parliament, 'An Act of the ninth year of the reign of His Majesty King George the Fourth, for the Administration of Justice in New South Wales and Van Diemen's Land.'" [27th July, 1838.]

WHEREAS, an Act was passed in the ninth year of the reign of His Majesty George 9th Geo. IV, the Fourth, intituled, "*An Act to cap. 83. 'provide for the Administration of Justice in New South Wales and Van Diemen's Land, and for the more effectual Government thereof, and for other purposes relating thereto.'*" And, whereas, the said Act is near expiring, and it is expedient to continue the same;—Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, that the said Act shall be continued until the thirty-first day of December, one thousand eight hundred and thirty-nine, and from thence to the end of the then next Session of Parliament.

PUBLIC ACCOUNTS.

ALL Persons having claims on the Colonial Treasury are requested to furnish their Accounts through the proper channel before the end of the year, or as soon thereafter as practicable.

The several Collectors and Officers in the receipt of Public Monies will pay over to the Colonial Treasurer, on or before the 31st of the present month, the amount of all collections remaining in their hands, respectively, up to that date, so that the entire Revenue collected by each may be credited in the accounts of the year within which it was received.

The Heads of Departments and other Officers who have received advances to enable them to defray expenses incurred under their superintendence are requested to furnish to the Audit Office, as far as practicable, and with all convenient despatch, the accounts of the expenditure thereof, and on or before the last day of the current month to pay into the Colonial Treasury the unexpended balance of such advances, that the adjustment of the same may appear in the accounts to the 31st instant.

They will also, as soon as practicable after the close of the year, bring forward all accounts of expenses incurred within the same, which do not admit of being previously settled, so that, if possible, all the expenses incurred in the present year may be finally adjusted and liquidated within one month after its termination.

In the event of a difference of opinion between the Contractor and the Party receiving the supply as to its quality, the same is to be decided in the following manner:—The Party objecting will name one Person as Arbitrator, the Contractor or his Agent another, these two will (previously to any other proceeding on their part) concur in naming a third as Umpire, who, in the event of the Arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final. And should it be decided that the article is not of proper quality, it must be immediately replaced by the Contractor, failing which it will be procured and the expense charged to his account.

14. It will be in the power of either Party to limit the duration of the Contract by giving in writing a Notice of three calendar months to the opposite Party, and to end the Contract at the expiration of that period, it being understood that such Notice can be given only from the first day of a Month.

15. The Contractor will be required to prepare his own account monthly, according to the prescribed form; and on the production thereof, with the requisite vouchers in a complete state, will receive payment either in British Silver Coin, or by a Bill on Her Majesty's Treasury at the es-

established rate of the period, at the option of the Senior Commissariat Officer.

16. The value of all packages to be included in the prices demanded.

17. Persons wishing to Tender are requested to apply either at this Office, or, to the Commissariat Officers in charge at the several Stations, who will furnish them with Printed Forms for the purpose, and communicate further particulars; and as adequate security will be required for the due fulfilment of the Contracts, each Tender must be accompanied by a letter for the Parties proposed as such, stating that they are willing to become bound as securities for the Contractor accordingly; and no payment will be made upon any Contracts until the bonds have been executed; the expense of which, if any, is to be paid by the Contractor.

18. The amounts of the Bonds required in the several Districts are as follows, viz:—Sydney, £5,000; Parramatta, £2,000; Liverpool, £1,000; Myrtle Creek, £500; St. Vincent, £1,000; Cox River, £1,000; Illawarra, £500; Blue Mountain, £1,000; Bathurst, £1,000; Windsor, £1,000; Lower Hawkesbury, £200; Lower Hunter, £1,500; Upper Hunter, £300; Port Macquarie, £1,500.

19. All Tenders are to be enclosed in a separate envelope, addressed to the undersigned, and marked "Supplies for 1839."

20. Flour in place of Bread to be given for the Military Ration, *when required*, in the proportion of 14 2-7th ozs. of the former for 16 ozs. of the latter.

21. The Contractor for the District of Sydney will also be required to furnish the Government Vessels, or casual purposes, any of the supplies under the head of Hospitals.

22. The Rations and Articles particularised under the head of Provisions, No. 1 to 12, may be required not only for the purposes specified, but also for any other purpose of the Military and Convict services, should there be occasion for it.
