THE Legislative Council having met pursuant to summons, His Excellency the Governor took the Chair. New Members sworn:—His Excellency Major-General Sir Maurice Charles O'Connell, K.C.H., commanding Her Majesty's Forces in New South Wales and its Dependencies; and Phillip Parker King, Esq., Captain, R.N. His Excellency the Governor then read the following

GENTLEMEN OF THE LEGISLATIVE COUNCIL, I Conneil to a few fa would be highly a season of the year, in order to propose to you the measure for the establishment of a Police without providing, Force, beyond the settled districts of the Colony.

Address :-

The vast interests which have grown up in those distant parts of the Territory, and the number of persons of all classes now engaged in depasturing Sheep and Cattle beyond what are called the Boundaries of Location, might be sufficient of themselves to call for the protection of a Police Force; but the necessity for it is rendered far more urgent, by the frequent aggressions made of late by the Aboriginal Natives upon the Flocks and Herds of the Colonists, as well as on the lives of their Stockmen-by the outrages which have been committed on the Aborigines, as well as by them -and particularly by one atrocious deed of blood, for which seven unhappy men have suffered on the scaffold.

The Bill which I shall lay before you proposes to accomplish its objects, by giving to the Crown Commissioners, who already perform certain functions in those districts, far more ample powers than they now possess; and by providing that each Commissioner shall be accompanied by a moving Police Force, sufficient to repress the predatory attacks of the Natives, and to keep order amongst all classes

As it appears to me perfectly just, that the persons who are to be protected by this Force, should bear the expense of maintaining it, the Bill provides for this object, by means of an assessment on Cattle and other Stock.

In proposing however a New Tax up n any portion of the people of this Colony, it not sufficient, I think, to shew that it falls pon persons who may properly bear it; it is f ther necessary to prove that the Tax itself carnot be dispensed with. Without therefore en ering into any elaborate statement of finance which at the present season of the year would be premature, I will request the attention of the Council to a few facts, tending to shew that it would be highly unwise, in the present state of our Finances, to incur any new expenses without providing, at the same time, the means of defraying them.

The total Revenue of the year 1838, exclusive of Crown Lands, was £202,960 7s 5d, being £26,739 12s 7d, less than it was estimated at by Sir Richard Bourke: The total expense for the same year, 1838, (exclusive of Immigration), cannot yet be exactly ascertained; but it may be taken at about £295,000, being an excess over the Revenue of the year, of upwards of £92,000.

The excess of Expenditure over Income, for the present year must be taken, I am sorry to

say, at a still higher sum.

In the Financial Minute, which I laid before the Council on the 7th August last, it was estimated at £100,798 6s 4d.; since that time. however, new charges have arisen, which are to be provided for; and the increased price of provisions of every description, has caused all our Contracts to be made at a higher rate than that which is set down in the Estimates. The excess of Expenditure over Income, for the year 1839, will therefore, I now apprehend, be much greater than what I considered probable in August last.

This excess of ordinary Expenditure, over ordinary Income, though greatly increased within the last two years, is not one altogether of sudden growth; for, from the most accurate accounts I have been able to procure of the three preceding years, viz, 1835, 1836, and 1837, I find there was an aggregate excess of Expenditure over Income, in those three years, of about £100,000; so that in no year since 1834, would it have been possible to keep the Expenditure of the year within its Income, without either stopping the Public Works, or adding to the Taxation of the People.

Gentlemen, I have thought it right that these circumstances should fairly be placed before you, though there is nothing in them that ought, in my opinion, to occasion the slightest degree of alarm; and I am fully persuaded that, by cautious and prudent measures, the appearance even of embarrassment may be avoided. Economy, however, is necessary-not descending to parsimony, which would be unwise in a new and rising State-but an economy which will People than to repress them.

I have never ceased, since I entered on the Government, to express my determination to enforce such an economy; and, however arduous and unpleasant the task, I trust, Gentlemen, with your assistance, to be able to accomplish it.

EAST MAITLAND.

Commencing at the north-west corner of Goldenham's 500 acres, and bounded on the south by his northern boundary line bearing east; then by its continuation as the northern boundary of a portion of 320 acres reserved for the extension of the Town; and further easterly at the northern boundary line of Davis' 200 acres to the north-cast corner thereof; on part of the east by a line bearing north about 100 chains; on part of the north by a line bearing west to a southerly continuation of Eckford's eastern boundary line; on the remainder of the east by that continuation and by the said boundary line bearing north to E. DEAS THOMSON. his north-east corner; again on the north by

Eckford's northern boundary line to the river; and on the residue of the north by Hunter's River to its confluence with Wallis' Creek; and on the west by Wallis' Creek southeasterly to the north-west corner of Goldenham's 500 acres as aforesaid.

#### WEST MAITLAND.

Commencing at the River Hunter at the confluence with the river of a creek dividing the allotments of Hall and Balcot; and bounded on part of the north by that creek so far as it bears westerly; thence by a continued west line to the south-west corner of Hall's allotment; on the west by Balcot's western boundary and its southerly continuation to P. F. Campbell's northern boundary line; again on the north by that boundary line bearing west to its north-west corner; again on the west by the western boundary line of Campbell and Luke Ralfe's lands to the north-west corner of J. T. Hughes' 4 acres; on part of the south by the northern boundary line of that land bearing east to Swamp Creek; on the remainder of the south and part of the east by that creek to its confluence with Wallis' Creek; and thence by Wallis' Creek to its own confluence with the River Hunter; and on the residue of the east and north by that river to its confluence with the creek, dividing the allotments of Hall and Balcot as aforesaid.

#### WINDSOR.

Commencing at a marked oak tree on South Creek to the south-east of the Court-house; from this tree by South Creek to a stake situated on the bank of the creek, on Fitzgerald's farm; from this stake by a line bearing west 91 chains to another stake; from this by a line passing the north fence of land belonging to the Benevolent Asylum, bearing west 34 degrees north 52 chains 80 links to a marked dead stump on Rickaby's Creek; from this stump by Rickaby's Creek to the Hawkesbury River; and by the Hawkesbury River to a stake nearly north of the Court-house; and from this stake by a line bearing south 28 degrees east 28 chains to the aforesaid marked tree on South Creek.
