Tappearing to the GOVERNOR that the condition of Female Convicts who are permitted to marry is imperfectly understood, His Excellency directs that the following particulars be published for general information, viz.:—

FEMALE CONVICTS.

1st. The marriage of a Female Convict with a Free Man operates neither as a pardon, remission of sentence, nor revocation of assignment; and notwithstanding her marriage, she continues subject to all the consequences of her sentence, and bound to serve and obey the master or mistress to whom she is assigned.

2nd. The Free Husband, who has taken a Convict Wife, is not entitled to bring her before a Court, or a Magistrate, to be tried and punished at his instance, for offences for which Convicts alone are punishable; inasmuch as by the effect of the marriage the condition of the convict has merged in that of the wife, and with respect to her husband she remains amenable to the law for those offences only, which, if she were free, might be made matter of complaint against her by him. With regard to the complaints of all other persons, the convict wife, notwithstanding her marriage, remains subject to the summary control of the Magistracy, as other prisoners of the Crown.

3rd. Upon the intermarriage of two Convicts, with the sanction of the Government, the wife is in all cases to be considered as immediately transferred, under the established regulations, to the service of the assignee of the husband; and the assignee is therefore bound to keep both parties in his service, and to maintain and control them, in the same manner as all other servants, until the husband obtains either his Freedom or a Ticket-of-leave, and until permission is obtained from the Government for the transfer of the wife to the husband.

WITH reference to the Government Notice of the 20th March, respecting the substitution of Meat for Flour, in consequence of the present scarcity of Grain in the Colony, His Excellency the Governor has been pleased to approve of the following substitution, being made by the Contractors whenever it may be found necessary, in the Ration of Convicts, male and female, in the service or employment of Government, until further notice, viz.:—

Two pounds of Beef or Mutton, or one pound and a quarter of Salted Pork, weekly, in lieu of three pounds of Bread, made from 10 per Cent. Flour, being the quantity which they receive; also, Rice may be substituted in place of the Maizemeal, in the proportion of twelve ounces of the former, for sixteen ounces of the latter.
