THE following descriptions of GRANTS OF LAND, with the names of the parties to whom they were originally promised, or by whom they are now claimed, are published for general information, in order that all parties concerned may have an opportunity of correcting any errors or omissions that may have been made inadvertently.

It is requested that within three months from the present date the particulars required by the Government Notice of the 1st October, 1838, may be accurately furnished to this Office, viz :-

Surname, and all Christian names of the person in whose navor the Deed is to be prepared, written at full length; his residence, and the intended name of the property.
