COUNCIL.

HIS Excellency the Governor is pleased to direct, that the general objects of the following Bill, about to be brought under the consideration of the Legislative Council, be published for general information.

By His Excellency's Command,
E. DEAS THOMSON.

"A Bill to repeal an Act relating to the Revenue of Customs in New South Wales, and to provide for the general Regulation thereof."

WHEREAS an Act of the Governor and Council of New South Wales, intituled, "An Act to Provide for the General Regulation of the Revenue of Customs in New South Wales," was passed in the Fifth Year of the Reign of His late Majesty King WILLIAM the Fourth, and it is expedient to Repeal the same, and make other Provision in lieu thereof, and to provide for the seizure and forfeiture of all Goods Exported or Imported contrary thereto, and of the Vessel or Vessels Exporting or Importing the same—It is proposed—

That every person employed on any duty relating to the Customs, whether appointed by the Commissioners of Her Majesty's Customs, or by the Governor of this Colony, shall be deemed to be an Officer of the Customs for such duty.

That every Officer of Customs who shall receive any Fee or Reward beyond such as he shall be authorised to receive, shall be dismissed; and that the person offering or promising the same, shall forfeit One Hundred Pounds.

That every Officer who shall make any collusive seizure shall forfeit Five Hundred Pounds.

That every person who shall make any collusive agreement with any Officer, shall forfeit Two Hundred Pounds.

That the Collector or other Principal Officer, with the sanction of the Governor, shall appoint the hours of general attendance.

That no Officer or other person employed in the Customs, shall be liable to serve in any other employment.

That no day shall be kept as a Public Holiday but such as shall be appointed by Proclamation, except Christmas Day and Good Friday.

That all affirmations or oaths shall be made before the Collector or other Principal Officer.

That persons convicted of making false affirmations or oaths, or of giving false evidence, shall be deemed guilty of perjury.

That Goods shall not be unladen at any Port in New South Wales, nor bulk broken after arrival of any vessel within four leagues of the coast, before entry of such Goods; and that Goods shall be unladen at such times and places, by such person or persons, and under such Officer or Officers only, as shall for that purpose be appointed.

That all Goods, Vessels, and Boats, which, by any law in force in this Colony, shall have been, or may be declared to be forfeited, shall be seized.

That Masters neglecting or refusing to bring to at proper stations, shall forfeit One Hundred Pounds.

That Officers may be stationed on board Ships, and if the Master of any such Ship refuse to provide any such Officer with suitable accommodation, he shall forfeit Twenty Pounds.

That Masters shall report the arrival of their Ships within twenty-four hours, and before bulk be broken, under penalty of One Hundred Pounds.

That the proper Officers may board Ships arriving, and remain on board till all Goods be duly delivered; and have access to every part thereof, with power to fasten Hatchways, and to mark, lock-up, seal, or otherwise secure Goods; and if any Goods be found concealed they shall be forfeited; and if any Packages so secured, be opened or secretly conveyed away, or if the Hatchway be opened after having been so secured, the Master shall forfeit One Hundred Pounds.

That persons entering Goods inwards shall deliver a Bill of Entry thereof, and shall pay down all the Duties due thereon before warrant be granted for unloading the same.

That every person who shall make an unauthorised entry, shall forfeit One Hundred Pounds.

That Goods may be landed and secured by proper Officer if Entry be not made within twenty days—and if the Duty due thereon, together with the charges of removal and custody of the same, be not paid within three months after such twenty days, the same may be sold.

That no Entry shall be valid, unless Goods be properly described therein; and that all Goods delivered out of any Ship or Warehouse, which shall not correspond in every respect with the particulars described in any such Entry, shall be forfeited.

That all Goods from the United Kingdom or British Possessions on which advantage is claimed shall appear upon the caskets or other documents, with the ground upon which such advantage is claimed.

That the expense of landing all Goods shall be borne by the Importer.

That all Bonds shall be taken by the Collector or other Principal Officer; and that all Bonds upon which no suit shall have been commenced within three years, shall be cancelled.

That all Goods exported, upon which any advantage is claimed as being the produce of this Colony or of Van Diemen's Land, shall be proved to be the produce of the same before certificate to that effect be granted.

That in certain cases, Goods may be entered by Bill of Sight, and landed for inspection of Importer, who shall make perfect Entry thereof within three days, and pay all Duties due thereon, together with the charges for removing and warehousing the same, otherwise the Goods to be sold.

That in all cases where duties are charged on value, such value shall be ascertained by declaration of Importer, except where there is reason to believe that Goods are under-valued, in which case the Importer shall make oath to the truth of the Invoice Price thereof.

That whenever any Importer shall refuse to pay the Duties fixed on such Goods, the same shall be sold within twenty days.

That Drawbacks shall be allowed in certain cases, and under certain restrictions; and that damaged Goods cleared for Drawback shall be sold, and the party clearing the same shall forfeit Two Hundred Pounds, or treble the Drawback.

That Exported Goods may be re-imported and entered by bill of store, provided the property in such Goods continue in the original Importer; and the Duties shall be the same on such goods as if they were then for the first time imported.

That Rent shall be charged on all goods warehoused.

That all Goods not cleared within three months from the Queen's Warehouse shall be sold, except such as will not pay the Duties, which may be destroyed.

That the Collector or other Principal Officer may appoint Warehouses.

That Goods may be warehoused without payment of Duties on first entry.

That the proper Officer shall take an account of all Goods to be warehoused, and mark the contents on each package; and that no such Goods shall be delivered except under the care of such Officers.

That upon Entry of Goods to be warehoused the Importer shall give Bond to pay Duties.

That Bonds given before the passing of proposed Act shall remain and continue in full force.

That Samples of Goods may be taken.

That upon Entry Outwards of Goods to be exported from Warehouse, Security in treble the Duties shall be given, that the same shall be landed at the proper Port.

That Goods may be re-gauged or re-weighed; and that the Duties chargeable thereon shall be according to the quantities so ascertained.

That Goods warehoused may be re-sorted or re-packed, and any part thereof destroyed, provided the same shall not prejudice the claim for Duty upon the original quantities; but that whole Packages may be abandoned for the Duties.

That Goods warehoused may be removed from one warehousing port to another under certain restrictions.

That the Governor may remit Duties on Goods lost or destroyed.

That Officers convicted of embezzling or destroying Goods shall be deemed guilty of misdemeanor, and if so convicted, through the instrumentality of the owner of such Goods, no Duty shall be charged thereon, and the damage occasioned thereby shall be made good to such owner.

That all Goods warehoused shall be stowed in such manner and in such parts as the Collector or other Principal Officer shall direct; and that the Warehouse shall be opened and visited at such times and in presence of such Officers only as the said Collector or other Officer shall direct.

That every Importer who shall gain unauthorised or fraudulent access to any such Warehouse shall forfeit Five Hundred Pounds.

That it shall be lawful for the Collector or other Principal Officer to sell all such Goods as shall not be cleared out of any such Warehouse within three years from entry of the same.

That all Goods entered to be warehoused, which shall not be duly so warehoused, or having been warehoused shall afterwards be taken out without due clearance, or having been entered for Exportation shall not be duly shipped, or having been so shipped shall afterwards be re-landed without permission, shall be forfeited.

That before any vessel outward-bound shall take in any Goods, the master shall deliver an entry outwards under a penalty of fifty pounds; and that before such vessel departs, the master shall deliver a true content of the Goods laden, with the names of the Shippers, and subscribe a declaration to the truth thereof, and truly answer on oath all questions that may be put to him, under penalty of One Hundred Pounds.

That no Goods shall be stated in the Certificate of Clearance to be the produce of the Colony unless expressly so stated in the Entry Outwards.

That all vessels trading with New Zealand, or with any Island in the South Seas, upon which there is no public European or American Settlement, and also all vessels employed in the Fisheries, shall be considered as being engaged in the Coast- ing Trade.

That all Goods carried or to be carried coast- wise, which shall be unladen or laden without due notice, shall be forfeited; and that the master of the vessel shall forfeit ten pounds.

That certain quantities of Tobacco and Spirits

shall be allowed Duty free to vessels fitting out for the Fisheries.

That Vessels found light shall be forfeited.

That Vessels not bringing to on being pursued may be fired into.

That no Vessel shall hoist any colour usually worn by Her Majesty's Ships, under penalty of Fifty Pounds.

That all Vessels' Boats, &c., used in the removal of Goods liable to forfeiture, shall be forfeited.

That Ships' Boats shall have Vessels' and masters' names painted thereon on pain of forfeiture.

That Shore Boats shall have owners' names painted thereon on pain of forfeiture.

That all Vessels with false bulk-heads, and all concealed Goods shall be forfeited.

That all Boats under register tonnage, employed in the removal of Goods, shall be licensed on pain of forfeiture.

That all Goods liable to Duties, and all prohibited Goods, which shall be clandestinely landed or otherwise removed, shall be forfeited, together with the Boats, Carts, Horses, &c., so landing or removing the same.

That any Officer of Customs, or Officer of Her Majesty's Navy on full pay, or any person authorised by the Commissioners of Her Majesty's Customs, or by the Governor, may seize Vessels, Boats, Goods, &c., liable to forfeiture wherever found.

That Officers may search Houses, stop and search Carts, &c.; persons preventing the latter to forfeit One Hundred Pounds.

That persons unshipping, or having custody of prohibited Goods, shall forfeit treble the value thereof, or One Hundred Pounds.

That persons offering prohibited Goods for sale shall forfeit the same, together with a sum equal to treble their value, or One Hundred Pounds.

That persons unshipping, or aiding, or being concerned in the unshipping Goods liable to forfeiture, shall forfeit One Hundred Pounds, or treble the value of such Goods.

That persons liable to be arrested and escaping may be afterwards detained.

That persons resisting Officers, or destroying Goods to prevent seizure, shall forfeit One Hundred Pounds.

That any person who shall shoot at any Boat, &c., in Her Majesty's Navy or Customs, shall be guilty of felony and suffer death.

That any person who shall be found in company with more than four other persons having with them any Goods liable to forfeiture, or in company with one other person within five miles of the coast, or of any navigable river, having any such Goods, and being armed or disguised in any way, shall be guilty of felony, and be transported for seven years.

That persons assaulting Officers may be transported.

That Vessels or Goods seized and condemned may be disposed of as Collector or other Principal Officer shall direct.

That the Governor may make allowance for support of poor persons confined for offences against proposed Act.

That one-half of all penalties shall go to the public uses of the Colony, the other to the persons suing for the same.

As to recovery of penalties and other legal proceedings under proposed Act.

LARNE LOUGH HARBOUR LIGHTHOUSE.

Ballast Office, Dublin.

18th October, 1838.

The Corporation for preserving and improving the port of Dublin, hereby give notice that a Lighthouse has been erected at the entrance of Larne Lough coast of County Antrim, from which a light will be exhibited on the evening of the 1st of February, 1839, and thenceforth from sun-set to sun-rise.

Specifications given of the position of the towers, &c., by Mr. Halpin, the Inspector of Lighthouses.

The Tower is built on Farres' Point, at the eastern side of the entrance to Larne Lough in lat. $54^{\circ} 50' 55''$ N., and long. $5^{\circ} 48' 0''$ W. of Greenwich, and bears from the Maiden Rocks North Lighthouse S.W. $\frac{1}{4}$ W., distant five sea miles; from the Hunter Rock S.W. by W. $\frac{1}{4}$ W., distant two and one-third sea miles from the Curran Point N.E. by E., distant three-quarter sea mile.

The Tower is circular, coloured white, having the lantern forty-seven feet over the mean level of the sea.

The light will be a stationary white light, shewing to the Lough and seaward from S. to E., and in clear weather may be seen at a distance of eight miles.

Shelving Rocks project from Farres' Point for half a cable's length from the Lighthouse.

The bearings given are magnetic, Var. $27^{\circ} 30'$.

COUNCIL.

THE Legislative Council having met this day pursuant to Summons, His Excellency the Governor took the Chair, and read the following Address.

WILLIAM MACPHERSON,
Clerk of Councils.

Gentlemen of the Legislative Council,

In meeting you for the dispatch of the ordinary business of the year, I am happy to be able to congratulate you on the improved prospects which are opened to us, by the termination of the calamitous drought, under which the Colony was laboring during the whole of our late extraordinary sitting; by the abundant rains which have fallen in most parts of the Territory, the hopes of the Colonists have been revived; and though grain of every description will probably yet for some months retain a high price, I trust all fears of an afflictive scarcity have passed away.

Acting on the advice of my Executive Council, I adopted measures in the month of April last, to insure an importation of corn from the markets of India, or South America, before the supplies which are now fast flowing in from our Sister Colony, shall be exhausted. My arrangements on the occasion were so made, as not in all probability to lead to any charge upon the Public Purse of the Colony; should, however, the contrary prove to be the case, I shall trust confidently to the wisdom and liberality of this Council, to enable the Government to make good its engagements.

I am happy, Gentlemen, to have it in my power to inform you, that the measure which was adopted by this Council, at the commencement of our last year's Session, for admitting the public to our

debates, has met the approval of Her Majesty's Government: the Despatch which I have received from the Secretary of State on this subject, I shall lay before you.

I shall also lay before you a despatch which I have received from the Secretary of State, announcing the early intention of Her Majesty's Government to appoint an Officer, who will be vested with the powers, and will assume the character of British Consul at New Zealand. Upon this appointment being made, the Office of British Resident will be discontinued.

Papers and returns, shewing the progress of Immigration during the course of the last year, are in preparation, and will be speedily presented to you. I shall then propose to refer these papers to a Committee of the Council—as has been the practice in respect to papers on this most interesting subject, in each of the last few years.

I also propose to revive the Committee, which sat during the last year, on two bills, which I then presented to you for effecting an alteration in the insolvent laws of the Colony, and for the abolition of imprisonment for debt on mesne process. I sincerely hope some satisfactory measure may be adopted on each of these important subjects.

Among the public establishments of the Colony there is not, it seems to me, one of more vital importance than that of the Police, or one to which the attention of this Council can be more profitably directed. Notwithstanding the extent of these establishments, and the enormous expense of them, I continue to receive complaints of their insufficiency; and demands are so frequently made upon me for extensions in them, that I feel it desirable, before I proceed to any further executive measures, to seek the advice and assistance of such members of this Council, as are most conversant with the actual state of the Police, and with the wants of the Colony. I therefore propose to refer the whole subject of our Police establishment to a Committee, similar to that which sat upon them in the year 1835.

Among the bills which will be laid before you, there is one for the regulation of the Customs, by which however, it is not so much proposed to make an alteration in the law, as to collect into one Act all existing regulations, and to adopt certain improvements which have already been introduced into the law of the Customs in Great Britain.

Upon the important subject of the Education of the people, it is my intention to submit to you a proposal when I bring forward my financial statement for the year: the basis of the arrangement I shall then propose will be, that the schools under the immediate control, either of Government, or of a Board of Education, shall be established on the principle of the British and Foreign School Society—leaving to every religious community the option of continuing their own schools, or of founding new ones, on the understanding that they will still receive from Government pecuniary assistance towards the support of them, equal in amount to what they derive from private contributions.

The rise in the price of almost every prime necessary of life, consequent upon the late drought, and augmented perhaps by the increase in our population, has, I regret to say, caused all our existing contracts, and particularly those for forage and provisions, to be made at a rate vastly exceeding that of the last year—had it not been for this

circumstance, which was in a great measure unforeseen, I have reason to believe that the expenditure of the current year, would have been within the estimates already sanctioned by the Council.

The accounts of the receipt and expenditure of the last year, will be laid before you with as little delay as possible, as well as the estimates for 1840—I shall also, according to directions received from the Secretary of State, lay before you a copy of the official documents for 1837, contained in what is generally denominated the "Blue Book."

I am happy to be able to state, that the Revenue of the Colony continues to improve; and though our expenditure for the present year, must greatly exceed the gross amount of it, I see no reason to doubt, that, by wise and economical measures, we may yet avoid any pecuniary embarrassments; and even devote, to the important object of Immigration, the amount of net revenue which we derive from the sale of the unimproved lands of the Crown.
