## PROCLAMATION.

By His Excellency Sir GEORGE GIPPS, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice Admiral of the same, &c., &c., &c.

**W**HEREAS, by a certain Act or Ordinance of the Governor and Legislative Council, passed in the Second Year of the Reign of Her Majesty Queen VICTORIA, intituled "An Act for Regulating the Police in the Towns of Parramatta, Windsor, Maitland, Bathurst, and other Towns respectively; and for removing and preventing Nuisances and Obstructions, and for the better Alignment of Streets therein," it was amongst other things enacted that whenever the Governor, or Acting-Governor for the time-being, shall deem it expedient to extend the same to any other Town in the said Colony, it shall and may be lawful for the said Governor, or Acting-Governor for the time-being, to declare the same by Proclamation; Now, therefore, I, the GOVERNOR, in pursuance of the Power and Authority so vested in me by the said recited Act, by this, my Proclamation, do hereby direct that the Provisions of the said Act be extended to the Town of KILSO, in the County of Roxburgh.

**H**IS Excellency the GOVERNOR is pleased to direct, that the general objects of the following Bill, now under the consideration of the Legislative Council, be published for general information.

"A Bill to make further Regulation with respect to Trial by Jury in Criminal Issues in the Colony of New South Wales, and to amend the Form of Proceeding in Criminal Prosecutions in said Colony."

WHEREAS, the said Colony, hath of late years greatly increased in population, and a sufficient number of respectable persons qualified to act as Jurors is to be found in all parts of the said Colony, where Juries are required, It is proposed, that the trial of offences by a Jury of seven Commissioned Officers of Her Majesty's Sea or Land Forces should in future be dispensed with, and

that from and after the day of next ensuing, the same shall cease and determine, except on application of Her Majesty's Attorney-General, or any other Prosecutor, or by and on behalf of any Prisoner to be tried in the Supreme Court for any Treason or Felony, when the Judges of the said Court, if they in their discretion think fit so to do, may direct the Sheriff to summon a Jury of seven Commissioned Officers for the trial of such issue.

**H**IS Excellency the Governor is pleased to direct, that the general objects of the following Bill about to be brought under the consideration of the Legislative Council, be published for general information.

*By His Excellency's Command,*  
E. DEAS THOMSON.

*"A Bill to amend and extend an Act intituled,  
"An Act to repeal in part, and to amend and  
"extend the provisions of an Act' intituled  
"An Act to establish a Savings' Bank in New  
"South Wales, and to provide for the manage-  
"ment thereof, and for the security of deposits  
"therein."*

**WHEREAS**, it is expedient to amend and extend the said recited Act, it is therefore proposed—That none of the enactments therein shall be repealed except such as may be virtually repealed by the enactments of the proposed Act.

That the Governor of New South Wales shall be the President of the said Bank; and that the management of its affairs shall be vested in eighteen Trustees to be nominated by the said Governor, one of whom shall be styled "Vice President."

That the Vice President, or any four of the other Trustees attending any meeting, may frame rules and regulations for the management of the said Bank; and may revoke, alter, or modify the same; and make new or other regulations as occasion may require: Provided that no such regulations shall be deemed valid, or be acted upon, until the same shall have been confirmed by the Governor.

That the Vice President and any four of the other Trustees may appoint any fit person to be the Accountant of the said Bank, subject to the approbation of the said Governor; and that the Accountant of the said Bank shall give security, by bond, with two or more sufficient Sureties for the due discharge of his office.

That it shall be lawful for any one or more of the said Trustees, together with the Accountant, or in the event of his absence, for any two or more Trustees, at such time or place as shall be fixed by regulations, to receive from any person or persons, in the way of deposit, any sum of money, not being of value less than One Shilling nor more than One Hundred Pounds; and they shall then and there cause the money so received to be entered in a Book to the credit of the party making such deposit; and the amount of such deposit, and all other monies received at the Bank, shall, with all convenient speed, be paid into such one of the Colonial Banks in Sydney as shall be approved of by the Vice President and any four of the said other Trustees; and the same shall be

then placed to the credit of the said Savings Bank, in an account to be entitled "The Account of the Vice-President and Trustees of the Savings' Bank of New South Wales," and no money shall be withdrawn from such account without the written order of two or more Trustees.

That on any day or days appointed for the purpose, it shall be lawful for the Trustees then attending, not being less than four, to discount, at a rate of interest not less than £8 per cent. per annum, any Bill of Exchange or Promissory Note, for any amount not exceeding £1000, and bearing names of not less than two persons to be approved of by such attending Trustees, or the major-part of them, and payable at a period not exceeding six calendar months from the time when the same shall be discounted. And that it shall be lawful for the said attending Trustees, to lend any sum or sums of money upon the security of any lands and hereditaments of an estate or inheritance in fee simple in the said Colony, such lands and hereditaments being free from all incumbrances, (except quit-rents) and such loan not to exceed the amount of £2000 to any one person; and that it shall be lawful for the said attending Trustees to direct a valuation to be made of the said hereditaments at the expense of the person applying for the loan; and such lands and hereditaments to be so mortgaged as aforesaid, shall be conveyed to the Vice-President for the time-being of the said Savings' Bank in fee simple, and subject to a promise for redemption of the same on payment of all principal money and interest; and there shall be inserted in such mortgage, a power of sale in default of payment of principal money and interest, but such power shall not prejudice the right of the Savings' Bank to foreclose the equity of redemption of the said hereditaments; and that all bonds, mortgages, warrants of attorney, and other securities which have been or which shall hereafter be taken in the name of any person as Vice-President of the said Bank, for and on account of the Bank, shall and may be put in suit and be sued and prosecuted at law or in equity, in the name of the Vice-President for the time-being, in whose name the same may have been taken, or in the name of any person who shall or may have succeeded to that office at the time such proceedings shall be instituted.

That the said Trustees, or any five of them, shall within one calendar month after the close of every year, cause a balance sheet to be prepared, and shall certify to the best of their belief the correctness thereof, and shall within three days thereafter lay the same before the Governor for approval, and being approved, shall cause the same to be published in the Government Gazette.

That all mortgage deeds, and securities for money, (excepting Bills of Exchange and Promissory notes) or other obligatory instruments which may be taken and received in security for the repayment of any sums of money which shall be lent by the said Trustees from the deposits in the Savings' Bank, shall be placed in the Colonial Treasury.

That every person depositing with the said Trustees in one or more payments any sum not less than twenty shillings shall be entitled to receive interest upon the same at the rate of £5 per cent per annum.

That the said interest shall be payable on any days appointed for receiving deposits in the month

of January in every year, and if the same be not applied for by the party entitled thereto, it shall be added to and incorporated with the sum which may be then standing in the books to the credit of such party, and shall bear interest from the first day of the said month of January, at and after the rate aforesaid. Provided always that nothing in the proposed Act contained, shall entitle any free person by one or by successive deposits, to place in charge of such Trustees any sums exceeding four hundred pounds in the whole; and provided also that nothing therein contained, shall limit the amount of monies belonging to the estates of intestate persons, which may be paid into the said Savings' Bank, under or by virtue of an Act of the Governor of New South Wales with the advice of the Legislative Council thereof, passed in the first year of the reign of Her present Majesty, intituled, "An Act for the investment of monies belonging to intestate estates by the Supreme Court in the New South Wales Savings' Bank at Sydney," or shall limit the amount of monies which may be directed to be invested in the said Savings' Bank, under any order of the said Supreme Court; but the person who may be ultimately entitled to the same shall not be entitled to claim any other benefit by virtue of the proposed Act, beyond interest at and after the rate of £5 per cent. per annum upon the principal monies so invested.

That any person being the owner of any sum deposited in the said Bank, or of the interest thereon, may claim and receive the same on giving due notice of his intention to claim the same.

That no person being the Trustee or Treasurer of the said Bank, or being in anywise concerned in the management thereof, shall be allowed to deposit any sums of money therein, or to borrow any money therefrom, or to derive any benefit from any deposit made in such Bank.

That all rules and regulations aforesaid, shall be filed in the Supreme Court, and be evidence in law.

That infants may make deposits.

That in case any depositor die, leaving any sum or sums of money in the funds of the said Bank, which shall amount in the whole to the sum of Twenty Pounds, the same shall not be paid to any person claiming to be the representative of such deceased Depositor, unless on notice in writing, setting forth the demands on which he claims to be entitled to receive the same, nor unless the said notice shall have been published thrice or oftener in the *Government Gazette*, and in one or more of the newspapers of the Colony, and three calendar months at least shall elapse before any payment be made in satisfaction of such claim.

That nothing in the foregoing contained shall interfere with the legal title and claim of any representative.

That all monies, &c., shall be vested in the Vice President for the time being, for the use and benefit of the respective depositors.

That no Trustee shall be personally liable except for wilful neglect.

That the funds of any other Savings' Bank may be received by the Savings' Bank of New South Wales.

That it shall be lawful for the said Trustees by order of the Governor to receive from, or on behalf of any transported offender any sum or sums of

money whatever, and to pay to any such offender the principal and interest in such sums on a certificate from the Principal Superintendent of Convicts, that such offender is entitled to receive the same.

That after three calendar months notice in the *Government Gazette*, it may be lawful for the said Trustees, or a majority of them at a General Meeting to be held in the month of January in every year, with the consent of the said Governor, to reduce the rate or rates of interest hereinbefore mentioned.

That it shall be lawful for the Governor as occasion may require, to appoint Trustees for the districts of Parramatta, Liverpool, Campbell Town, Berrima, Goulburn, Bathurst, Penrith, Windsor, Richmond, Maitland, Port Stephens, Port Macquarie, and for such other districts as to him shall seem meet, to be signified by an order to that effect in the *Government Gazette*, and such appointment shall take effect immediately after such notification.

That an Accountant shall be appointed by the Vice President and Trustees of the Savings Bank in Sydney, for each of the aforesaid districts, who, upon giving reasonable security, shall in the presence and not otherwise of one or more of the district Trustees aforesaid, receive deposits from persons residing within his district, at such times and places as the district Trustees shall appoint, and all money so received shall be remitted to the accountant of the Savings' Bank in Sydney, on the first day in every month or oftener if required.

That depositors in country districts, may withdraw deposits upon like notices respectively as required from Sydney depositors.

That in case a country depositor die leaving any sum of money in the funds of the said Bank, the sum shall be paid only on the conditions hereinbefore provided in like cases in Sydney.

That district Trustees shall have no personal interest whatever in the funds of the Bank; and

That an Accountant may be a witness.

#### VACCINATION.

**I**N order to avert the calamities which must necessarily follow if the Small Pox be introduced into the Colony, and to keep up a constant supply of Vaccine Lymph, His Excellency the GOVERNOR directs it to be notified, that Children will receive Vaccination gratis if taken to any of the Public Hospitals, or Colonial Surgeons, throughout the Colony, every Tuesday, at eleven o'clock in the forenoon. But as the operation itself, without any proof of its having taken effect would be insufficient security to the public mind, His Excellency has been pleased to direct, that a charge of one shilling shall be deposited for every Child vaccinated, which sum will be returned on the presentation of the Child on the next Vaccination day.

His Excellency very strongly recommends to Parents and Guardians to avail themselves as early as possible of the means thus afforded to them of taking this necessary and proper precaution, with respect to all Children not already Vaccinated.

**H**IS Excellency the GOVERNOR, in pursuance of the Provisions of the Act of the Governor and Council 2 VICTORIA, No. 2, intituled "*An Act for Regulating the Police in the Towns of Parramatta, Windsor, Maitland, Bathurst, and other Towns respectively, and for removing and preventing Nuisances and Obstructions, and for the better Alignment of Streets therein*," has been pleased to direct with reference to the Notice inserted in the *Government Gazette* of the 26th of December last, and to the Proclamation of this date, the publication of the following descriptions of the Boundaries of the Towns of Bathurst and Kelso, viz.—

#### BATHURST.

Commencing on the Macquarie River, at the south-east corner; and bounded southerly by a line bearing south  $41\frac{1}{2}$  degrees west to Seymour-street, and by that street to its intersection with Piper-street; westerly by Piper-street to its intersection with Rankin-street, northerly by Rankin-

street, and by a line bearing north  $41\frac{1}{2}$  degrees east to the Macquarie River; and by that river upwards to the south-east corner as aforesaid.

#### KELSO.

Commencing on the Macquarie River, at the north-west corner of an allotment granted to John Cooke; and bounded south-easterly by a line bearing east 30 degrees north 70 chains; north-easterly by a line bearing north  $29\frac{1}{2}$  degrees west 131 chains; north-westerly by a line bearing west 35 degrees south 80 chains 33 links to the Macquarie River; and south-westerly by that river upwards to the north-west corner of the allotment granted to John Cooke as aforesaid.

#### ROADS.

**H**IS Excellency the GOVERNOR, with the advice of the Executive Council, having deemed it expedient to open and make a certain PARISH ROAD from KIAMA, in the County of Camden, to join the great road leading southward towards the Shoalhaven River, a description of which is subjoined; Notice is hereby given, that in conformity with the provisions of the Act of the Governor and Council, 4th William IV., No. 11, intituled, "*An Act for making, altering, and improving the Roads throughout the Colony of New South Wales, and for opening and improving the Streets in the Towns thereof*," a survey and tracing shewing the intended line of the said road are now deposited in the Office of the Surveyor-General; and all persons interested therein are requested to transmit in writing, addressed to the Clerk of the Executive Council, within one month from this date, any well-grounded objection which may exist to the formation of the said Road.

#### RATIONS.

**I**N consequence of the continued scarcity of Flour in the Colony, His Excellency the GOVERNOR is pleased to authorise, with reference to the Government Notice of the 20th March last, sanctioning the substitution of two pounds of Beef or Mutton, or one pound and a quarter of Salt Pork, for two Pounds of Seconds Wheaten Flour, in the weekly rations of Convicts, the further alteration of four and a half pounds of rice and six ounces of sugar, for three pounds of Seconds Flour for Convicts in Assigned Service.

The Weekly Rations which Assignees are au-

thorised to issue to their Convict Servants will then consist as follows, viz.—

9lbs. Meat  
4lbs. Seconds Flour  
4½lbs. Rice  
6 Ounces Sugar  
2 Ounces Salt  
2 Ounces Soap.

With such substitutions of Salt Meat for Fresh, or of Maize Meal for Flour, as are authorised by the Government Order of 29th June, 1831, provided only, that the quantity of Seconds Flour shall in no case be reduced below four pounds.

Parties are reminded that all applications for Agricultural Labourers and Mechanics, must be removed at these Sessions, as after the 1st day of October, ensuing, all former applications for Convicts of that description, will be cancelled in conformity with the existing Regulations.
