HER MAJESTY THE QUEEN having been pleased to command that

CHARLES JOSEPH LA TROBE, Esquire, shall be appointed Superintendent of the Settlement and District of Port Phillip, His Excellency the Governor directs it to be notified that a Commission containing such Appointment has been issued accordingly, under the Great Seal of the Territory, and the prescribed Oaths have been this day administered to his Honor in the presence of the Governor and the Executive Council.

The District of Port Phillip will comprise that portion of the Territory of New South Wales which lies to the south of the thirty-sixth degree of south latitude, and between the one hundred and forty-first and one hundred and forty-sixth degree of east longitude; within those limits his Honor the Superintendent will exercise the powers of a Lieutenant Governor, and all Officers of the Government and others are hereby required to render him obedience and respect accordingly.

His Excellency cannot allow Captain Lonsdale to be relieved from the duties with which he has been hitherto charged, as the chief organ of the Government at Port Phillip, without availing himself of the opportunity to express publicly the sense he entertains of the ability, zeal, and success with which that Officer has performed those duties, and labored to develope the resources of that important Settlement, under the peculiar difficulties attending its first formation and very rapid pro-

The services of Captain Lonsdale, however, will still be retained to the Government and the Public in his capacity of Police Magistrate for the Town and District of Melbourne.

O eligible Tenders having been received for Conveyance of the Post Office Mails, from and to the undermentioned places, in pursuance of an advertisement from this Office, bearing date 9th July, 1839, and inserted in the Government Gazette of 24th July, Persons disposed to Contract for their Conveyance for Three Years from 1st January next, are invited to send their offers, in writing, to this Office, until twelve o'clock on Monday, the 30th September next, endorsed " Tender for Conveyance of Mails in Cumberland." From and to Sydney and Windsor via Parramatta daily (Sundays excepted)

From and to Sydney and Campbelltown via

Liverpool daily (Sundays excepted)

It will be required of persons tendering to specify the rate demanded per mile, and payment will be made according to the number of miles actually run over and computed for the distance by the Surveyor-General.

Each Tender must be accompanied by a plan or model of the vehicle it is proposed to use, and each Contractor will be bound under a penalty of fifty pounds not to use any other description of carriage without the express permission of the Postmaster-General, accidents only excepted.

Each vehicle must be supplied with a commodious and secure box for the accommodation of the mail bags, and to be drawn by two horses, and not to carry more than three passengers, exclusive of the driver, under a penalty of five pounds for a breach of agreement in either case.

It is to be understood that the Mail is invariably to start at the hours as now or hereafter to be fixed by the Postmaster-General, and the Contractor to carry all bags or letters which may be delivered to him under the authority of the Postmaster-General,

or any of the Postmasters.

Each Contractor will be bound under a penalty of five pounds for each and every offence over and above the penalties provided by the Act of Council for the receipt or conveyance of any letter or packet by himself, or by any of his servants or passengers, to the prejudice of the Post Office revenue.

The drivers employed to be free men, and of certified good character, and the Contractor to be answerable for the conduct of his agents and

servants.

The Contractor will be liable to a fine of five shillings for every five minutes delay after the

specified time of starting.

The rate of travelling will not be less than seven miles per hour including all stoppages, under a penalty of five shillings for every ten minutes delay after the specified time of arrival.

All fines and penalties incurred under the agreement to be deducted by the Postmaster-General from the next quarterly payment falling due to the Contractor.

It is desirable that each party tendering, or an agent for him, may attend at this Office on the day appointed for opening the Tenders; and that each Tender may bear the signatures of two respectable and solvent persons, willing to enter into a bond with the Contractor for the safety of the Mails and the due performance of the Contract.

The hours of starting from each Post Office. and other particulars may be ascertained at the General Post Office, where parties proposing to tender are invited to apply.
