By His Excellency Sir George Gipps, Knight, Captain-General and Governor-in-Chief, of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, with the advice of the Legislative Council.

An Act further to continue for a limited time an Act intitled, 'An Act for regulating the Constitution of Juries, and for the trial of Issues in Certain Cases in the Supreme Court, of New South Wales.'

WHEREAS an Act of the Governor and Council of New South Wales, was passed in the second year of the Reign of His late Majesty King William the Fourth, intitled, "An Act 2 Wm. IV., for regulating the Constitution of Juries, and for the Trial of Issues in Certain Cases in the Supreme Court of New South Wales;" And whereas the said Act was, by a certain other Act of the said Governor and Council, passed in the fourth year of the Reign of His said Majesty, intitled, "An Act to continue 4 Wm. IV., for a limited time an Act of the No. 12. Governor and Council of New South Wales, intitled, 'An Act for regulating the Constitution of Juries, and for the trial of Issues in Certain Cases in the Supreme Court of New South Wales;' and to make further provision for trial by Jury, in Criminal Cases, in the said Colony," continued until the thirtieth day of June, One thousand eight hundred and thirty-five; And whereas the said first recited Act was, by a certain other Act of the said Governor and Council, passed in the fifth year of the Reign of His said Majesty, intitled, "An Act 5 Wm. IV., to continue for a limited time, an No. 25, Act of the Governor and Council of New South Wales, intitled, 'An Act for regulating the Constitution of Juries, and for

the trial of Issues in certain cases in the Supreme Court of New South Wales,' and to make further provision for trial by Jury." further continued until the thirtieth day of June, one thousand eight hundred and thirty-six; and whereas the said first recited Act was, by a certain other Act of the said Governor and Council passed in the sixth year of the Reign of His said Majesty, intitled, "An Act further to continue for a 6 Wm. IV., limited time, an Act intitled, 'An No. 15. Act for regulating the constitution of Juries, and for the trial of Issues in certain cases in the Supreme Court of New South Wales,' and to make further provision for trial by Jury," further continued until the thirtieth day of June, one thousand eight hundred and thirty-seven; and whereas the said first recited Act was, by a certain other Act of the said Governor and Council, passed in the seventh year of the Reign of His said Majesty, intitled, "An Act to further continue 7 Wm IV., for a limited time, an Act intitled, No. 9. An Act for regulating the constitution of Juries, and for the trial of Issues in certain cases in the Supreme Court of New South Wales," further continued until the thirtieth day of June, one thousand eight hundred and thirty-eight; and whereas the said first recited Act, as altered and amended by any or all of the Acts herein last recited, was, by a certain other Act of the said Governor and Council, passed in the first year of the Reign of Her present Majesty Queen Victoria, intitled, "An Act to further 1 Victoria, continue for a limited time, an Act No. 1. intitled, 'An Act for regulating the constitution of Juries, and for the trial of Issues in certain cases in the Supreme Court of New South Wales,'" further continued until the thirtieth day of June, one thousand eight hundred and forty; and it is expedient further to continue the said first recited Act, so altered and amended as aforesaid, as hereinafter is provided: Be it

Continued therefore enacted, by His Excellency until June, the Governor of New South Wales, 1842. with the advice of the Legislative Council thereof, that the said first recited Act passed in the second year of the Reign of His said late Majesty, as altered and amended by any or all of the Acts herein last recited, shall be, and the same is hereby continued in force, from and after the said thirtieth day of June next ensuing, until the thirtieth day of June, one thousand eight hundred and forty-two.

II. Provided always, and be it declared and enacted, that nothing in this Act contained shall be construed to alter or repeal, An Act intituled, 3 Vict., "An Act to make further regulation No. 11. with respect to trial by Jury in Criminal Issues in the Colony of New South Wales, and to amend the form of proceeding in Criminal Prosecutions in the said Colony."

By His Excellency Sir George Gipps, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, with the Advice of the Legislative Council.

"An Act to further continue for a limited time an Act intituled 'An Act to facilitate the Apprehension of transported felons and Offenders illegally at large, and of persons found with Arms and suspected to be Robbers.'"

WHEREAS an Act of the Governor and Legislative Council of New South Wales, was Preamble. passed in the Fifth year of the Reign of His late Majesty King William the Fourth, intituled

5 Wm. IV. "An Act to facilitate the Apprehension No. 9. of transported Felons and Offenders illegally at large, and of persons found with Arms and suspected to be Robbers;"

which said Act was by a certain other Act of the said Governor and Council passed in the Sixth year of the Reign of His late Majesty, intituled

6 Wm. IV. "An Act to continue for a limited time No. 17. an Act, intituled, "An Act to facilitate the Apprehension of transported

"Felons and Offenders illegally at large, and of persons found with arms and suspected to be Robbers," continued until the thirty-first day of August, one thousand eight hundred and thirty-eight; And whereas the said first recited Act was by a certain other Act of the said Governor and Council, passed in the first year of the Reign of Her present Majesty Queen Victoria, intituled

1 Victoria "An Act further to continue for a No. 2 limited time, An Act intituled 'An Act to facilitate the apprehension of transported Felons and Offenders illegally at large, and of persons found with Arms, and

"suspected to be Robbers," continued in force, except as to so much of the said Act as relates to the time of passing and execution of any Sentence of Death as in the said Act is mentioned, from and after the said thirty-first day of August then next, until the thirty-first day of August, one thousand eight hundred and forty; and it is expedient further to continue the said first recited Act in manner and to the extent hereinafter provided: Be it therefore enacted by His Excellency the Governor of New South Wales, with the advice of the Legislative Council thereof, that the said first recited Act of His said late Majesty, shall be, and the same is hereby continued in force, except as to so much of the said Act as relates to the time of passing and execution of any Sentence of Death as in said Act is mentioned, from and after the said thirty-first day of August, one thousand eight hundred and forty, until the thirty-first day of August, one thousand eight hundred and forty-two.

"An Act to continue for a limited time an Act, intituled 'An Act for preventing the Extension of the disease commonly called the Influenza or Catarrh, in Sheep and Lambs, in the Colony of New South Wales.'"

WHEREAS an Act of the Governor and Legislative Council of New South Wales, was passed in the Second year of the Reign of Her present Majesty, Queen Victoria, intituled,

2 Vict., No. 12. "An Act for preventing the extension of the disease commonly called the Influenza or Catarrh, in Sheep and Lambs, in the Colony of New South Wales," and the said recited Act will expire on the ninth day of October, One thousand eight hundred and forty, and it is expedient to continue the same for a limited time:

Be it therefore enacted, by His Excellency the Governor of New South Wales, with the advice of the Legislative Council thereof, That the said Act shall be, and the same is hereby
