NFORMATION having been received that the small-pox has been accidentally introduced into the Colony of the Cape of Good Hope, His Excellency the GOVERNOR directs the republication of the Notice of 29th July, 1839, with the view of again drawing the attention of parents and guardians to the importance of Vaccination.

In order to avert the calamities which must nea cessarily follow if the small-pox be introduced into the Colony, and to keep up a constant supply of Vaccine Lymph, His Excellency the GOVERNOR directs it to be notified, that children will receive Vaccination gratis, if taken to any of the Public Hospitals, or Colonial Surgeons, throughout the Colony, every Tuesday, at Eleven o'Clock in the forenoon. But as the operation itself, without any proof of its having taken effect would be insufficient security to the public mind, His Excel-LENCY has been pleased to direct, that a charge of one shilling shall be deposited for every child Vaccinated, which sum will be returned on the presentation of the child on the next Vaccination day.

His Excellency very strongly recommends to parents and guardians to avail themselves as early as possible of the means thus afforded to them of taking this necessary and proper precaution, with respect to all children not already Vaccinated.

NOTICE TO MARINERS. LIGHT AT ST. KATHERINE'S POINT, ISLE OF WIGHT.

> Trinity-House, London, 4th February, 1840.

Notice is hereby given, that the Light Tower, which has been for some time past in course of erection on St. Katherine's Point, in the Isle of Wight, being nearly completed,—the Light will be exhibited therein on or before the evening of the 1st March next, and thenceforth continued every night from sun set to sun rise.

The Light at the above Station will burn at an elevation of 178 feet above the level of highwater, and will appear as a fixed bright Light in all directions seaward.

#### DESCRIPTION.

Dark bay Mare, supposed to be in foal, faint star on the forehead, three black legs, the near hind fetlock white, long tail, two white saddlemarks, about fifteen hands high.

Brown Pony, cropped ears, hog mane, small star on forehead, fired in both fore legs, fetlock joint of the off hind leg much enlarged, several white saddle-marks on both sides, white spot on the rump bone near side, small white spot in the lower part of the neck on the off side.

Dark bay Horse, four black legs, high between the rump and withers, small faint white spot centre of forehead, same over the off eye, white saddlemarks on both sides.

### CROWN LANDS.
