MARKET.

THE GOVERNOR having laid before the Executive Council, a resolution adopted at a Public Meeting of the Inhabitants of Melbourne, held on the 21st January, 1841, in conformity with the provisions of the Act of the Colonial Legislature, 3rd VICTORIA, No. 19, in favour of establishing a Market within the said Town; His Excellency directs it to be notified, with the advice of the said Council, that He has approved of the establishment of a Market at Melbourne, accordingly.

His Excellency further directs it to be notified, that with the advice of the Executive Council, the Town of Melbourne has been divided into four Wards, and that the number of Commissioners to be elected for the management of the Market has been fixed at eight, viz., two Commissioners for each Ward.
