HIS Excellency the GOVERNOR is pleased to direct that the general objects of the following Bills, nowunder consideration of the Legislative Council, be published for general information.

By His Excellency's Command,

E. DEAS THOMSON.

No. 1.—" A Bill to amend an Act, intituled,
"An Act to provide for the periodical publication
of the Liabilities and Assets of Banks, in New

South Wales and its Dependencies, and the Registration of the names of the Proprietors thereof."

Whereas by the Act 4 Victoria, No. 13, the members of any Banking Company, established by ROYAL CHARTER, are exempted from liability for any debt incurred by the Company, except so far as such members may be liable under the provisions of the Charter;—it is proposed to extend the like exemption to the members of any Banking Company established by LETTERS PATENT.

No. 2.—" A Bill to permit goods, the product or "manufacture of New Zealand and Van Diemen's "Land, to be imported into the Colony of New "South Wales, free of Duty; and to indemnify "certain Officers for acts already done."

Whereas the free importation into New South Wales of goods and manufactures, the product of New Zealand and Van Diemen's Land, may be productive of considerable commercial advanteges; it is proposed to exempt from duty all goods and manufactures imported into New South Wales from either of the said Colonies, which shall not be the growth or manufacture of foreign countries—Spirituous Liquors alone excepted—and to indemnify the Officers of Customs for acts already done.

No. 3.—"A Bill to further continue, for a limited "time, an Act, intituled An Act to facilitate "the apprehension of Transported Felons and "Offenders illegally at large, and of Persons "foundwith Arms and suspected to be Robbers."

It is proposed by this Bill to further continue for two years, from and after the 31st day of August next, the Act 5 William IV., No. 9, except so much thereof as relates to the time of the passing and execution of any sentence of death.

It is also proposed that no Justice of the Peace shall have power to cause the removal of any person to Sydney for examination, unless such person shall have been apprehended within the Police District of Sydney, or on the information of some credible witness, on oath, that there is

strong ground for suspecting such person to be a Transported Felon or Offender illegally at large.

No. 4 .- " A Bill to amend an Act, intituled, " An Act to provide for the more effectual " administration of Justice in New South Wales " and its Dependencies.'

Whereas since the passing of the Act 4 Victoria, No. 4, New Zealand has been formed into an Independent Colony; it is proposed by this Bill to repeal so much of the said Act as relates to the Administration of Justice in New Zealand.
