#### PROCLAMATION.

By His Excellency Sir George Giffs, Knight, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

HEREAS by a Proclamation, bearing date the twenty-seventh day of January last, the Legislative Council of this Colony was prorogued to Tuesday, the nineteenth day of March next, but circumstances have arisen to render an earlier meeting of the said Council expedient :-Now, therefore, I, Sir George Gipps, Governor of the Colony of New South Wales, do hereby alter the day to which the Legislative Council was by the said Proclamation prorogued; and I do, by virtue of the power and authority vested in me as Governor of New South Wales, by an Act of the Imperial Parliament of Great Britain and Ireland, passed in the 5th and 6th year of the reign of Her present Majesty Queen Victoria, intituled "An Act for the Go-"vernment of New South Wales and Van Dic-"men's Land," hereby announce and proclaim, that a Session of the said Legislative Council shall be holden on Tuesday, the fifth day of March next, instead of the said nineteenth day of March, at twelve o'clock, at noon, in the Council Chamber, situate in Macquarie-street, Sydney; and the Members of the said Legislative Council are hereby required to give their attendance at the said time and place accordingly.

PROCLAMATION.
By His Excellency SIR GEORGE GIPPS, Knight,

Captain-General and Governor-in-Chief of the Territory of New South Wales, and its Dependencies, and Vice-Admiral of the same, &c., &c. HEREAS by an Act of the Imperial Par-VV liament of Great Britain and Ireland, passed in the ninth year of the Reign of His late Majesty King George the Fourth, intituled "An "Act to provide for the Administration of Justice in "New South Wales and Van Diemen's Land, and "for the more effectual Government thereof, and for "other purposes relating thereto," it was, amongst other things enacted, that every Law or Ordinance to be passed by the Governor of New South Wales, with the advice of the Legislative Council thereof, should, within six months from the date of such Law or Ordinance, be transmitted by the Governor for the time being of the said Colony, to one of His Majesty's Principal Secretaries of State for the time being; and that it should and might be lawful for His Majesty, His Heirs and Successors, from time to time, as He or They should think necessary, to signify, through one of His or Their Principal Secretaries of State, His or Their approbation or disallowance of all such Laws and Ordinances, and that from and immediately after the time when such disallowance should be published in the said Colony by Proclamation, to be for that purpose issued by the said Governor, all such Laws and Ordinances should be null and void: And whereas a certain Actor Ordinance was passed, during the sixth year of the Reign of Her present Majesty Queen Victoria, by the Governor of New South Wales, with the advice of the Legislative Council thereof, intituled "An "Act to permit Goods, the produce or manufacture of "New Zealand or Van Diemen's Land, to be imported "into the Colony of New South Wales, free of duty; "and to indemnify certain Officers for acts already "done:" and whereas the Right Honorable Lord Stan-

ley, one of Her Majesty's Principal Secretaries of State, has signified in a Despatch, bearing date the thirty-first

day of August, one thousand eight hundred and

forty-three, addressed to the said Governor, Her Majesty's disallowance of the said Act: Now, therefore, I, Sir George Gipps, Knight, the Governor aforesaid, do, by this my Proclamation, declare, that the said Act is null and void accordingly.

PRODUCE OF NEW ZEALAND OR VAN DIEMEN'S LAND, IMPORTED INTO NEW SOUTH WALES.

HIS Excellency the GOVERNOR is pleased to direct the publication, for general information, of the following Despatch, from the Secretary of State, dated the 31st August, 1843, No. 133, stating the circumstances under which Her Majesty has been advised to disallow the Act of the Legislature of this Colony, 6th Victoria, No. 1.

SIR.

With reference to my Despatch of the 10th instant, No. 124, I have to acquaint you, that I have laid before the Queen the Act of the Legislature of New South Wales, (No. 1, 6 Victoria,) entitled "An Act to permit goods, the produce or manu- facture of New Zealand or Van Diemen's Land, "to be imported into the Colony of New South "Wales, free of duty; and to indemnify certain "Officers for acts already done."

The object of this Act is to give to articles the produce or manufacture of New Zealand the same advantages in their importation into New South Wales as are now enjoyed by articles the produce or manufacture of Van Diemen's Land.

It has been passed, no doubt, in consideration of New Zealand having, until lately, formed a dependency of New South Wales, and having, as such, been entitled to the same advantages in regard to its trade as that Colony.

But the principle of establishing differential Duties in favour of particular Colonies, is so objectionable, that Her Majesty's Government cannot consent to any further extension or recognition of such a system. If allowed, it would inevitably give rise to retaliating measures, on the part of other Colonies, and a system of protection and preferences would gradually be established among the several Colonial Dependencies of the empire, by which the operation of commerce would be embarrassed, and the Colonies be deprived of the advantage they now derive from being parts of one great empire.

Under these circumstances, I have felt it my duty to submit to Her Majesty, that this Act should be disallowed; and Her Majesty having been pleased to approve that advice, the Act is disallowed accordingly.
