FORTY POUNDS REWARD, OR A CON-DITIONAL PARDON.

HE following descriptions of GRANTS of LAND and TOWN ALLTOMENTS, which have, from time to time been appropriated to the purposes of the Presbyterian Church, as hereunder more particularly mentioned, are published for general information, in order that all parties concerned

may have an opportunity of correcting any errors or omissions that may have been made inadvertently being in addition to the allotments advertised on 1st October, 1842, and on 1st March, 6th June, and 12th September, 1843, and on 22nd January, 1844.
