# GROSE FARM.

HEREAS by an Act of the Governor, with the advice of the Legislative Council, passed in the fifth year of the reign of His late Majesty King William the Fourth, intituled, " An " Act for better regulating the alignment of " Streets in the Town of Sydney," it is amongst other things enacted, that before the Surveyor-General shall set out the footway in any Street, or part of a Street, or Public Place in the said Town, after the passing of the said Act, he shall lay before the Governor and Executive Council a plan of the same, setting forth the proposed breadth of the carriage and footways; and thereupon it shall and may be lawful for the said Governor and Council, by Notice in the New South Wales Government Gazette, to fix and declare the distance from the curb-stone, or exterior edge of the said footway in any such Street, part of a Street, or Public Place, within which it shall not be lawful to erect any building.
