#### PROCLAMATION.

By His Excellency Sir Charles Augustus Fitz Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

HEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the fifth year of the Reign of Her Majesty Queen Victoria, intituled, "An Act to "make further provision for the Trial of Cases "in the Circuit Courts of New South Wales, " and to amend, in certain respects, the Act pro-" viding for Trial by Jury in such Courts," it is amongst other things enacted, That it shall be lawful for the Governor for the time being, of the said Colony, by any Proclamation or Proclamations, by him from time to time for that purpose issued, to apportion and divide the said Colony into three or more Circuit Districts: Now, therefore, I, the said Governor, in pursuance of the authority so in me vested as aforesaid, by the said recited Act, do divide the parts of the said Colony heroinafter mentioned, into three Circuit Districts, to be called, respectively, the Northern, the Southern, and the Western Districts: And I do proclaim and appoint that the said Northern District shall consist of all parts of the said Colony comprehended within the Counties of Northumberland, Gloucester, Durham, Hunter, Brisbane, and Bligh, with the exception of such parts of the Counties of Northumberland and Bligh as are respectively comprised within the Police Districts of Brisbane Water and Wellington. according to the boundaries thereof, set forth in the Notices from the Colonial Secretary's Office, published in the New South Wales Government Gazette, and bearing date the fifteenth day of September, one thousand eight hundred and forty-one, and the twenty-fifth day of March, one thousand eight hundred and forty-five.

And I further proclaim and appoint, that the said Southern Circuit District shall consist of all parts of the said Colony comprehended within the Counties of Camden, Argyle, St. Vincent, Murray, and King, with the exception of such parts of the Counties of Camden and St. Vincent as are comprised within the Police Districts of Picton, Camden and Narellan, Campbelltown, Illawarra, and Broulee, according to the boundaries thereof, respectively set forth in the said Notice of the fifteenth day of September, one thousand eight hundred and forty-one.

And lastly, I proclaim and appoint, that the aforesaid Western Circuit District shall consist of all parts of the said Colony comprehended within the Counties of Bathurst, Wellington, Bligh, Phillip, Roxburgh, Georgiana, Westmoreland, and Cook, with the exception of such parts of the Counties of Bligh, Westmoreland, and Cook, as are comprised within the Police Districts of Cassilis, Picton, Penrith, and Windsor, according to the boundaries thereof, respectively set forth in the Notices from the Colonial Secretary's Oflice, published in the New South Wales Government Gazette, and bearing date, respectively, the fifteenth day of September, one thousand eight hundred and forty-one, and the twenty-fifth day of March, one thousand eight hundred and forty-five.

#### PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

THEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the fourth year of the reign of Her Majesty, intituled, " An Act to provide for the more effectual \* Administration of Justice in New South Wa'es " and its Dependencies," it is amongst other things enacted, that it shall be lawful for the Governor of the said Colony, by Proclamation under his Hand and Seal, issued and published from time to time, by and with the advice of the Executive Council of the same, to direct Circuit Courts to be holden in or at such towns or places within the Colony, and on such days respectively, as he shall by the advice aforesaid think fit to appoint; And whereas it has been thought expedient to discontinue the holding in future of any Circuit Court at the Town of Berrima: And whereas by a Proclamation under my Hand and Seal, bearing even date herewith, I, the said Governor, have, by virtue of the authority in me vested in that behalf divided the parts of the Colony therein mentioned into three Circuit Districts to be called respectively the Northern, the Southern, and the Western Circuit Districts; Now, therefore, I, the Governor aforesaid, by and with the advice of the said Executive Council do hereby direct and appoint that Circuit Courts for the trial of Criminal as well as Civil Issues, shall be holden in this Colony hereafter as follows-that is to say, at Goulburn, in the said Southern Circuit District, on the third day of February, and the first day of September, in each year; at Maitland, in the said Northern Circuit District, on the twelfth day of February, and the tenth day of September, in each year; and at Bathurst, in the said Western Circuit District on the twenty-second day of February, and the twentieth day of September in each year: Provided that whenever any of those days shall happen on a Sunday, the Court shall be holden on the day next following.

#### FAMILIES OF EXILES.

TIS Excellency the Governor is pleased to direct the re-publication of the following Notice.

> By His Excellency's Command, E. DEAS THOMSON.

HER Majesty's Government having determined to defray a moiety of the expense of conveying to this Colony the families of those married persons who arrived at Port Phillip as "Exiles" from Great Britain, His Excellency the Governor directs it to be notified that, in any case in which the Exile shall place in the hands of the Local Government a sum sufficient to cover one-half the expense of conveying his wife and children to the Colony, the other half will be defrayed by the Home Government.

Persons of this class, therefore, who are desirous of availing themselves of this indulgence, will make application accordingly to His Honor the Superintendent of Port Phillip, if still resident in that District, or otherwise to the Principal Superintendent of Convicts in Sydney.

As however, it will not be possible to predetermine the actual expense of providing passages for each such family, the applicants will be required to deposit in the Colony such a sum of money as will cover one moiety of the probable expense, calculated according to the following scale, and the balance (if any) after paying a moiety of the actual expenes

His Excellency the Governor directs it to be notified, that Her Majesty's Government have determined to revive the practice of forwarding to this Colony, at the public expense, the wives and families of married convicts who have become free by pardon or otherwise, or who have obtained tickets of leave, and who may be recommended by the GOVERNOR as worthy of that indulgence.

2. Those persons who have already obtained tickets of leave, or any higher degree of liberty, or whose terms of transportation have expired, and who may be desirous of being joined by their families, will make application in the annexed form, to the Principal Superintendent of Convicts.

3. Every such application must be supported by the recommendation of two or more respectable persons known to the Government, and satisfactory assurance must be afforded that the applicant has the means of supporting his family.

4. In like manner, Convicts at present under sentence will be allowed to apply for the above indulgence, as soon as they have received tickets of leave, but not before.

5. Those persons whose applications were forwarded to the Secretary of State under the regulations of 6th May, 1833, but were not then complied with, will be required to make fresh applications in the accompanying form.

# PUBLIC ACCOUNTS.

LL persons having claims on the Colonial Treasury are requested to furnish their accounts through the proper channel, before the end of the year, or as soon thereafter as practicable.

The several Collectors and Officers in the receipt of public monies, will pay over to the Colonial Treasurer, on or before the 31st of December, the amount of all collections remaining in their hands respectively up to that date, so that the entire Revenue collected by each, may be credited in the Accounts of the year within which it was received.

The Heads of Departments and other Officers, who have received advances to enable them to defray expenses incurred under their superintendence, are requested to furnish to the Audit Office, as far as practicable, and with all convenient despatch, the accounts of the expenditure thereof, and on or before the last day of December, to pay into the Colonial Treasury, the unexpended balance of such advances that the adjustment of the same may appear in the accounts to 31st proxime.

They will also, as soon as practicable, after the close of the year, bring forward all accounts of expenses incurred within the same, which do not admit of being previously settled, so that if possible all the expenses incurred in the present year may be finally adjusted and liquidated within one month after its termination.

The Colonial Treasurer is requested to use his endeavours to give effect to these directions, and to report through the proper channel, for the information of His Excellency the Governor, any instance of neglect in complying therewith, on the part of the Government Officers concerned.
