DEPASTURING LICENSES AND ASSESSMENT ON STOCK.

CONSIDERABLE sums being still due to the Government for Depasturing Licenses, and for arrears of Assessment on Stock pastured on Crown Lands beyond the boundaries of location, His Excellency the Governor directs it to be intimated to all persons thus in default, that unless they forthwith pay up all arrears and take out licenses for the runs they occupy, the Government will be reluctantly compelled to proceed for penalties, and to dispossess them, under the Act of Parliament 9 and 10 Victoria, cap. 104.

And all parties thus in arrears are reminded, that under the proposed Order in Council, the licensed occupants of Crown Lands, at the time the same may come into effect, will alone be entitled to demand or obtain without competition leases of their runs.

REPAIR OF THE LIVERPOOL ROAD BETWEEN THE EIGHTH AND TWELFTH MILESTONES.

TENDERS will be received at this Office until Monday, the 23rd August next, marked "Tenders for repairing Liverpool Road," from persons willing to contract for reforming and repairing that portion of the Liverpool Road, lying between the 8th and 12th Milestones, in the following manner:—

The portion of Road to be divided into two

lots, of two miles each.

The roadway to be formed thirty feet in width, with a curved full of one foot from the centre to the side drains, or water tables.

The holes and ruts to be filled with the best convenient material.

All the drains for carrying off the surface water to be cleared out and deepened, and others to be made, where absolutely necessary.

The whole of the work, including bridges, drains, sc., in each let, to be completed within six months from signing the Bond, and to be kept in repair for three years from the date of the completion of the work, to the satisfaction of the Surveyor General, or the Officer appointed to superintend.

The Contractor or Contractors to assume the whole risk of executing the works, and to acquaint themselves as to the work required to be executed in each lot, as no excuse will be entertained for deviating from the true intent and meaning of this

The Assistant Surveyor of Roads will point out, on the ground, the manner in which the work is to be performed, and will give every information to persons desirous of tendering, on application to him, at the Surveyor General's Office, Sydney, between the hours of eleven and three, on any Friday or Saturday before the day fixed for opening the Tenders.
