FAMILIES OF EXILES.

to defray a moiety of the expense of conveying to this Colony, the families of those married persons who arrived at Port Phillip as "Exiles" from Great Britain, His Excellency the Governor directs it to be notified that, in any case in which the Exile shall place in the hands of the Local Government a sum sufficient to cover one-half the expense of conveying his wife and children to the Colony, the other half will be defrayed by the Home Government.

Persons of this class, therefore, who are desirous of availing themselves of this indulgence, will make application accordingly to His Honor the Superintendent of Port Phillip, if still resident in that District, or otherwise to the Principal Superintendent of Convicts in Sydney.

As, however, it will not be possible to predetermine the actual expense of providing passages for each such family, the applicants will be required to deposit in the Colony such a sum of money as will cover one moiety of the probable expense, calculated according to the following scale, and the balance (if any) after paying a moiety of the actual expense incurred, will be returned to the parties, namely:—

IMMIGRATION.

TIH reference to the Government Notice of 7th April, 1847, respecting the allowance of Bounties for Emigrants from the Continent of Europe, in which the testimonials of intended Immigrants are required to be authenticated, by a certificate of the Secretary to the Land and Emigration

Commissioners in London, His Excellency the Governor directs it to be notified, with a view to meet a case of possible occurrence, in which this obligation might involve considerable inconvenience and expense, that in the event of a laborer being engaged at the port of embarkation, in order to supply a vacancy of unexpected occurrence, the signature of the British Consul at such Port will be admitted in lieu of the signature of the Secretary to the Land and Emigration Commissioners, if accompanied by such Consul's certificate, that the interval between the laborer's selection and the time fixed for the ship's sailing was too short to admit of the usual reference to the Commissioners in London, or that there was some equally valid cause for non-compliance with the regulation requiring such reference.

His Excellency also directs it to be explained, in order to remove a misapprehension which appears to have been entertained by some persons interested in the objects of the Notice of 7th April, 1847, that it is not intended that either the laborers selected for Emigration under that Notice, or the persons who selected them, should present themselves, with the certificates, at the office of the Land and Emigration Commissioners in London, but merely that the certificates should be sent to that office for inspection and

approval.

CONTRACTS FOR THE COLONIAL SERVICE, FOR 1848.

OTICE is hereby given, that Tenders will be received at this Office, until 12 o'clock, of Monday, the 1st November next, for furnishing, for the Colonial Service, in the several Districts, the supplies undermentioned, in such quantities as may be required, during Twelve Calendar Months, commencing 1st January, 1848, upon the conditions hereafter specified.

PROVISIONS.

1. The Ration for Emigrants :- For Men, 24oz. wheaten bread. 16oz. fresh meat, 8oz. vegetables, $\frac{1}{2}$ oz. of salt, $\frac{1}{4}$ oz. tea, $1\frac{1}{2}$ oz. sugar, $\frac{1}{4}$ oz soap—ForWomen, 16oz. wheat bread, 12oz fresh meat, 6oz vegetables, $\frac{1}{2}$ oz. salt, $\frac{1}{4}$ oz tea, $1\frac{1}{2}$ oz. sugar, $\frac{1}{2}$ oz. soap-Children under ten years, to be allowed twothirds of the Ration of Female Adults; above that age, and under fifteen, the same as Adults.

2. The Ration for Prisoners of the Crown, and others in the employment of Colonial Departments when authorised to receive it, with the exceptions specified in Nos. 3, 6, and 7-20oz. wheat bread, 80z. maize meal, 160z. fresh beef, $\frac{1}{4}$ oz. salt, 10z.

sugar, $\frac{1}{4}$ oz. soap.

3. The Rations to Officers in charge of Surveying parties, when in the field, and men composing such parties; and for Soldiers of the Mounted Police, and other Mounted parties, when required: -24oz. flour, 16oz. fresh beef, $\frac{1}{2}$ oz. salt, $\frac{1}{2}$ oz. tea, $2\frac{1}{2}$ oz. sugar, $\frac{1}{2}$ oz. tobacco, $\frac{1}{4}$ oz. soap.

4. The Ration for wives of Soldiers of the

Mounted Police :- 8oz. bread, 8oz. meat.

5. The Ration for children of Soldiers of Mounted Police above 7 years: -5\frac{1}{3}oz. of bread, 5\frac{1}{3}oz. the Master's children: -22oz. flour, 16oz. meat, meat—under 7 years, 40z. of bread and 40z. of meat. $\frac{1}{2}$ 0z. salt, $\frac{3}{8}$ 0z. tea, 20z. sugar, $\frac{1}{2}$ 0z. soap.

6 The Ration to the Superintendent and Crew of the Floating-light Vessel, Sydney Harbour :-16oz. biscuit, 8oz. flour, 16oz. fresh beef, ½oz. tea, 3.z. sugar, $2\frac{1}{2}$ oz. raisins, 1-14 pint outmeal, 1-14 pint vinegar.

7. The Ration to Men attending the Light-house, South Head, Telegraphs, and Boatmen in the Departments of Customs, Harbour Master, and Police:-240z. wheat bread, 16oz. fresh beef, ½oz. salt, 1oz.

sugar, $\frac{1}{4}$ oz. soap.

8. The Ration to Apprentices to the Colonial Architect :- 20oz. bread, 16oz. fresh beef or mutton, 8oz. vegetables, $\frac{1}{4}$ oz. tea, 2oz. sugar, $\frac{1}{2}$ oz. salt, $\frac{1}{2}$ oz. soap.

9. To prisoners confined in Gaol:-12oz wheat bread, 12oz. maize meal, 4oz. fresh beef, 8oz. vegetables, ½oz. salt, ½oz soap—(Ration No. 2 is issued to Gaol attendants, and to Witnesses and others awaiting bail; and if confined in solitary cells, Ration No. 11.)

10. To children of Female Prisoners confined in Gaol: -8oz. wheat bread, 4oz. fresh beef, 1 pint

milk, $\frac{1}{4}$ oz. yellow soap.

11. Prisoners co fined in Lock-up or Watchhouses: - 24oz. wheat bread or 20oz. flour-(Ration No. 2 is occasionally issued at Watch-houses to Prisoners of the Crown, when travelling from one station to another, and in other cases when sanctioned by a Magistrate.)

12. The Ration to Men, to the Matron, and to the Apprentices in the Government Printing Establishment :- 24oz. bread, 16oz. fresh beef or mutton,

 $\frac{1}{2}$ oz salı, $\frac{1}{2}$ oz. tea, $2\frac{1}{2}$ oz sugar, $\frac{1}{4}$ oz. soap.

13. Forage for Horses and Oxen :-- 81bs, maize or barley, or 10lbs. of oats, 4lbs. bran, 12lbs. oaten or cultivated grass hay, and 4lbs. wheat straw, for each horse daily, and half that quantity for each bullock.

14. For the Light-house, South Head, and Floating-light, Sydney Harbour :- Best clarified sperm oil, per imperial gallon; patent wicks each.

15. Flour, tea, sugar, and tobacco, bread or meat, in such quantities as may be required, for deserving Mechanics and others in Colonial Establishments when authorised.

16. Fuel and Light:-Firewood per '100lbs.; sperm oil, common oil, per imperial gallon; mould

candles, dipt candles, cotton wick per lb.

17. For children under 7 years of age, best wheaten bread is to be substituted, if required, in the propor-

tion of 8oz of bread for 12oz. of flour.

On Sundays and other days, 12oz. flour, 8oz. meat, $\frac{1}{3}$ oz. salt, $\frac{1}{4}$ oz. tea, 1oz. sugar, $\frac{3}{4}$ oz. soap.

6. For the use of the Establishment: $-1\frac{3}{4}$ pint

oil $1\frac{1}{2}$ pint vinegar.

7. Milk and vegetables for the Children, best wheat bread, flour, tea, sugar, salt, pearl barley, rice, oatmeal, arrowroot, sago, yeast, lard, common dipt candles, soap, vinegar, straw, and firewood, as required.

For Children under 7 years of age :- Best wheaten bread is to be substituted, if required, in the proportion of 8oz. of bread for 12oz. of flour.

DISTRICTS.

The Districts for which Contracts will be required, are as follows, viz :--

1. Sydney; 2, Parramatta; 3, Liverpool; 4, Campbelltown; 5, Picton: 6, Camden and Narrellan; 7, Illawarra; 8, Berrima; 9, Goulburn; 10, Braidwood; 11, Broulee; 12, Queanbeyan; 13, Yass, including Gunning and Narrawa, at the Fish River; 14, Windsor; 15, Penrith; 16, Hartley, including Blackheath; 17, Bathurst; 18; Carcoar; 19, Wellington; 20, Mudgee; 21, Brisbane Water; 22, Newcastle and Raymond Terrace; 23, Dungog; 24, Maitland; 25, Wollombi and M'Donald River; 26, Paterson; 27, Patrick's Plains; 28, Merton and Muswellbrook; 29, Scone and Murrurundi; 30, Cassilis; 31, Macquarie; 32, Moreton Bay.

The 31 Districts first mentioned, are the Police Districts described in the Notices from this Office, dated 15th September, 1841, 9th August, 1842, and 25th March, 1845, and further particulars respecting them may be obtained from the Police Magistrates and Benches.

Separate Tenders will be required for the forage in the District of Sydney, but the other supplies for that District are to be tendered for together.

The supplies for each of the other Districts, with the exception of those for the Male and Female Orphan Schools, the Institution for Destitute Roman Catholic Children, and the Lunatic Asylum, are intended to be included in one Contract, and therefore no Tenders can be received, unless for supplying the whole that may be required in the entire of a District, and for each District there must be a separate Tender, excepting Hartley and Blackheath, and Yass, Gunning, and Narrawa, for each of which places Tenders may be sent in separately.

Separate Tenders must also be made for the Male | Orphan School, the Female Orphan School, the Institution for Destitute Roman Catholic Children, and for the Lunatic Asylum.

The Tenders for the Moreton Bay District, to specify the sum required for the supply of the following articles, daily, for Boatmen, in addition to the price of their Ration No. 7, viz : $-\frac{1}{2}$ oz. tea, $1\frac{1}{2}$ oz. sugar, $\frac{1}{2}$ oz. tobacco.

CONDITIONS.

1. All the articles required by this Notice are to be of the best quality of their several kinds.

2. The Flour and Bread must be the produce of clean sound Colonial wheat, from which, on the Ration of Emigrants, Surveying, and Mounted Police or other parties, Superintendent and Crew of the Floating-light, Men at the Light House, Telegraphs Boatmen, Apprentices, the Orphan Schools, and the Institution for Destitute Roman Catholic Children, 20 per cent., and on the Ration to Prisoners of the Crown, 10 per cent., has been extracted in bran and waste.

3. Beef and Mutton to be issued in such proportions as may be required for the Ration to Emigrants, and when the quantity admits of it, this, as well as the Convict Ration of Beef, to be delivered in fore and hind quarters alternately.

4. Beef to be issued to the Male Orphan School on five days, and Mutton on two days of the week; and to the Female Orphan School, Beef to be issued three days, and Mutton four days of the week.

5. The Maize Meal to be similar in quality to

the Wheat Meal, and to be twice ground.

6. The Tobacco to be Colonial.

7. When it may be necessary to substitute one article for another, the following proportions are to be observed, viz.: - 1 lb. wheat flour or 1lb. biscuit equal to 11th. of bread; 1th. salt Beef or 1th. Mutton, or 10oz. salt pork, equal to 1lb. of fresh

8. These substitutions are to be made only when required by the Officers authorised to draw the several Rations.

9. Hospital Bread is to be supplied to the Children of the Orphan Schools, and to the Institution for Destitute Roman Catholic Children when required by the Surgeon, in lieu of the ordinary Ration.

10. Vegetables to be supplied in reasonable proportions of potatoes, greens, pumpkins, onions, &c.,

11. In case the whole ration of Forage be not required or delivered, each of the species to be reckoned as the portion of the Ration undermentioned :- The Maize or Barley, 4-12; the Hay, 5-12; the Bran, 2-12, and the straw, 1-12.

12. The supplies are to be delivered at the nearest fixed station, on the requisition of the Officer in charge; being, previously to removal from the Contractor's premises, approved by a person, if any, authorised for the purpose.

13. The Tenders for provisions and Forage, when required by Rations, according to the scale under their respective heads, are to express the price per

Ration only.

14. The Tenders for Forage are not required to state the price of the Ration for Oxen, as when the latter is required, one-half of the allowance fixed for Horses will be drawn, and one-half the price allowed to the Contractor, whose engagement will be to provide for both Horses and Oxen.

15. In the event of a difference of opinion between the Contractor and the party receiving the supplies, as to the quality, the same is to be decided, in cases where the article is not of a perishable nature, by a Board of Survey, composed by persons named by the Government, according to the practice of the service. But in country districts, where such a Board of Survey cannot be conveniently assembled, the party objecting will name one person as arbitrator, the Contractor or his agent another, and these two will (previously to any other proceeding on their part,) concur in naming a third as umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

16. If the board, arbitrators, or umpire shall decide that the article is not of proper quality, it must be immediately replaced by the Contractor, failing of which, it will be procured by the Department requiring it, and the expense charged to the

Contractor.

17. In the event of any unnecessary delay, or failure of the Contractor to supply the articles when required, they will be otherwise procured, and

charged in like manner.

18. In cases where the article is of a perishable nature, or from some other cause injury would be sustained, either by the parties to whom the Rations are due, or to the Contractor, by waiting for a Board of Survey, the head of the Department, or Officer in charge of the party or parties for whom the Rations are to be received, shall have power to reject such article or articles as are obviously of inferior quality; it being distinctly understood, that he will be responsible to the Government for so doing; and that the Contractor will have a right to appeal to the Governor, although, in the mean time, he must take back the rejected article, and supply good in its stead, failing of which it will be obtained by the Officer or party requiring it, and the expense charged to the Contractor.

19. A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will also subject the Contractor, upon the Report of the Officer in charge of the parties or establishment, to such mulct, not exceeding one-fourth the amount of his monthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the Contract forthwith.

20. It will be in the power of either party to limit the duration of the Contract, by giving, in writing, a notice of three full calendar months to the opposite party, and to end the Contract at the expiration of that period, it being understood that such notice can be given only from the first day of a month, and within the period for which the Contract is made, or agreed to be made.

21. The Contractor will be required to prepare his own cash account, monthly or quarterly, in the prescribed form; and on the production thereof, with the requisite vouchers, in a complete state to the Officer receiving the supplies, the same will be forwarded by the latter to the Auditor General, in order that a warrant may be prepared and payment made from the Colonial Treasury.

22. The value of all packages to be included in the prices demanded.

23. Printed forms of Tender may be obtained at this Office, or from the Police Magistrates or Benches of the several Districts; and at the foot of every

Tender, there must be a Memorandum, signed by the party tendering, and two responsible persons as sureties, agreeing to be responsible for the due performance of the Contract, in the event of the Tender being accepted, and undertaking, in that event, that they will severally execute and deliver, within one month from the usual notification of acceptance, a bond to Her Majesty, for securing such performance, otherwise such Tender will not be taken into consideration.

24. The Tenders to contain the names of the Tenderers and their Sureties, and places of residence,

at length.

25. Each Tender must be in the form referred to in paragraph 23, and to be enclosed in a separate envelope, and marked "Tender for Provisions, &c."

26. Further particulars and information may be obtained on application at this Office, or to the

Auditor General.

27. The party tendering, or an Agent authorised in writing to act for him, is requested to attend at this Office, at the time appointed for receiving the Tenders, to afford such explanation or information as may be required.

5. The Ration for children of Soldiers of the Mounted Police, above 7 years, 5\(^1_3\)oz. of bread, 5\(^1_3\)oz. meat—under 7 years, 4oz. of bread and 4oz. meat.

11. Prisoners confined in Lock-up or Watchhouses:—24oz. wheat bread or 20oz. flour—(Ration No. 2, is occasionally issued at Watch-houses to Prisoners of the Crown, when travelling from one station to another, and in other cases when sanctioned by a Magistrate.)

13. Forage for Horses and Oxen:—8lbs, maize or barley, or 10lbs, of oats, 4lbs, bran, 12lbs, oaten or cultivated grass hay, and 4lbs, wheat straw for each horse daily, and half that quantity for each

DISTRICTS.

The Districts for which Contracts will be made, are as follows, viz.

1. Maneroo; 2. Murrumbidgee; 3, Lachlan; 4, Wellington; 5, Bligh; 6, Liverpool Plains; 7, New England; 8, Darling Downs; 9, MacLeay River; 10, Clarence River; 11, Moreton Bay.

2. The Stations at which Supplies will be required,

are--

1, The Head Quarters of the Commissioners; 2, Eden, Cooma, and Bombala, in the District of Monaroo; 3, Tumut, Albury, Deniliquin, Wagga Wagga, Lower Murray, and Hume River, in the District of Murrumbidgee; 4, Binalong, in the District of Lachlan; 5, Molong, in the District of Bligh; 7, Tamworth, Warialda, Pockatoroo, and Wee Waa, in the District of Liverpool Plains; 8, Armidale, Wellingrove, and Tenterfield, in the District of New England; 9, Cambooya and Warwick, in the District of Darling Downs; 10, MacLeay River; 11, Grafton, Cassino, and Tabulam, in the District of Clarence River; 12, Ipswich and Cressbrook, in the District of Moreton Bay.

2. And further particulars respecting them may be obtained from the respective Commissioners of Crown Lands, or from the Commandant of the

Mounted Police.

CONDITIONS.

1. Tenders will be received for the whole of a District, or separate for the different Stations mentioned in it.

2. All the articles required by this notice are to be of the best quality of their several kinds.

- 3. The Flour and Bread must be the produce of clean sound Colonial Wheat, from which 20 per cent. has been extracted in bran and waste.
- 4. The Tobacco to be Colonial.
- 5. When it may be necessary to substitute one article for another, the following proportions are to be observed, viz.:—1lb. wheat flour or 1lb. biscuit, equal to 1\frac{1}{2}\lb. of bread; 1lb. salt beef or 1lb. mutton, or 10oz. salt pork, equal to 1lb. fresh beef. These substitutions are to be made only when required by the Officers authorized to draw the several Rations.
- 6. The supplies are to be delivered at the nearest fixed Stations to the places where the party may be employed, on the requisition of the Officer in charge, being previously to removal from the Contractor's premises approved by a person, if any, authorized for the purpose; and in case the whole Ration of Forage be not required or delivered, each of the species to be reckoned as the portion of the Ration undermentioned, viz.:—

The maize or barley 4-12, the hay 5-12, the bran 2-12, the straw, 1-12.

7. The Tenders are to express the price per Ra-

tion only.

8. The Tenders for Forage are not required to state the price of the Ration for Oxen, as when the latter is required, one-half of the allowance fixed for Horses will be drawn, and one-half the price allowed to the Contractor, whose engagement will be to provide for both Horses and Oxen.

9. In the event of a difference of opinion between the Contractor and the party receiving the supplies, as to the quality, the same is to be decided in the following way :- the party objecting, will name one person as arbitrator, the Contractor or his Agent another, and these two will (previously to any other proceeding on their part,) concur in naming a third as umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

10. If the arbitrators or umpire, shall decide that the article is not of proper quality, it must be immediately replaced by the Contractor, failing of which, it will be procured by the party requiring it, and the expense charged to the Contractor.

11. In the event of any unnecessary delay, or failure of the Contractor to supply the articles when required, they will be otherwise procured, and charged

in like manner,

- 12. In cases where the article is of a perishable nature, or from some other cause injury would be sustained, either by the parties to whom the Rations are due, or to the Contractor, by waiting for the decision of the arbitrators, the Officer in charge of the party or parties for whom the Rations are to be received, shall have power to reject such article or articles as are obviously of inferior quality-it being distinctly understood, that he will be responsible to the Government for so doing; and that the Contractor will have a right to appeal to the Governor, although, in the mean time, he must take back the rejected article, and supply good in its stead, failing of which, it will be obtained by the Officer or party requiring it, and the expense charged to the Contractor.
- 13. A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will also subject the Contractor, upon the Report of the Officer in charge of the parties, to such mulct, not exceeding one-fourth the amount of his monthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the Contract forthwith.

14. It will be in the power of either party to limit the duration of the Contract, by giving, in writing, a notice of full three calendar months to the opposite party, and to end the contract at the expiration of that period, it being understood that such notice can be given only from the first day of a month, and within the period for which the contract is made, or

agreed to be made,

15. The Contractor will be required to prepare his own cash account, monthly or quarterly, in the prescribed form; and on the production thereof, with the requisite vouchers, in a complete state to the Officer receiving the supplies, the same will be forwarded by the latter to the Auditor General, in order that a warrant may be prepared and payment made from the Colonial Treasury.

16. Printed forms of Tender may be obtained at this Office, from the Commandant of the Mounted Police, from the Commissioners of Crown Lands, and from the Benches of the several Districts; and at the foot of every Tender there must be a memorandum signed by the party tendering, and two responsible persons as sureties, agreeing to be responsible for the due performance of the Contract, in the event of the Tender being accepted, and undertaking in that event, that they will severally execute and deliver within two months from the usual notification of acceptance, a Bond to Her Majesty, in the penal sum of one hundred pounds, for securing such performance, otherwise such Tender will not be taken into consideration.

17. The Tenders to contain the names of the Tenderers and their Sureties, and places of residence, at length.

18. Each Tender must be in the form referred to in paragraph 16, and is to be enclosed in a separate envelope, and marked" Tender for provisions, &c., for Police Districts beyond the Boundaries.'
