CROWN LANDS BEYOND THE SETTLED DISTRICTS.

PUBLIC ACCOUNTS.

A LL persons having claims on the Colonial Treasury are requested to furnish their accounts through the proper channel, before the end of the year, or as soon thereafter as practicable.

The several Collectors and Officers in the receipt of public monies, will pay over to the Colonial Treasurer, on or before the 31st of December, the amount of all collections remaining in their hands respectively up to that date, so that the entire Revenue collected by each, may be credited in the Accounts of the year within which it was received.

The Heads of Departments and other Officers, who have received advances to enable them to defray expenses incurred under their superintendence, are requested to furnish to the Audit Office, as far as practicable, and with all convenient despatch, the accounts of the expenditure thereof, and on or before the last day of December, to pay into the Colonial Treasury, the unexpended balance of such advances that the adjustment of the same may appear in the accounts to 31st proximo.

They will also, as soon as practicable, after the close of the year, bring forward all accounts of expenses incurred within the same, which do not admit of being previously settled, so that if possible all the expenses incurred in the present year may be finally adjusted and liquidated within one month after its termination.

The Colonial Treasurer is requested to use his endeavours to give effect to these directions, and to report through the proper channel, for the information of His Excellency the Governor, any instance of neglect in complying therewith, on the part of the Government Officers concerned.

His Excellency further directs it to be notified, that a pardon will be granted to any one of the persons concerned in this outrage, (not being the actual perpetrators thereof,) who will give such information as shall lead to the apprehension and conviction of any one or more of his accomplices.

AMENDED REGULATIONS RESPECTING
THE LIGHTS TO BE EXHIBITED BY
STEAM VESSELS.

1. The Board appointed under the provisions of the Act of the Governor and Council, 11th Victoria, No. 3, for the regulation of sea going steam and other vessels carrying passengers, have with the approval of His Excellency the Governor, established the following Regulations respecting the lights to be exhibited by sea going steam vessels which are accordingly to take effect after the expiration of one month from the publication of this notice.

2. All sea going steam vessels are to be provided with three lanterns which are to be fitted with strong reflectors, and of the following descriptions.

3. One of the said lanterns is to exhibit a plain light visible on three sides, viz.:—on the starboard and port sides, and ahead, and is to be carried at the vessel's foremast head, on the collar of the forestay, and is to hang clear of any canvass that may be set.

4. One of the said lanterns is to exhibit a green light, visible on two sides only, viz.:—on the starboard side and ahead, and is to be fixed on the fore

part of the starboard paddlebox.

3. The third or remaining lantern is to exhibit a red light, visible on two sides only, viz.:—on the port side and ahead, and is to be fixed on the fore

part of the port paddlebox.

6. The whole of the three lanterns are to be exhibited at all times between the hours of sunset and sunrise whenever the vessel is under weigh; but when at anchor the first mentioned lantern only, with three plain lights is to be exhibited at the foremast head.

7. Steam vessels lying at their respective wharves at Sydney, or the outports are not required to exhibit

any light.

8. The master or person in charge of any steam vessel who shall offend against any of these regulations is liable under the provisions of the said Act to a penalty not exceeding twenty pounds for every night in which default shall be made.

9. At the expiration of one month from the date of the publication of this notice the regulations respecting lights to be exhibited by steam vessels, as published in the New South Wales Government Gazette, of the 10th March, 1848, are hereby cancelled, except as to any offence or default previously committed.

RULES OF COURT.

In the Supreme Court of New South Wales.

Saturday, the fifth day of August, in the year of Our Lord one thousand eight hundred and fortyeight.

Rules following established: Equity, Lunacy, and Infancy.

T is ordered that the several Rules and Orders following,—numbered from 1 to 17 inclusively,—be in force and take effect as General Rules and Orders of this Court, for the regulation of the Practice of the Court in its Equitable Jurisdiction, and also (so far as the same shall be applicable) in Lunacy and Infancy, from and after the tenth day of August instant;—and that the same shall be in force and applied, in and with respect to all proceedings now pending in this Court, or in the Master's Office, so far as the same severally can be applied.

Accounts, Charge, &c. Evidence may be taken separately.

1.—Whenever any State of Facts, Claim, Charge, Discharge, Account, or other matter, is brought in before the Master, in respect whereof evidence is to be given, the Master shall be at liberty to direct, from time to time, that evidence shall be taken separately upon any selected point or points, and the evidence shall be taken accordingly.

Evidence to be proceeded with continuously.

2.—The taking of evidence before the Master, under any reference to him by Decree or Order, whether upon the whole matter, or upon any selected point or points, shall be proceeded with and closed, under his direction, in the same manner (as nearly as may be) as upon an Issue of Fact at Common Law.

On close of evidence, Master to endorse his Decision.

3.—After the evidence shall have been closed, the Master shall endorse on the State of Facts, Claim, Charge, Discharge, Account, or other matter whereon evidence shall have been given, his decision thereon; and after such indorsement, no further evidence shall be taken without an Order of Court:—but he shall be at liberty nevertheless to alter his decision, and the indorsement thereof, at any time before the Draft of his Report shall be settled.

Draft Report.—Objections not allowed.

4.—After the Draft of the Report shall have been settled, no objections thereto shall be taken, nor shall any alteration be made therein; but the Master shall sign the Report, within four days after the Draft thereof shall have been settled, without notice to any of the parties concerned; and no Warrant shall issue, or attendance be had, on preparing the Draft Report, or on signing the Report.

States of Facts, &c.; when to be filed.

5.—All States of Facts, Claims, and other matters, on which the Master's decision shall have to be indorsed, shall be left in the Master's Office before taking evidence thereon: but no such matters shall be filed, until his decision or decisions shall have been indorsed thereon:—after which, the same shall not be withdrawn, added to, or altered, without an Order of Court.

Service of Warrants, &c.

6.—The Master shall be at liberty to direct, that service of any Warrant, State of Facts, or other matter heretofore used to be served on any person, shall be dispensed with.

Proof of service.

7.—No affidavit shall be made of the service of any Warrant, State of Facts, Appointment, or other matter requiring service thereof to be shown to the Master; but the Master shall take proof thereof when requisite, vivá voce. And where such proof shall have been required, he shall make and file with the proceedings a Note, stating that the party has given, or failed to give such proof—as the case may

Attendance on Warrants.—Adjournments.

8.—Whenever a Warrant is attended before the Master, he shall be at liberty to continue the proceedings upon the same, for any length of time he may think fit, and to adjourn the proceedings thereunder from time to time; and no more than the first Warrant shall be taken out, for the time during or to which he shall so continue or adjourn the proceedings. But the Solicitor shall, as heretofore, be entitled to receive six shillings and eight-pence for each hour of attendance thereon.

Examination of Parties.

9.—The Master, under the usual Order contained in Decrees for the examination of Parties, shall be at liberty to examine either by written Interrogatories or viva voce; or partly in the one way and partly in the other, as he shall think most expedient.

Witness previously examined.

10.—No order shall be necessary to enable the Master to examine a Witness, who has given evidence preparatory to the hearing, except as to matters on which he shall have been examined before.

Proving Debts. - Proof without Written Claim.

11.—In Suits wherein Creditors are permitted or required to come in and prove their debts before the Master, no Creditor (other than a Party to the Suit) shall be entitled to attend, on any matter not connected with the proof of his own debt, except by direction of the Master. And in all such Suits the Master may, (if he shall think fit,) where the proof is not opposed, allow the debt on the Affidavit of the Claimant alone; and also, if he shall think fit, without any Claim in writing having been brought in. Provided that in such last mentioned case, the allowance or disallowance of the debt shall be indorsed on such affidavit.

Special Circumstances.

12.—The Master shall be at liberty, in future, in all cases, to state special circumstances in his Report.

Confirming Reports.—Exceptions.

13.—No Order Nisi to confirm a Report shall hereafter be made; but, in cases where such Orders have hitherto been required on moving to confirm a Report, the confirmation shall be by an Order Absolute in the first instance, upon motion.—Provided that not less than eight days' notice of such Motion shall be given; and that, within that time, or previously, any party dissatisfied with the Report may file and set down Exceptions to the same.

Exceptions ; or Motion to Review.

14.—Exceptions may be taken to the Master's Report, in all other cases, or a Petition may be filed, or Motion made, that the Master do review his Report, notwithstanding the abolition of Objections to the Draft Report.—Provided always, that unless the Party shall in such case make it appear, either that he objected to the Report on the same grounds, upon the settlement of the Draft thereof, or that he could not then avail himself of those grounds, he shall not be entitled to any costs;—unless the Court shall otherwise order.

Settling Conveyances.

15.—When the Master is ordered to settle any Conveyance, in case the parties shall differ about the same, a statement in writing of the required alterations shall be served, by the party objecting to the Draft, on the party by whom the same was prepared, within eight days after service of notice of the leaving of such Draft with the Master.

Allowing Costs specially.

16.—Whenever it shall appear to the Master, that the Costs or part of the Costs of any attendance, or of any proof before him, or Costs which may have been incurred through any non-attendance, ought not to abide the general event of the reference to him but that it is just and reasonable that the same should be paid specially by any Party or Claimant, it shall be lawful for him in his discretion to award the payment of such Costs, or part thereof, or a fixed sum in lieu of such Costs, as and when and by whom he shall in that behalf direct.

Court Fees reduced.

17.—In lieu of the Fees of Court, now payable upon or in respect of the matters hereinafter mentioned, the following reduced amounts only shall be henceforth paid; that is to say:—
