CLAIMS TO LEASES OF CROWN LANDS

BEYOND THE SETTLED DISTRICTS.
MACLEAY RIVER DISTRICT.

IIS Excellency the GOVERNOR directs it to be notified for the information of all persons interested, that in pursuance of Her Majesty's Order in Council, of 9th March, 1847, the undermentioned persons have demanded Leases of the several Runs of Crown Land, particularised in connexion with their respective names.

Persons who object to any of these claims, either whally or in part, should lodge caveats at this Office within two months from the present date, specifying the Lands to which their objections extend, and the grounds on which their objections are based.

It is to be distinctly understood, that the Government does not pledge itself to the issue of a Lease in any case until due enquiry has been made into the validity of the claim, and whether or not it may be necessary to reserve any portion of the Laud claimed, for any of the public purposes contemplated in the Order in Council.

No. 1.

Ainsworth John.

Name of Run—Adelaide Plains.

Estimated Area—1,200 Acres.

Estimated Grazing Capabilities—250 Cattle.

Bounded on the south by the boundary of the Colony; on the east by a marked tree line from Ravenswood to Dungy Creek, at the crossing place near M'Leod's stockyard; on the north by Dungy Creek; on the west by a line from the second crossing place or dray road, bearing south-west to the boundary of the Colony adjoining Mr. Salwey's Run. No. 2.

Australasia, Bank of, per Charles Falconer. Name of Run—Innes Creek. Estimated Area—48,000 Acres. Estimated Grazing Capabilities—1,200 Cattle.

Bounded on the north by the M'Leay River; on the west by a range dividing it from Betts and Panton's Run "Wabra;" on the south by a range of mountains and a point of Innes Creek at an old stockyard, dividing it from Kemp's Run; and on the east by a creek known as Lovelock's Creek, dividing it from D. Bell's Run.

No. 3.

Briggs William.
Name of Run—Sherwood.
Estimated Area—4,480 Acres.
Estimated Grazing Capabilities—450 Cattle, 2,000
Sheep.

Situated on the south bank of the M'Leay River, and bounded on the north and east by the M'Leay liver; on the west by the Dungee Dray Road; and on the south by a line drawn from the M'Leay River to Kippara Mountains.

No. 4.

Bell David.
Name of Run—Cullatin.
Estimated Area—10,240 Acres.

Estimated Grazing Capabilities-650 Cattle.

Bounded on the east and north by dray road from dividing range of Dungay Creek and M'Leay Waters and by M'Leay River as far up as M'Kenzie's hill, adjacent run, Ducats and Hill; on the west by M'Kenzie's hill and Lovelock's Creek, up to dividing range, adjacent run, Innes; on south by dividing range between M'Leay River and Dungay Creek, adjacent run, Kemp.

No. 5.

Chapman W. H., & Co. Name of Run-Yarrabandine. Estimated Area-19,000 Acres.

Estimated Grazing Capabilities-500 Cattle.

On south and west by Christmas Creek, up to a mountain called No. 3; again on west by the mountains or Owen Kihi Creek; on north partly by parish of Tanban, and the mountains; on east by section line running north from the mouth of Christmas Creek, including a small allotment at mouth of creek and river.

No. 6.

Chapman W. H., & Co. Name of Run-Tanban. Estimated Area-19,000 Acres.

Estimated Grazing Capabilities-500 Cattle.

On south by Yarrabandine; west by Owen Kihi Creek and No. 3 mountain; north by part of Owen Kihi and parish of Barruganyatty; east by section line being a continuation of the Western line of Barruganyatty until it meets the Yarrabandine parish line.

Chapman W. H., & Co. Name of Run-Belimbopine. Estimated Area-9,600 Acres.

Estimated Grazing Capabilities-300 Cattle.

On east by Mr. H. Oakes section line, west nearly parallel to the natural swamp up to the Klybucku or Barraganyatty; north by south line of Barraganyatty parish; west by Tanban being a continuation of the west line of Barraganyatty until it meets the north line of Yarrabandine parish.

No. 8.

Chapman W. H., & Co. Name of Run-Bally Bally, (Heifer Station.) Estimated Area-19,000 Acres.

Estimated Grazing Capabilities-600 Cattle. On east by the ocean or three miles thereof; north by south arm of Belingen Creek; south by north arm of Nanbucka; west by scrub mountains and part by north arm of Nanbucka.

No. 9.

Ducat William. Name of Run-Moonaba. Estimated Area—7,680 Acres. Estimated Grazing Capabilities-300 Cattle.

Situated on the north bank of the M'Leay River; and bounded on the north, south, and west by that river; and on the east by the dray road running from Yarrawal down by Water Hole Creek.

Ducat Charles. Name of Run-Yarrowall. Estimated Area-14,360 Acres. Estimated Grazing Capabilities-400 Cattle.

Situate on the north bank of the M'Leay River; bounded on the south and west by the said river; on the north by Christmas Creek; and on the east by a line running north from the fence of the station called the M'Leay River Steam Works to Christ- | Name of Run-Elsineur. mas Creek.

No. 11.

Ducat and Stephen. Name of Run—Towal Creek. Estimated Area-32,000 Acres.

Estimated Grazing Capabilities-960 Cattle.

Situate on both sides of the River MacLeay, the part on the north side of the river being bounded by George's Creek on the west, by the MacLeay River on the south, and on the east and north by the range dividing the waters of Five-day Creek, and Lagoon Creek, and the part on the south side of the M' Leay River, being bounded on the north and east by that river and the range dividing the waters of Towal Creek from Stockyard Creek; on the west by Carroll's Creek; and on the south by the main dividing range. No. 12.

Ducat and Stephen. Name of Run-Stockyard Creek. Estimated Area-13,440 Acres.

Estimated Grazing Capabilities-500 Cattle.

Situate on the M'Leay River, and bounded on the north by that River; on the east by a range dividing the waters of Oreen Brook and Stockyard Creek; on the west by a range dividing the waters of Stockyard Creek and Towal Creek; and on the south by the main dividing range separating Parallel Creek from Stockyard Creek.

No. 13.

Evans John. Name of Run-Euroka.

Estimated Area-10,000 Acres.

Estimated Grazing Capabilities-300 Cattle 2,000

Bounded on the north by the M'Leay River; on the east by the boundary of the Colony; on the south by north branch of the Maria River; on the west by the fourth section line of the parish of Callitini.

No. 14.

Gamack Alexander.

Name of Run-Dungee Creek. Estimated Area—16,000 Acres.

Estimated Grazing Capabilities-800 Cattle.

Bounded on one side by Major Kemp's station; on another side by Mr. Salway's station, "Yesaba;" on the third by Dungee Creek; and on the fourth by Mr. Gray's station "Combatane."

No. 15.

Hill Henry.

Name of Run-Corrungala. Estimated Area—15,360 Acres.

Estimated Grazing Capabilities-500 Cattle.

Bounded on the north by Mungay Creek; on the south by the Deep Creek and a line running easterly dividing it from the Yarrawall run; on the west by the River M'Leay; and on the east it extends about 4 miles from the River M'Leay.

Hill Henry.

Name of Run-Toorookoo.

Estimated Area-16,000 Acres.

Estimated Grazing Capabilities—700 Cattle.

Bounded on the south by the Corrungala station; west by the M'Leay River; and on the east and north by Hickey's Creek, and part of Mungay Creek.

No. 17.

Henderson John. Estimated Area 14,720 Acres. Estimated Grazing Capabilities-700 Cattle.

On the south of the river. Bounded by the M'Leay River on the north side; south by range dividing the waters of the Wabra from Oreen Brook; west by a line running due north and south from a point of the M'Leay opposite Peedee Creek Station; and on the east by a line drawn due north and south from a point of the M'Leay one quarter of a mile below the station. On the north side of the river; bounded on the north by a marked tree line running from top of dividing range to Nullah Nullah Creek; on the west by range dividing the waters of Peedee Creek from Nullah Nullah Creek; on the south by the M'Leay; and on the east by Nullah Nullah Creek up to marked tree line.

No. 18

Hebden George, and Co. Name of Run-Klybucca.

Estimated Area—20,000 Acres. Estimated Grazing Capabilities—800 Cattle.

Bounded on the north by Yarrapappini Mountain about 3 miles, bearing east; then by swamp and a creek about $3\frac{1}{2}$ miles, southerly and westerly to the mouth of Klybucca Creek; then by that creek about 4 miles S. W. up to its junction with Doorookoongha Creek; then by that creek about 21 miles S. and S. westerly, up to a fence which divides this Run from that of Mr. H. R. Oaks; then by the fence 55 rods N.W. to Shuttle's Lagoon; then by that lagoon about $1\frac{3}{4}$ W. and N. Westerly; then by a supposed line about 1 mile N.W. across swamp to a creek on the S. side of a range known as the Scrubby Range; then by that creek which divides this Run from Messrs. W. H. Chapmanand Co's. "Tamban" Run, about $2\frac{1}{2}$ miles west to the main range; then by a supposed line about 1½ miles N. W. Oankihi Creek; then by that creek about 5 miles N. E. to the starting point at the base of the Yarrapappini Mountains.

No. 19.

Jobling George.
Name of Run—Cunderay.
Estimated Area—40,000 Acres.
Estimated Grazing Capabilities—1,100 Cattle.

The Run known as Cunderay is situate on the north and south sides of the M'Leay River. On the north side of the M'Leay River it is bounded on the south by that river; on the east by a line drawn due north from the deep crossing place to the dividing range; on the west by the table land; and on the north by table land. On the south side of the M'Leay River it is bounded on the north by that river; and on the east by a line drawn due south from the deep crossing place to the dividing range; on the west by table land; and on the south by the dividing

range.

Kemp William.
Name of Run—Booningii (lately Upper Dungee.)
Estimated Area—12,800 Acres.

Estimated Grazing Capabilities—640 Cattle.

Commencing on the east about two miles and a half above Dr. Gamack's Station, on the Dungee Creek, extending up the Dungee Creek to the west, 8 or 10 miles, with 3 miles on the Combatine Creek, to within 2 miles of Mr. Gray's Station, on Combatine Creek; and bounded on the north by a dividing range, separating it from Parallel Creek; and on the south by a range on the south side of the Combatine Creek.

No. 21

Kemp William.
Name of Run—Toorunbee.
Estimated Area—16,000 Acres.
Estimated Grazing Capabilities—700 Cattle.

Commencing to the north-east at a natural boundary about 4 miles above a station belonging to the Bank of Australasia, on Parallel Creek, and extending up the creek about 8 or 10 miles; and bounded on the west by a dividing range between it and Captain Jobling's Station, on Cunderang Creek; and on the south by a dividing range separating it from Major Kemp's Station, on Dungee Creek.

No. 22.

M'Leod Magnus. Name of Run—Dondingalong. Estimated Area—2,500 Acres.

Estimated Grazing Capabilities-400 Cattle.

Situated on Dungee Creek, on the south bank of the M'Leay River; and bounded on the north by the M'Leay River; on the west by the Dungee Creek from the M'Leay River to my Stockyard; likewise a portion of land on the west side of the creek; bounded by a range running south to the third crossing place; on the south by a marked line to Ravenswood; on the east by the Old M'Leay River Road to the M'Leay River; bounded by stations on the north belonging to Mr. Salwey; on the south belonging to Mr. Ainsworth; on the east belonging to Captain Campbell.

No. 23.

Mackay Patrick.
Name of Run—Tait's Station.
Estimated Area—17,920 Acres.

Estimated Grazing Capabilities __600 Cattle.

Situated on the south bank of the M'Leay River, and bounded on the east by range running parallel with Stony Creek to its junction with Blind Creek, and by Innes Creek from that junction downwards to the range below the mouth of Tait's Creek; south by Major Kemp's Heifer Station; north by Wabra and Innes Creek Stations; and west by Government Land.

No. 24.

Oakes Henry Richard.
Name of Run—Seven Oaks.
Estimated Area—5,000 Acres.
Estimated Grazing Capabilities—300 Cattle.

Situated on the north bank of the M'Leay River, and bounded on the south and east by that River; on the north by the Klybucca Creek; and on the west by swamps dividing the Seven Oaks and Bellimbopine Stations.

No. 25.

Panton John.
Name of Run—Wabbra.
Estimated Area—32,000 Acres.
Estimated Grazing Capabilities—1,400 Cattle.

South side of River.—On the south by ranges dividing the waters of Innes and Wabbra Creeks up to within $\frac{1}{2}$ a mile of Mc. Can's old station; east and north by the M'Leay; west by M'Kenzie's Creek from Thomson's hut up to a range dividing waters of Wabbra and Stockyard Creeks. North side of River.—On the west by the M'Leay; north by Sugar Loaf Mountain; east by creek emptying itself into the M'Leay nearly opposite River Station; south by Toorookoo Run.

No. 26.

Panton John.

Name of Run-Long Flat.

Estimated Area-17,280 Acres.

Estimated Grazing Capabilities-1,000 Cattle.

North side of River.—East by Lower George's Creek; north by main dividing range; south by the M'Leay; west by a line drawn north and south from Deep Crossing Place to Table Mountain. South side of River.—east by Carroll's Creek; north by the M'Leay; south by main ranges; west by a line drawn north and south from Deep Crossing Place to Main Range.

No. 27.

Rudder, Enoch William
Name of Run-Woodfield.

Estimated Area-3,808 Acres.

Estimated Grazing Capabilities-200 Cattle.

Commencing from the M'Leay River, at the commencing corner of section No. 7, in parish of Kalateenee; on the west by section No. 3, in the occupation of Mr. John Evans, called Euroca, by section No. 6, section No. 11, and section No. 16; thence by a line west to the corner of section No. 23; thence by a line due south to the south branch of the Maria River, having section No. 23 on the west; on the south by Maria River; on the east by the limits of the county of Macquarie; and on the north by the M'Leay River. The whole as thus set forth comprehends sections No. 7, No. 10, No. 17, No. 20, and No. 22, as laid down in the map in the Surveyor General's Office.

No. 28.

Smith William.

Name of Run-Warwick.

Estimated Area-7,680 Acres.

Estimated Grazing Capabilities—400 Cattle.

Situated on the north bank of the M'Leay River, and bounded on the south by that River; on the west by Yarrawal; on the east by the boundary line of Thomas A. Salmon's Run; and on the north by Christmas Creek,

No. 29.

Salwey Herbert. Name of Run—Calatini.

Estimated Area—19,200 Acres.

Estimated Grazing Capabilities-600 Cattle.

On the north by the M'Leay River to the mouth of Dungee Creek; west by Pig Station Creek up to a marked tree line leading to Ravenswood; south by dividing Range; and on the east by fence dividing Euroka from Calatini on to dividing Range.

No. 30.

Salwey Herbert. Name of Run—Yesaba.

Estimated Area-7,680 Acres.

Estimated Grazing Capabilities—400 Cattle.

On the north by a line from the mouth of Dungee Creek to the Dry Creek dividing Captain Briggs' Run from Yesaba; on the east by a line from the Britti Ranges to the mouth of Dungee Creek, dividing Mr. M'Leod's and Mr. Ainsworth's Runs from Yesaba; on the south by the Britti Ranges; and on the west by the Wabbra dray road to the Dry Creek.

No. 31.

Salmon Thomas Armitage.
Name of Run—Glenrock Plain.
Estimated Area—5,000 Acres.

Estimated Grazing Capabilities-300 Cattle.

Situate on the north bank of the M'Leay River, by which it is bounded on the east and south; by Messrs. Chapman and Co's. Station on the north; and by Mr. William Smith's on the west.

No. 32.

Warne John and Charles F. Name of Run—Five Day Creek.

Estimated Area—19,200 Acres.
Estimated Grazing Capabilities—750 Cattle.

Situate on the creek called Five Day Creek, leading into the River M'Leay; bounded on the north by the table land; on the south by the M'Leay River; on the west by the range dividing the waters of George's Creek from Five Day Creek; and on the east by the range dividing the waters of Five Day Creek from P. D. Creek.
