CLAIMS TO LEASES OF CROWN LANDS,

BEYOND THE SETTLED DISTRICTS.

NEW ENGLAND DISTRICT.

IIIS Excellency the Governor directs it to be notified for the information of all persons interested, that in pursuance of Her Majesty's Order in Council, of 9th March, 1847, the undermentioned persons have demanded Leases of the several Runs of Crown Land, particularised in connexion with their respective names.

Persons who object to any of these claims, either wholly or in part, should lodge caveats at this Office within two months from the present date, specifying the Lands to which their objections extend, and the grounds on which their objections are based.

It is to be distinctly understood, that the Government does not pledge itself to the issue of a Lease in any case until due enquiry has been made into the validity of the claim, and whether or not it may be necessary to reserve any portion of the Land claimed, for any of the public purposes contemplated in the Order in Council.

Bounded on the north by a range dividing it from Windyer's run Deep Water; on the south by a range dividing it from A. Boyd's Run; on the west by a marked tree line dividing it from Bloxam's Run; on the east partly by a broken range dividing it from Duncan's Run Glen Elgin; and an imaginary line dividing it from the Whit-

Bounded on the north and south-west by a range dividing it from Captain Ditmas' Run; on the north and east by a range dividing it from A. Boyd's Run; on the south by a range dividing it from William Boyd's Run; on the west by a range dividing it from M'Intyre's Run Waterloo.

No. 3.

Name of Run—Mole River.
Estimated Area—60,000 Acres.
Estimated Grazing Capabilities—10,000 Sheep.
Bounded on the north and north-east by a range dividing it from the Clifton and Tenterfield Runs;

on the south-east by a broken country dividing it from Irby's Run Bolivia; on the south by a range dividing it from Windyer's Run Deep Water, and Robertson's Run Wellington Vale; on the west by a spur of a range dividing it from Morgan's Run on either side of the river; and a broken country dividing the Table Land from Blaxland's Run on Reedy Creek.

No. 4.

Australasia, Bank of. Name of Run-Kentucky. Estimated Area-40,000 Acres. Estimated Grazing Capabilities-10,000 Sheep.

Bounded on the east by a range dividing it from Marsh's Run Salisbury; on the north by a ridge to the west end of a Lagoon known as Dangar's Lagoon, dividing it from Dangar's Run Gostwyck; and from thence by a ridge dividing it from Dumaresq's Run Saumarez, and the fall of the water, westward from said ridge; on the west by a ridge dividing it from Morse and Tourle's Run, and partly by Buchanan's Run; on the south by a ridge dividing it from Taylor's Run.

Estimated Grazing Capabilities-8,000 Sheep.

Bounded on the north by the Apsley River; on the west by a marked tree line, and range dividing it from Rusden's Run, on the south by a range dividing it from "Walcha" Run; on the east by a range dividing it from Macnab's Run; and the fall of the water from said ridge to Stoney

No. 6.

Australian Agricultural Company. Name of Run-Nowendoc. Estimated Area—14,000 Acres. Estimated Grazing Capabilities-800 Cattle, 8,000 Sheep.

Bounded on the north and north-west by the dividing range between the Manning and M'Leay Rivers; on the east by the Cooplacurripa Range; and on the south and south-west by the range bounding the left bank of the Barnard River; adjoining on the north Mr. William Dennis Station; and on the south other stations Giro, and Upper Barnard, in the occupation of the Australian Agricultural Company.

Australian Agricultural Company. Name of Run-Giro. Estimated Area—14,060 acres. Estimated Grazing Capabilities - 250 Cattle, 2,000 Sheep.

Commencing at Stony Creek, on the Upper Barnard River; bounded on the south by the River to a point 5 miles above the Stockyard, at the turning off of the Mountain Road up the Big or Hungry Hill; on the north and north-east by the Mountain Range; and on the east and west Survey herewith forwarded.

Australian Agricultural Company. Name of Run-Upper Barnard. Estimated Area-11,500 acres. Estimated Grazing Capabilities - 300 Cattle, 3,000 Sheep.

Situated on the right bank of the Upper Barnard River; bounded on the north and northeast by the river, commencing on the east at a point opposite Stony Creek and terminating on the west at a point opposite the western limit of the leased land called Giro, as per enclosed sketch; and bounded on the south by the Mountain Range.

No. 9.

Ashbee Edward. Name of Run-Frazer's Creek. Estimated Area—60,000 Acres. Estimated Grazing Capabilities-4,000 Cattle.

On the south by George Wyndham's marked tree line; on the east by Mr. Strathan's station; on the north by Messrs. George Bowman's and Bettington's runs, the runs being divided by the apex of the ridges between Frazer's Creek and the Severn; on the west by the apex of the ridges separating the waters that flow into Frazer's Creek from those that flow into the M'Intyre.

No. 10.

Anderson Colin Alexander. Name of Run—Newstead. Estimated Area—71,680 Acres. Estimated Grazing Capabilities-15,000 Sheep.

This station is watered by two small creeks, Newstead Creek and Swanbrook, both running into the M'Intyre River; and bounded on the north and north-east by a range dividing the waters falling into Swanbrook from King's Plains (Mr. Vivers) and Waterloo (Mrs. M'Intyre); on the south by the Mintyre River; on the west and north-west by a marked boundary line running nearly north, north-east and south southwest, dividing this run from Glenmore (Messrs. Brown and Alcorn) and Inverell (Mr. Campbell); east and south-east by a range of mountains dividing the waters falling into Newstead Creek from those of Paradise Creek (Mr. Dangar.)

No. 11.

Boyd Archibald. Name of Run-Boyd's Plains. Estimated Area—80,000 Acres. Estimated Grazing Capabilities-1,500 Cattle, 1,000 Sheep.

Bounded on the south by W. M. Boyd's station, the bluff point of the main range leading in a straight line west into Beardie Creek, following a branch creek west south-west to the range between Boyd's Plains and Glen Innes' run, continuing the range for 2 miles below Garrapond; on the north by Dundeo station :- A high stringy bark range leading from the Beardie Creek in a north-eastern direction to the boundary of Glenelgin, a thick scrub being the division; on the east by a bald hill, known as the Bald Nob, from by lines bearing north-east 2 miles in length as per thence along a spur leading to Man's River, following Man's River to the point of the bluff range,

a mile above J. P. Robinson's cattle station; 6 or 7 miles, where it crosses to the south bank, continuing the spur to the main range; following this main range southerly between Boyd's Plains and the Run occupied by Richard Old, until you join the bluff point on the south line.

No. 12.

Boyd Archibald. Name of Run-Whitmore or Yarrow Ford. Estimated Area - 50,000 acres. Estimated Grazing Capabilities—5,000 Sheep.

North by Dundee Plains; south by Blair Hill; east by Shannon Vale Run; west by Dividing Range.

No. 13.

Boyd William Mitchell. Name of Run-Boyd's Plains. Estimated Area—Not stated. Estimated Grazing Capabilities—2,500 Cattle.

Extending from the source of Boyd's or Beardy Creek on both sides for about 14 miles in length by about 4 in width, including the ground on the main stream as well as that on the banks of the tributaries which flow into it on either side; the main creek flowing from south to north; the boundary on the east, south, and west being the summits of the dividing ranges from which the waters fall on every side into the Beardy Creek; the boundary on the north is a swamp on the west side of the creek, and about 4 miles from the head station, with an imaginary line from the swamp in a direct line across the plains to the top of the great dividing range on the east side; this north boundary divides the stations of Mr. A. and W. Boyd. The chief, or leading geographical feature, is the great dividing range, between the eastern and western waters, this station being entirely on a western water.

No. 14.

Bloxsome Oswald. Name of Run-Ranger's Valley. Estimated Area—70,000 Acres. Estimated Grazing Capabilities-18,000 Sheep.

Bounded on the west by broken ranges of mountains to the west of Beardy waters; north by a leading range dividing it from Mr. Robertson's run to Rocky Point, and from thence to Beardy Water; east by part of same range and a marked tree line to Sugarloaf Mountain, dividing it from Mr. Windeyer's station and Dundee Run; and south from Sugarloaf Mountain by broken range to Beardy Water.

No. 15.

Bowman George. Name of Run-Maidenhead. Estimated Area—63,000 Acres. Estimated Grazing Capabilities-2,000 Cattle or 5,000 sheep.

Bounded on the north by a marked tree line about 7 miles above the station, dividing this from Mr. Blaxland's run, and crossing the river there at right-angles, commencing at the river and running westward about 4 or 5 miles; on the west Hethrington's run, continuing a line to the river | eastern and western waters.

to a tree marked by Shaw and Leicester, situated in a small watercourse, about 4 miles from the station on the righthand side of the road going up the river, and a continued southerly line for about 6 miles, still being the dividing line from Hethrington's run; on the south by an easterly line for about 16 miles, and thence northerly (crossing the Beardy Creek waters about 6 miles from the river) for about 10 or 11 miles; and again on the north by a line westerly to the commencing marked tree line at the river, being about 4 miles. This run is supposed to contain about 63,000 acres, and consists of about one-third part of good grazing flats and hills, and the other two-thirds stony and brushy ranges and steep rocky mountains; watered by the Severn River, Beardy Creek, and some small creeks.

No. 16.

Borthwick Thomas P. (per W. M. Borthwick.) Name of Run-Auburn Vale. Estimated Area—76,800 Acres. Estimated Grazing Capabilities - 500 Cattle,

6,000 Sheep.

Undulating ridges. The greatest part of the run is unfit for sheep; it consists of sandy ground, and is only fit for a back run for cattle in the winter; bounded on the east by Mrs. Hughes, Mr. John Browne, and Mrs. Macintyre; also on the north by Mrs. Macintyre; and on the west by Henry Dangar, Esq.; and on the south-west by Allen Macpherson, Esq., for 2 miles along the Bundarrah River.

No. 17. Betts and Panton (per John Panton.) Name of Run-Jeogola. Estimated Area—28,000 Acres.

Estimated Grazing Capabilities—1,500 Cattle.

Bounded by Mr. Hall's station, and extending to the River Styx; watered by this river, Oaky Creek and Ponds; the boundary of Mr. Hall's station is, per the Commissioner's authority, forming our boundary. The Commissioner not having fixed the exact boundaries, it is impossible to give the exact description.

No. 18.

Brown John and Edward Alcorn. Name of Run-Elmsmore. Estimated Area—51,200 Acres.

Estimated Grazing Capabilities-1,200 Cattle.

Bounded on the west by the late Peter Macintyre's station, on the north by Alexander Campbell's station, and on the north-east by Sinclair; on the east by a dividing range, boundary of Henry Dangar's station, Paradise Creek; on the south by Mrs. Hughes' station, Cope Creek, having a frontage on each side of the river 8 miles by 10 miles.

No. 19.

Browne and Herring (per H. II. Browne.) Name of Run-Barney Downs. Estimated Area—90,000 Acres. Estimated Grazing Capabilities—700 Cattle, 7,000 Sheep.

Bounded on the north by Wellington look out; east by the Falls; south by a range of mountains; by a scrub and range dividing this from Mr. Wm. and west by the range dividing the falls of the No. 20.

Buchanan W. F. (per C. H. Buchanan.)
Name of Run—Looanga.
Estimated Area—35,000 Acres.
Estimated Grazing Capabilities—6,000 Sheep.

Bounded on the east between the runs of Messrs. Taylor and Buchanan, by a range northerly draining the waters into Carlisle Gully; on the north by a range bearing westward about 10 miles between Kentucky Run and that of Messrs. Morse and Thurl, draining the waters into Carlisle Gully, and by the Bundara Road; and to the south by Carlisle Gully, bearing easterly about 8 miles to the head thereof,—breadth about 6 miles—broken country and part sandy soil.

No. 21.

Buchanan C. H. and W. F. Name of Run—Rimbauda. Estimated Area—38,400 Acres. Estimated Grazing Capabilities—1,000 Cattle.

Bounded by Carlisle Gully to the north, and C. H. Buchanan's run, about 10 miles; to the west by Bundara Road and Gipson's run; and to the south and east by William Buchanan's run, by a range running nearly parallel to the New England Road, about 8 miles, general breadth about 6 miles, broken country and part sandy.

No. 22.

Burrowes Nathan.
Name of Run—Hanging Rock.
Estimated Area—15,360 Acres.
Estimated Grazing Capabilities—500 Cattle.

Bounded on the east side by Armytage's Creek; on the west by the Peel River; on the north by Mr. Thomas Hall's station; and on the south by the Hanging Rock.

No. 23.

Blick John W. P.
Name of Run—Tyringham (Belmont?)
Estimated Area—17,280 Acres.
Estimated Grazing Capabilities—800 Cattle or
5,000 Sheep.

Bounded on the east by the Harness Cask River three miles, running north to its junction with O'Connel's Main Water; on the north of the said Main Water by a line north three miles to the top of a high range of hills; on the north by the said range running west or thereabouts four miles and a half; on the west by a line south 6 miles crossing the said main water; on the south by a line east to the commoneing point. The runs adjoining are—the Stockyard or Mitchell's on the east, Ward's (new run) and Hyland's on the north-west, O'Connell's on the west, and Freeman's and H. Dangar's Bald Hills on the south.

No. 24.

Barlow Alexander.
Name of Run—Abington.
Estimated Area—53,760 Acres.
Lemmated Grazing Capabilities—2,000 Cattle.

commencing at the mouth of a creek called Five Mile Creek or Cash's Creek, and extending down-

wards to a gully opposite to Mr. A. Darby's house, dividing it from Mr. Hall's station; on the north by top of mountains, which form a sort of basin, commonly known as head of George's Creek and Laura or Smashem's Creek, then by a direct line from these mountains to some rocks in Laura Creek, and extending onwards to top of the ridge which divides the waters between Laura Creek and Barlow's Creek, and by the top of this ridge downwards to the high road, and then by the head of the waters which fall into the gully opposite Mr. A. Darby's house, separating it from Mr. Smith's station; on the south by a creek called the Five Mile Creek or Cash's Creek, commencing at Bundarra River, and extending upwards until it is joined by the Basin Creek; then by the Basin Creek and by the heads of the waters that fall into the Basin, separating it from Mr. Munro's station; on the east by the top of the mountains which divide the table land of New England from the Bundarra Country, commencing at some high perpendicular rocks up Barlow's Creek, Mr. Marsh's station (Borrolong) being on the other side.

No. 25.

Blaxland Edward J., and Arthur, (now John Dobie and John Blaxland.)

Name of Run—Aitkin's Flat.

Estimated Area—20,000 Acres.

Estimated Grazing Capabilities—800 Cattle.

Bounded on the east by Boman's Station; and on the west by Bonshaw Run; and on the north and east by two creeks.

N.B.—This Run has been transferred, with the sanction of the Government, to Messrs. John Dobie and John Blaxland, in whose names the Lease will accordingly be prepared.

No. 26.

Brown, Hetherington, and Robinson.

Name of Run—Bonshaw.

Estimated Area—143,360 Acres.

Estimated Grazing Capabilities—2,000 Cattle and
6,000 Sheep.

Bounded on the north by Mr. Cox's Run, the boundary between them being an imaginary line running due east and west from a marked tree, said tree being on the point of a stony range which abuts on the west side of a large sheet of water in the river, between 2 and 3 miles north of Bonshaw head station; on the south by high land, which divides the waters flowing into the Frazer from the waters flowing into the Severn; on the east by George Bowman's Run, the boundary being an imaginary line running north and south from a marked tree on the point of a range, which abuts on the river, about half a mile east of Oaky Creek; and on the west by an imaginary line running north and south from a marked tree near the junction of Branch Creek and Mandoey Creek.

No. 27.

Bingle John R., and Seymonr G. Watt. Name of Run—Hartswood. Estimated Area—50,000 Acres. Estimated Grazing Capabilities—700 Cattle.

Bounded on the north-east by Separation Creek; on the south-east by the Bundarra River; on the north-west by Myall Creek, or the separation line between the adjoining station.

No. 28.

Campbell Alexander.
Name of Run—Inverell.
Estimated Area—50,000 Acres.
Estimated Grazing Capabilities—10,000 Sheep.

Bounded on the south and south-west by the M'Intyre River for 7 miles; on the west by a marked tree line, running nearly north for 4 miles, bounding Mrs. M'Intyre's station; on the north by the range dividing Swan Brook from Frazer's Creek for 12 miles, bounding George Wyndham and William Vivers; on the east by a marked line bounding Dr. Anderson about 7 miles; and on the south-east by the range dividing Swan Brook from King's Creek and the M'Intyre River, bounding Messrs. Brown and Alcorn. This station is watered by the M'Intyre River and Swan Brook.

No. 29.

Clerk Edward George.
Name of Run—Clerkness.
Estimated Area—66,560 Acres.
Estimated Grazing Capabilities—16,000 Sheep.

East south by Georgo's Creek; south, Bundarra River; north by King's Gut Range; west by Messrs. Darby and Goldsmith's run of water-holes.

No. 30.

Coventry Andrew.
Name of Run—Oban.
Estimated Area—32,000 Acres.
Estimated Grazing Capabilities—7,000 Sheep.

All the lands drained by the River Anne, and by the Denner Gully, from the heads of them down to the falls.

No. 31.

Crawford and M'Donell (per A. F. Crawford.)
Name of Run—Moona Plains.
Estimated Area—15,000 Acres.
Estimated Grazing Capabilities—600 Cattle and
4,000 Sheep.

These lands are bounded south and east by the Falls of the Table Land into the M'Leay District; west by ranges and a marked line dividing this station from those of Huth and Eliott; and south by the head of Richards' Creek, and an imaginary line running eastward.

No. 32.

Cruikshank Frederick.
Name of Run—Enmore.
Estimated Area—10,000 Acres.
Estimated Grazing Capabilities—1,200 Cattle,
4,000 Sheep.

Broken country and scrubby, bounded on the east, north, and south by the Falls forming the head of the McLeay River, on the west by a dividing range running north and south about 4 miles, separating Enmore from Mihi Creek, now in the occupation of Messrs. Cullen and Ferrett, and Mr. George Jonkins.

No. 87. 14TH AUGUST, 1848,-2

Cullen Thomas.
Name of Run—Mihi Creek.
Estimated Area—12,800 Acres.
Estimated Grazing Capabilities—5,000 Sheep.

Bounded on the north and north-east by the Falls of the M'Leay River; from that by Dangar's Creek, to a marked tree line running about south, to Mr. George Jenkins' licensed run, from that by a line to the Mihi Creek head station, from thence by Mr. Jenkins bough-yard road to the range heading the waters of Gross Creek, from that heading all the waters of Gross Creek to the first named boundary, the Falls of the M'Leay River.

No. 34.

Cox James and Thomas Smith.

Name of Run—Kingsgate.
Estimated Area—26,880 Acres.
Estimated Grazing Capabilities—1,200 Cattle,
8,000 Sheep.

Mountain and undulating ridges, bounded on the east by Government Land; on the west by James Rogerson's scrubby range, and J. P. Robinson's swamp oak creek; on the north by Archibald Boyd's sheep station near the Bald ridge; and on the south by J. Rogerson's Back Creek, watered by Man's River and Yarra Creek.

No. 35.

Dangar Henry.
Name of Run—Gostwyck.
Estimated Area—48,000 Acres.
Estimated Grazing Capabilities—640 Cattle, and
20,000 Sheep.

Watered by Dangar Creek, Gara and Plain's Creek, and Rocky River; bounded on the northeast by Captain Dumaresq and Captain O'Connell's Tilbuster and Gara Stations, by astringy bark range, terminating near the Captain's Creek, then by that creek adjoining the latter run, in all about 7 miles; on the east and south-east by exceedingly rough country, crossing various falls of the M'Leav River to Dangar's Creek, at a large cataract, thence up that Creek, about a mile to a marked tree line, and a stringy bark range, dividing it from Eumore, (Cruikshank's) Mihi Creek, (Cullen's) and Jonkins' Runs, about 11 or 12 miles; on the south and south-west by a continuation of the same range, dividing the waters of Mihi and Dangar's Creek to a point on the plains ereck, dividing this Run from Salisbury (Marsh); on the west by the Plains Creek to its junction with Dangar's Creek; thence again on the south-west by that creek to a gully near the corner of Marsh's paddock; thence again on the west by a marked line to the top of Willcott's range; thence by a gully from the north side of that range to the Rocky River, dividing this Run from the Salisbury and Kentucky ones about 7 miles; and on the north-west by part of the Rocky River to a marked tree line (determined by Commissioner M'Donald,) to a large stringy bark range dividing it from Saumarez, (Mrs. Dumarcsq) about 12 miles to the commencing

No. 36.

Dangar Henry.
Name of Run—Paradise Creek.
Estimated Area—32,000 Acres.
Estimated Grazing Capabilities—8,000 Sheep.

Watered by the M'Intyre River; by Cope's, Paradise, and Aurora Creeks, and bounded on the north by very broken country, dividing this from Brown's Run, and an elevated range dividing it from Dr. Anderson's Run, 10 or 12 miles; on the east by a broken country, including all the heads of the creek, and a barren range leading to the falls of Aurora Creek 8 miles, dividing this Run from Wauchope's Moredun Run; on the south and west by an elevated range leading to Cope's Creek, thence by part of that Creek, and a line traversing the broken country, dividing this from Brown's and Wauchope's Runs, about 13 or 14 miles.

#### No. 37.

Dangar Henry.
Name of Ruu—Bald Hills.
Estimated Area—19,200 Acres.
Estimated Grazing Capabilities—960 Cattle.

Watered by several heads of the Clarence, and bounded on the west by Captain O'Connell's Hernaui Station, by the boundary creek, commencing at the Gulfs at its head, and extending down to a noted Rocky Nob near the Creek; on the north by Freeman and Mitchell's Stations, on an east line 6 miles to Jackass Creek; on the east by that Creek, about 5 miles to the coast scrub, and at the head of the said Creek; and on the south by the coast scrub including the heads of all the waters between Jackass, and the boundary creeks, to the commencing corner at the Hernani Station.

#### No. 38.

Day Edward Denny.
Name of Run—Aberfoil.
Estimated Area—75,000 Acres.
Estimated Grazing Capabilities—25,000 Sheep,
or Cattle in proportion.

This Run is bounded by Mr. Wm. Dangar's Serpontino Station; on the south by Messrs. Landsborough's Run; on the north by Ward's Mistake; and on the west by Falkner's Plains.

#### No. 39.

Dangar William.
Name of Run—Kangaroo Hilfs.
Estimated Area—35,840 Acres.
Estimated Grazing Capabilities—10,000 Sheep.

Bounded on the west by the station of E. D. Day, commencing at a point on Cook's Creek, determined with Mr. Day, and to follow the Creek up to the read, and to run about the range dividing the waters of the second Chandler from those of the Sagar Loaf River, from a tree marked W. and J. D. on one side, and Day on the other; on the south by a spar of the Snowy Mountain Range; on the east by the Scabby Station Creek and Dough Boy Hollow Creek; on the north by impassable Gulfs or the waters of the River Ann or Styx, running to the Clarence River, all the waters of the Creeks fall into the Clarence.

Dangar William.
Name of Run—Serpentine River.
Estimated Area—19,200 Acres.
Estimated Grazing Capabilities—650 Cattle.

Bounded on the north by Mr. Wards station' Guy Faux; to commence at the small creek running into the first Guy Faux, above the fall near the tree marked WTD to follow up that creek to the range dividing the waters of the Clarence from those of the McLeay then to follow that range eastward to the coast range, Mr. Ward taking the country to the northward of this boundary decided by Mr. Macdonald in 1844; on the east by the coast range scrubby; on the west by the Snowey Mountains; on the south by a small stream falling into the McLeay called the third stream, backed in by gulf's and dense scrubs.

Donaldson Stuart Alexander.
Name of Run—Tenterfield.
Estimated Area—100,000 Acres.
Estimated Grazing Capabilities—800 Cattle,
25,000 Sheep.

This station is bounded by Mr. Marsh's, the Bank of Australasia late Mr. M'Lean, and Mr. Nevisson;—boundary lines run as follows,—from Sugarloaf Hill to Master's Swamp, keeping the dividing range cross the Peel road at Master's Swamp, and continue along the dividing range called Marsh's big hill to a rocky point on the crock, about half a mile from the head station up the gully leading to one tree hill on Salisbury Plains, and from that straight to Sugarloaf Hill, distance 7 miles from Sugarloaf Hill to Master's Swamp, 3 miles from Master's Swamp to Rocky Point, and 3 miles from that to Sugarloaf Hill.

No. 114.

Tod Alexander.
Name of Run—East Yarrowitch.
Estimated Area—32,000 Acres.
Estimated Grazing Capabilities—8,000 Sheep.

On the west, north, and south by the river Yarrowitch and a straight line from the head of that river to the dividing range; on the east by the most casterly of the three creeks which are crossed on the old Port Macquario Road, and following it down till it falls into the Yarrowitch; as also the following portions of the west bank of the Yarrowitch, viz.,—the small herse paddock in

which Alexander Tod's hut now stands, and the Inn called the "Squatters' Arms," and the flat in front of it, but excepting from the above the hut and garden of Christopher Dawson Fenwick, and that portion of the bullock paddock which is on the eastern side of the Yarrowitch. The above Run is bounded on the west, north, and south by Christopher Dawson Fenwick's Run of West Yarrowitch; and on the east by thick unavailable scrubs unoccupied.

No. 115.

Vigne Frederick.
Name of Run—Tenterden.
Estimated Area—64,000 Acres.

Estimated Grazing Capabilities-12,000 Sheep.

Bounded on the east by the Messrs. Everett's station, the eastern boundary line begins on the high hill close to Ram's Gully, on the Boorelong road, runs in a straight line to a rocky hill, and so across the Sandy Creek to a marked tree on the top of the dividing range between Brushy Creek and Sandy Creek, and thence continues by a marked tree line on the top of the dividing range between Brushy Croek and George's Creek, and crossing George's Creek about 2 miles above Tenterden is continued by a marked tree line along the top of the dividing range between the Kangaroo Creek and the Limestone Creek, and continues across the Limestone Creek to the top of the range which sheds its water into the Limestone; the northern boundary continues along the top of the range which sheds its water into the Limestone Creek; the southern boundary is the top of the dividing range between Reedy Creek and Sandy Creek, commencing at the high hill above mentioned, close to Rams Gully, and continuing as far as the junction of the two creeks-the Reedy and Sandy Creeks, the boundary line then crosses Sandy Creek and runs two miles back from the creek; the western boundary is the fall of the table land.

Vivers William.

Names of Runs—King's Plains & Frazer's Creek. Estimated Area—61,440 Acres.

Estimated Grazing Capabilities—1,000 Cattle, 10,000 Sheep.

Bounded on the north by a barron scrub, dividing Mr. Polhill's station, Pindari, from King's Plains and Frazer's Creek, extent of about 14 miles on the east and west line; on the east by a chain of ridges dividing Wellingrove and Waterloo Runs, extent about 8 miles on the north and south line; on the south by a chain of ridges dividing part of Newstead and Swan Brook Runs, extent of about 18 miles, including part of a creek that runs into Swan Brook, occupied for 8 years unmolested, within the boundary of my returns, uow disputed by A. Campbell, since 1816, on the east and south-west line; on the west by a ridge agreed upon by Mr. A. Campbell and Mr. W. Strachan, extent of about 4 miles on the north and south line.

Windeyer Charles and Archibaid.

Name of Run-Deep Water.

Estimated Area -60,000 Acres.

Estimated Grazing Capabilities—200 Cattle, 10,000 Sheep.

Bounded on the east by the great dividing range 14 miles; on the north by a spur of the great dividing range, separating this run from Irby's (Bolivia Run,) S miles; and on the west and south by about 16 miles of low ranges, dividing the waters of the Mole from the Beardy Waters, and separating this run from those of Bloxsome, Robertson, and Dundee.

No. 118.

Windeyer W. H. and F. Eldershaw.

Name of Run-Manooan.

Estimated Area—17,000 Acres.

Estimated Grazing Capabilities—300 Cattle, 4,000 Sheep.

Commencing at the hill known especially as Ben Lomond, the summit of which is part of the southern boundary, follows the course of the Ben Lomond Range for about 6 miles in a northerly direction, (said range being the western boundary and division between Manooan and Wauchope's Run) to the head of a branch of Beardy Creek, known as Williams' Creek, down that creek to where the main road from Armadale to the northward crosses it, then along the road in a southerly direction about half a mile to the top of the ridge dividing the eastern and western waters, there hardly to be distinguished as a range, along said ridge about 2 miles to a point where Old's road to Beardy Plains crosses it, said range, road, and creek dividing Manooan from Boyd's run, and being the north-western boundary, from that point down a spur of the range in an easterly course to Manooan Creek, then down that creek about half a mile to a point adjacent to an established marked tree on the road from Manooan to Old's, and about equi-distant from the head stations of those two runs, thence following an allowed marked tree line running east with a little southing to an established marked tree on Mann's River, opposite Mr. Old's four mile station, the said marked tree line, creek, and spur of range being the northern boundary and division of Manocan from Old's run, from the marked tree opposite Old's four mile station in a southerly direction up Mann's River about 2 miles to a determined stringybark range, then up said range in a westerly direction about 1 mile to the top of the ridge dividing the waters of Mann's River and Manooan Creek, along the said ridge first in a southerly and then in a westerly direction about 6 miles to Ben Lomond Hill, being the eastern and southern boundaries, and dividing Manooan from Old's and Rawson's runs.

Wyndham George.

Names of Runs-Bukkulla, and Nullamana.

Estimated Area—Bukkulla 100,000 Acres, Nullamana 30,000 Acres.

Estimated Grazing Capabilities—Buckkulla, 2,000 Cattle, 10,000 Sheep, Nullaman, 6,000 Sheep.

Comprising a section of the vallies of the M'Intyre and Frazer; bounded on the south by the watershed of Swan Brook, and by M'Intyre's Run, and Waterford's—the boundary line of each being determined; on the east by Vivers' Run, Polhill's and Strachan's; on the north by Blaxland's Run and Red Bank Creek; on the west by the watershed to Reedy Creek.

No. 120.

Wauchope Andrew.

Name of Run-Moredun.

Estimated Area \_\_ 67,200 Acres.

Estimated Grazing Capabilities-15,000 Sheep.

The station is situated on western waters, and is bounded on the east by the dividing range between the eastern and western waters; the eastern side being occupied by William Rawson, Esq.; on the north and north-west it includes all the ground that lies on the fall of the water into the Creek, that passes the head station called Moredun Creek, (dividing it from the ground occupied by W. M. Boyd, Esq.,) as well as into the Orora or Reddy Creek, and the heads of the river Macintyre, (dividing it from the ground occupied by Mrs. Macintyre or her Trustees); on the west the station is bounded by the said Macintyre river as low as the common crossing place of said river, on the road between Moredun and Byron Plains, dividing it from the Run of H. Dangar, Esq.; on the south-west by a line drawn from said crossing place to where the Limestone Creek runs into the Moredun Creek, about 8 miles below the head station; and on the south it includes the ground that lies on the fall of the water into the Moredun Creek, as well as into that swamp, between the Moredun and Limestone Creeks called Jones' swamp, and at a certain marked tree boundary line, about a mile parallel with the road between Moredun and Mr. Everett's station, all the ground that lies on the fall of the water into the Limestone Creek, dividing it on that side from the ground occupied by Messrs. Vigne and Everett.

Wilson and Milford.
Name of Run—Aberbaldie.
Estimated Area—24,320 Acres.
Estimated Grazing Capabilities—1,200 Cattle, or 8,000 Sheop.

On the north by the Surveyor's Creek Run, belonging to Messrs. Jamison and M'Kenzie, being on the west side of the River Macdonald, a stony ridge running back for about 4 miles from the river, at an old station called Mona Vale, to the range dividing the Liverpool Plains from the New England district, all waters falling to the south side of the stony ridge being claimed by us; and on the east side of the River by Cash's Creek, all waters falling into this Creek on the south side being claimed by us; this portion of the Run on the east side of the river is bounded on the east by the main range, dividing the eastern and western waters and as far as to the ugly range up the river to the south; on the south by Ingalba Run, being on the west side of the river, a straight line drawn at right angles from a point on the river, exactly half way between the two head stations of Ingalba and Aberbaldie, to the range separating the Liverpool Plains and New England Districts, and dividing the country between the two head stations into two equal portions; and on the east side of the river, by Glen Morison, being a straight line drawn from a point on the river one mile and a half below Glen Morison, to the point where the road from Glen Morison and Ingalba to Branga crosses the Bald swamp; on the east by Branga, being the Bald swamp from the point where it is crossed by the road from Glen Morison and Ingalba to Branga, to its junction with the running creek, and from that point of junction in a line to the rough country between the deep gully on the Cobrabald Creek, from that point down the Cobrabald Creek to its junction with the river Macdonald-being the boundary line between ourselves and Bergen-op-zoom; on the west by the range dividing the Liverpool Plains from the New England District.

Estimated Area—16,000 Acres.
Estimated Grazing Capabilities—640 Cattle.
