WHEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the ninth year of the reign of Her present Majesty, the Governor and Executive Council of the Colony are empowered in certain cases therein named, to substitute a declaration in lieu of an oath, solemn affirmation, or affidavit, which might, but for the passing of that Act, be required to be taken or made, which said declaration is to be made and subscribed before the Officer previously empowered to administer such oath, solemn affirmation, or affidavit, notice is hereby given, that His Excellency Sir Charles Augustus Fitz Roy, the Governor of the said Colony, and the said Executive Council, have been pleased, in pursuance of the said Act, to substitute, by an Order in Council, a declaration in lieu of oath, solemn affirmation, or affidavit, required in the case, and in respect of the matters mentioned in the said Order, which is as follows, viz. :-

To the Male Children above 6 years of age :-On Holidays, 200z. flour, 120z. meat, ½0z. salt, ½0z. tea, 1\frac{1}{3}\text{oz.} sugar, 1\frac{1}{4}\text{oz.} raisins or currants, 1\frac{1}{3}\text{oz.} suet, \frac{1}{2}\text{oz.} soap. On Thursdays, 160z. flour, \frac{1}{2}\text{oz.} salt, joz. tea, 1 joz. sugar, 1 joz. raisins or currants, 1½0z suet, ½0z. soap,. The Districts for which Contracts will be required are as follows, viz ;-

The Districts numbered 1 to 17, and 19 to 32, are the Police Districts described in the Notices from this office, dated 15th, September, 1841, 9th August, 1842, and 25th March, 1845. Further particulars may be obtained from the several Police Magistrates and

Benches.

Separate Tenders will be required for the forage in the District of Sydney, but the other supplies for that District are to be tendered for together.

The supplies for each of the other Districts, with the exception of those for the Protestant Orphan School, the Institution for Destitute Roman Catholic Children, and the Lunatic Asylums, are intended to be included in one Contract, and therefore no Tenders can be received, unless for supplying the whole that may be required in the entire of a District, and for each District there must be a separate Tender, excepting Hartley and Blackheath, and Yass, Gunning, and Narrawa, and Bathurst and

Separate Tenders must also be made for the flour, 120z. meat, 20z. salt, 20z. tea, 22 oz. sugar, Protestant Orphan School, the Institution for Destitute Roman Catholic Children, and for the Lunatic Asylums.

CONDITIONS

1. All the articles required by this Notice are to be of the best quality of their several kinds.
2. The Flour and Bread must be the produce of

clean sound Colonial wheat, from which, when forming part of the Ration to Prisoners of the Crown, 10 per cent., and in all other cases, 20 per cent. has been extracted in bran and waste.

3. Beef and Mutton to be issued in such proportions as may be required for the Ration to Immigrants, and when the quantity admits of it, this, as well as the Convict Ration of Beef, to be delivered in fore and hind quarters alternately.

4. Beef to be issued to the Protestant Orphan School on five days, and Mutton on two days of the week, for the Boys; and for the Girls, Beef to be issued three days, and Mutton four days of the week.

.5. The Maize Meal to be similar in quality to the Wheat Meal, and to be twice ground.

6. The Tobacco to be Colonial.

7. When it may be necessary to substitute one article for another, the following proportions are to be observed, viz. :—1 ib. wheat flour or 1 ib. biscuit equal to 14th. of bread; 1th. salt Beef or 1th. Mutton, or 10oz. salt Pork, equal to 11b. of fresh Beef; 1lb. of Coal equal to 3lbs. of Firewood.

8. These substitutions are to be made only when required by the Officers authorised to draw the

several Rations.

9. Hospital Bread is to be supplied to the Children of the Orphan School, and to the Institution for Destitute Roman Catholic Children, when required by the Surgeon, in lieu of the ordinary Ration.

10. Vegetables to be supplied in reasonable proportions of potatoes, greens, pumpkins, onions,

&c., &c.

11. In case the whole Ration of Forage be not required or delivered, the several articles composing it are to be reckoned in the following proportions, and paid for accordingly, viz. :

The Maize or Barley, as 4-12; the Hay, as 5-12; the Bran, as 2-12; and the Straw, as 1-12 of the

whole Ration respectively.

12. The Supplies for Immigrants in the Sydney. District are to be delivered at such places in the City as

may be required by the Agent for Immigration.

13. The supplies of Provisions, Fuel, and Light for the Penal Establishment at Cockatoo Island are to be delivered on the Island by the Contractors. 14. In respect of supplies for other services they

are to be delivered at the nearest station, on the re-

quisition of the Officer in charge.

146. The Tenders for Provisions and Forage, when required by Rations, according to the scale under their respective heads, are to express the price per Ration only.

16. The Tenders for Forage are not required to state, the price of the Ration for Oxen, as when the latter is required, one-half of the allowance fixed for Horses will be drawn, and one-half the price allowed to the Contractor, whose engagement will be to provide for both Horses and Oxen.

17. In the event of a difference of opinion between the Contractor and the party receiving the Yass, Gunning, and Narrawa, and Bathurst and supplies, as to the quality, the same is to be Orange, for each of which places Tenders may be decided, in cases where the article is not of a perishable nature, by a Board of Survey, composed

to the practice of the service. But in country districts, where such a Board of Survey cannot be conveniently assembled, the party objecting will name one person as arbitrator, the Contractor or his agent another, and these two will (previously to any other proceeding on their part,) concur in naming a third as umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

18. If the board, arbitrators, or umpire shall decide that the article is not of proper quality it must be immediately replaced by the Contractor, failing of which, it will be procured by the Department requiring it, and the expense charged to the Con-

tractor.

19. In the event of any unnecessary delay, or failure of the Contractor to supply the articles when required, they will be otherwise procured, and char-

ged in like manner.

20. In cases where the article is of a perishable nature, or from some other cause injury would be sustained, either by the parties to whom the Rations are due, or to the Contractor, by waiting for a Board of Survey, the head of the Department, or Officer in charge of the party or parties for whom the Rations are to be received, shall have power to reject, at the place of delivery, such article or articles as are obviously of inferior quality; it being distinctly understood, that he will be responsible to the Government for so doing; and that the Contractor will have a right to appeal to the Governor, although, in the meantime, he must take back the rejected article, and supply good in its stead, failing of which it will be obtained by the Officer or party requiring it, and the expense charged to the Contractor.

21. A repetition of irregularity in the quality or quantity of the supplies or of any delay in delivering or replacing them when required, will also subject the Contractor, upon the Report of the Officer in charge of the parties or establishment, to such mulet, not exceeding one-fourth the amount of his mouthly account, as the Governor may direct. It will also be in the power of the Governor, upon such repetition, to terminate the Contract forthwith.

22. Great inconvenience having been experienced in former years from the discontinuance of Contracts, under the option given after three months notice on either side, parties tendering will observe that no such power will be reserved in respect to the Contracts for 1850, but that the same will be for the full period of the year, whatever may be the fluctuations in the prices of provisions or otherwise.

23. The Contractor will be required to prepare his own cash account, monthly or quarterly, in the prescribed form; and on the production thereof, with the requisite vouchers, in a complete state to the Officer receiving the supplies, the same will be forwarded by the latter to the Auditor General, in order that a warrant may be prepared and payment made from the Colonial Treasury.

24. The value of all packages to be included in

the prices demanded.

25. Printed forms of Tender may be obtained at this Office, or from the Police Magistrates or Benches of the several Districts; and at the foot of every Tender, there must be a Memorandum, signed by the party tendering, and two responsible persons as sureties, agreeing to be responsible for bullock.
