PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

WHEREAS Her Majesty was pleased, by Letters Patent, bearing date at Westminster, the seventeenth day of February, one thousand eight hundred and forty-six, to erect into a separate Colony, to be known and designated as the Colony of "North Australia," all those parts of the territories theretofore comprised within the Colony of New South Wales, lying to the northward of the twenty-sixth degree of south latitude; and whereas Her Majesty, by Letters Patent bearing date at Westminster, the twenty-eighth day of December, one thousand eight hundred and forty-seven, was further pleased to revoke and determine the said Letters Patent, establishing the said Colony of North Australia; and whereas by a Commission, under the Great Seal of the United Kingdom of Great Britain and Ireland, addressed to me as such Governor as aforesaid, and bearing date at Westminster, the twentieth day of February, one thousand eight hundred and forty-six, Her Majesty did thereby define the Territory or Colony of New South Wales, as comprising all that portion of the Territory of Australia or New Holland, lying between the one hundred and twenty-ninth and one hundred and

fifty-fourth degrees of east longitude, and between the twenty-sixth and fortieth degrees of south latitude, including all the islands adjacent in the Pacific Ocean, within the latitudes aforesaid, save and except that part of Her Majesty's said Territory which is called and known by the name of the Province of South Australia: Now I, Sir Charles Augustus Fitz Roy, as such Governor as aforesaid, do hereby proclaim and notify that, by Letters Patent dated at Westminster, the third day of April last past, Her Majesty was pleased to declare and ordain, that in addition to all the territory defined and comprised as aforesaid, the Territory or Colony of New South Wales shall comprehend all Her Majesty's said Territory lying northward of the twenty-sixth degree of south latitude, with all the islands adjacent in the Pacific Ocean; and all persons are required to take notice thereof accordingly.

> Given under my Hand and the Seal of the Territory, at Government House, Sydney, this sixteenth day of January, in the year of Our Lord one thousand eight hundred and forty-nine, and in the twelfth year of Her Majesty's reign.

PETITION RESPECTING SUPPLY OF LABOR BY A MODIFIED SYSTEM OF TRANSPORTATION.

IIS Excellency the GOVERNOR directs the publication of the following Despatch, from the Right Honorable the Secretary of State, and of its enclosure, in reply to a petition addressed to Her Most Gracious Majesty the Queen, by certain employers of labor in New South Wales, praying that transportation may be revived upon the principles recommended in the report of a Select Committee of the Legislative Council, or upon such modifications thereof as may be deemed expedient.

SIR,

I have the honor to acquaint you that I have received from the hands of Mr. Francis Scott and some other gentlemen, a numerously signed Petition, purporting to proceed from all the principal classes of employers of labor in New South Wales, of which document I enclose a copy for your information.

It would have been far more regular that this petition should have been transmitted through the Governor, and I much regret that the subscribers to it should have thought it advisable to deviate from the usual course. They may rely upon it that they can choose no channel through which any wishes they may be desirous to express, can be transmitted with greater advantage than through Her Majesty's Representative in the

You will acquaint the Petitioners, however, that I have laid their Petition at the foot of the Throne. You are also aware that in the general object at which it aims, Her Majesty's Government concur, and that they will be very glad if means can be found of sending out Convicts, at a proper stage of their punishment, so as both to furnish some addition to that supply of labor of which the Colony stands so greatly in need, and protect it against the moral injury which the system of transportation, as it formerly existed, inflicted upon it. The certainty of employment in the Colony, and the conditions which must be fulfilled before the convict can obtain his pardon and freedom, will, it is hoped, by opening anew the prospect of respectability and independence to him, secure these objects.

But as I have received from you resolutions of the Legislative Council on this important subject, it will be more appropriate to convey to you in answer to that representation any more particular statement of the views of Her Majesty's Govern-

GOVERNOR SIR CHARLES FITZ ROY,

TO THE QUEEN'S MOST EXCELLENT MAJESTY.

The Petition of the undersigned, Bankers, Merchants, Agriculturalists, Stockholders, and others, employers of labor in New South Wales,

Humbly sheweth,

That your Majesty's Petitioners are now suffering great inconvenience and injury from the want of an adequate supply of Labor, owing to the suspension of Immigration, and other causes beyond the power of Petitioners to control.

That the want of Labor of which your Majesty's Petitioners thus complain becomes every day more urgent, in consequence of the additional demand which the natural increase of Cattle and Sheep

rapidly occasions.

That during the last two years, the price of Labor has increased about 50 per cent, a rate of increase incompatible with a fair profit upon Agricultural and Pastoral investments, whilst on the other hand, the price of Wool, (the staple of the Colony,) has fallen at least 45 per cent.

That under these circumstances, many of your Majosty's Petitioners are not only precluded from extending their operations, but, in some instances the farmer has been obliged to suspend them altogether, whilst the owners of flocks and herds will soon have no alternative left but to boil them down for the mere tallow.

That such a state of things, if not speedily remedied, must be productive of results ruinous to the immediate interests of your Majesty's Petitioners, and disastrous to the future prosperity

of the Colony.

That under the pressure of such circumstances, your Majesty's Petitioners have read with much interest a Despatch addressed to the Governor of this Colony by the Right Honorable W. E. Gladstone, dated 30th April, 1846, on the subject of the renewal of transportation to this Colony: They have also read with much satisfaction, the Report of a Select Committee of the Legislative Council, to whose consideration the important Despatch in question was referred.

That your Majesty's Petitioners would earnestly solicit your Majesty's gracious attention to the facts and recommendations set forth in the Report of the Select Committee alluded to, and humbly trust, that they may have sufficient influence on your Majesty's Councils to induce the resumption of transportation to this Colony upon the principles therein recommended, or upon such modifications thereof as may be deemed ex-

pedient.

That in the opinion of your Majesty's Politioners, a such measure would be equally advantageous to this Colony, and to the Parent Country by opening out a cheap and boundless field of reformation for her criminals and support for her paupers, and thus relieving her from the burthen of their maintenance in expensive establishments at Home.

And Your Majesty's Petitioners, as in duty bound, will ever pray, &c.

RETIRED OFFICERS.

IS Excellency the GOVERNOR has been pleased to direct that the following Notice, containing an amended scale of remission to be allowed to Officers in the purchase of Land, issued from the Office of the Secretary of State in August, 1848, for the use of Officers purposing to settle in the British Colonies, and having reference to the Regulations for the disposal of Land in the Australian Colonies, shall be re-published here for the information of all persons interested.

INFORMATION FOR THE USE OF MILI-TARY AND NAVAL OFFICERS PUR-POSING TO SETTLE IN THE BRITISH COLONIES.

1. The Colonies in which Military and Naval Officers are allowed privileges in the acquisition of public Lands are the following:-First,-the Australian Settlements, consisting of New South Wales, Van Diemen's Land, South Australia, Western Australia, and the Northern Province of New Zealand; Secondly,—Ceylon; Thirdly,—the Cape of Good Hope; and Fourthly,—Nova Scotia and Cape Breton, the only province in North America where privileges are still allowed.

2. In the different Australian Settlements, in Ceylon, and at the Cape of Good Hope, land is disposed of by sale only; but Officers purchasing land, are allowed a remission of the purchase money, according to the undermentioned scale :-

Field Officers, of 25 years' service and up-	
wards, in the whole	£600
wards, in the whole	500
Field Officers, of 15 or less years' service,	300
in the whole	400
Captains, of 20 years' service and upwards.

Captains, of 15 years' service or less, in

Subalterns, of 20 years' service and up-

Subalterns, under 7 years' standing, are

Regimental Staff Officers, and Medical Officers of the Army and Navy, are allowed the benefit of

In Nova Scotia and Cape Breton, allotments of land are granted to Officers on the following scale and conditions :---

To a Lieutenant-Colonel	1200 acres
To a Major	1000 acres
To a Subaltern	800 acres 500 acres

3. Officers of the Army or Navy, proposing to proceed to the Colonies, in order to take advantage of this indulgence, should provide themselves with

certificates from the Office of the Commander-in-Chief, or of the Lords Commissioners of the Admiralty, or of the Master General of the Ordnance, showing that their emigration has been sanctioned. and stating exactly their rank and length of service. No document from the Office of the Secretary of State is necessary.

4. Officers on half-pay, residing in the Colony where they propose to settle, are admitted to the privileges of Military and Naval settlers, without referring to this country for testimonials, provided they can satisfy the Governor that there is no objection to their being allowed the indulgence, and that the statement of their rank and length of service is accurate; and provided, if they belong to the Navy, they produce their letter of leave of ab-

sence from the Admiralty.

5. Military Chaplains, Commissariat Officers, and Officers of any of the Civil Departments of the Army; Pursers, Chaplains, Midshipmen, Warrant Officers of every description, and Officers of any of the Civil Departments of the Navy, are not allowed any privileges in respect of land. Although members of these classes may have been admitted formerly, and under different circumstances, they are now excluded. Mates in the Royal Navy rank with Ensigns in the Army, and Mates of three years' standing, with Lieutenants in the Army, and are entitled respectively to corresponding privileges in the acquisition of lands.

6. Gentlemen who have ceased to belong to Her Majesty's Service are not allowed the advantages to which they were entitled while in the Army or Navy. This rule, however, is not to affect Officers who desire to quit the service, for the express purpose of settling in the Colonies; it is only required, that when they resign their Commissions, they should apply for a certificate from the Commanderin-Chief, or from the Lords Commissioners of the Admiralty, or from the Master General of the Ordnance, that they do so with the view of emigrating, and such certificate, if produced to the Governor of any of the Colonies before-mentioned within one year from its date, but not otherwise, will be a sufficient warrant for allowing the bearer the same advantages as Officers who are still in Her Majesty's

7. An actual residence of two years in the Colony must be proved before the titles can be granted, except in cases in which death may have occurred before the expiration of that period.

8. For the convenience of Officers, the following heads are subjoined of the rules for the sale of land in the Australian Settlements:-

All lands are disposed of by sale alone, and must have been once at least exposed to public auc-

The lowest upset price is not less than £1 per acre; but the Government has power to raise the same by Proclamation, though not again to reduce it.

The lands are distinguished into three different classes; viz. Town Lots, Suburban Lots, and Country Lots.

Upon Town and Suburban Lots, as well as upon a proportion not exceeding one tenth of the whole of the Country Lots offered for sale at any auction, the Governor has the power of naming a higher than the general or lowest

upset price: these last to be designated " Spe-

cial Country Lots.'

Town and Suburban Lots are in no case disposed of except by public auction; but Country Lots, which have already been put up to public auction, and not sold, may be disposed of afterwards by private contract at the upset price.

No lands are sold by private contract, except for ready money. When sold by public auction, one-tenth at least of the whole purchase money must be put down, and the remainder within one calendar month, or the deposit is forfeited. Lands are put up for sale in lots not exceeding

one square mile in extent.

9. In Ceylon, land is sold by auction at an upset price, which is to be fixed by the Governor, but which is not to be less than £1 per acre. Before the lands are exposed for sale, they will be surveyed by the Government and duly advertised.

10. The several prices above-mentioned are of course subject to a revision at any time by the proper authorities, and the pecuniary amount of the remission made to Officers cannot be increased on account of an increased value set upon the lands.
