WHEREAS the Legislative Council of New South Wales now stands prorogued to Tuesday, the twentieth day of November instant, and it is expedient further to prorogue the same: Now, therefore, I, Sin Charles Augustus Fitz Roy, Knight Companion of the Royal Hanoverian Gaelphic Order, in pursuance of the power and authority in me vested, as Governor of the said Colony, do hereby further prorogue the said Legislative Council to Tuesday, the first day of January now next ensuing.

Given under my Hand and Seal at Government House, Parramatta, this fifth day of November, in the year of Our Lord one thousand eight hundred and forty-nine, and in the thirteenth year of Her Majesty's Reign.

TEN POUNDS REWARD OR A CONDI-TIONAL PARDON.

PROVISIONS, AND OTHER ARTICLES.

. 1. The Ration for Immigrants :- For Male and Female Adults, of the age of 14 years and upwards daily-16oz. wheat bread, 16oz. fresh meat, 16oz. potatoes or other vegtables, or when these are not obtainable, 80z. wheat bread in lieu thereof, 20z. tea, 1½0z. sugar, ½0z. salt, ½0z. soap, ½1b. oatmeal in lieu of meat if required. One half of the above quantities to Children of Immigrants, under 14 years of age.

2. The Ration for Prisoners of the Crown, and others in the employment of Colonial Departments, when authorised to receive it, with the exceptions specified in No. 3-20oz. wheat bread, 8oz. maize meal, 16oz. fresh meat, ½oz salt, 1oz. sugar, ¼oz.

The Ration to Officers in charge of Surveying parties, when in the field, and men composing such parties, and for Officers and Soldiers of the Mounted Police, and other Mounted parties, when required :- 24oz. flour, 16oz. fresh meat, 1 oz. salt, 120z. tea, 2\frac{1}{2}0z. sugar, \frac{1}{2}0z. tobacco, \frac{1}{2}0z. soap.

4. The Ration for wives of Soldiers of the

Mounted Police :- 8oz. bread, 8oz. meat.

5. The Rations for children of soldiers of Mounted Police above seven years :— $5\frac{1}{3}$ oz. of bread, $5\frac{1}{3}$ oz. meat-under seven years, 40z. of bread and 40z. of

6. To Prisoners confined in Gaol :- 12oz. wheat bread, 12oz. maize meal, 4oz. fresh meat, 8oz. vegetables, ½oz. salt, ½oz. soap-(Ration No. 2 is issued to Gaol attendants, and to Witnesses and others awaiting bail; and if confined in solitary cells, Ration No. 8.)
