PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

HEREAS by a certain Act of the Governor and Legislative Council of New South Wales, passed in the third year of the reign of His late Majesty King William the Fourth, intituled, " An Act to consolidate and amend the " laws for the transportation and punishment of " offenders in New South Wales, and for defining " the respective powers and authorities of General " Quarter Sessions and of Petty Sessions, and for " determining the places at which the same shall be "holden, and for better regulating the summary
"jurisdiction of Justices of the Peace, and for
"repealing certain laws and ordinances relating
"thereto," it was amongst other things enacted, that the Courts of General Quarter Sessions for the said Colony, should be holden at such times respectively as the Governor for the time being should by any Proclamation duly issued for such purpose appoint: Now I, the said Governor, in pursuance of the power and authority so vested in me by the said recited Act, do hereby direct and appoint that the said Courts of General Quarter Sessions shall be holden, during the year of our Lord one thousand eight hundred and fifty, at the several times and places

AT MAITLAND .- On Monday, the 7th of January; the 1st of April; the 1st of July; and the 7th of October.

AT BATHURST :-- On Thursday, the 24th of January; the 18th of April; the 18th of July; and

the 24th of October.

AT SYDNEY :- On Monday, the 4th of February; the 6th of May, the 5th of August; and the 11th of November; and also by adjournments of such Sessions respectively—on Monday, the 11th of March; the 10th of June; the 9th of September; and the 9th of December.

AT PARRAMATTA: On Tuesday, the 12th of February; the 14th of May; the 13th of August;

and the 19th of November.

AT GOULBURN :-- On Thursday, the 21st of March; the 20th of June; the 19th of September; and the 19th of December.

PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

HEREAS by an Act of the GOVERNOR and Legislative Council of New South Wales, passed in the sixth year of the reign of Her present Majesty Queen Victoria, intituled, " An " Act to consolidate and amend the laws relating " to Courts of Requests, and to extend the jurisdic-" tion of such Courts in the County of Cumber-" land;" it was, amongst other things enacted, That from and after the first day of January, 1843, Courts of Requests should be holden in and for such counties and districts, or other portions of this Colony and its Dependencies, and at such places respectively, as the Governor should by Proclamation for that purpose from time to time appoint: And whereas by another Act passed in the eleventh year of the reign of Her said Majesty, intituled, " Act to amend the laws relating to Courts of Re-" quests in the City of Sydney, and County of Cumberland, and in the Town of Melbourne, "and County of Bourke respectively," it was enacted, that all Courts of Requests established or to be established within the City of Sydney and County of Cumberland, and in the Town of Melbourne, and County of Bourke, should respectively have power and authority to hear and determine in a summary way all actions whatsoever, for the recovery of any hereinafter respectively mentioned, that is to say :- | debt, demand, or damage, whether liquidated or unliquidated, to an amount not exceeding thirty pounds : Now, I, the said Governor, in pursuance of the power and authority so vested in me by the said first recited Act, do hereby direct and appoint that Courts of Requests in and for the City of Sydney, and County of Cumberland, shall be holden during the year 1850, at the times and places, and for the districts hereinafter respectively mentioned, that is to say :- The "Ordinary Sittings" of the Court of Requests for the trial of all cases, not exceeding Ten pounds, for the City of Sydney, and for the Police district thereof, as described in a certain notice from the Colonial Secretary's Office, bearing date the 15th day of September, 1841, and published in the New South Wales Government Gazette, shall commence and be holden on the following days, and shall respectively be continued. by adjournment from day to day, as may be found necessary, viz.:—
Monday, 7th January; Monday, 4th February;
Monday, 4th March; Monday, 1st April; Monday,
6th May; Monday, 3rd June; Monday, 1st July;
Monday, 5th August Monday, 2nd Santamber Monday, 5th August; Monday, 2nd September; Monday, 7th October; Monday, 4th November, and Monday, 2nd December, respectively. The New Sittings of the said Court for the trial of all causes from ten to thirty pounds, for the said City and Police District thereof as aforesaid, shall commence and be holden on the following days, and shall repectively be continued by adjournment from day to day, as may be found necessary, viz. :- Monday 14th January; Monday, 11th February; Monday, 11th March; Monday, 8th April; Monday, 13th May; Monday, 10th June; Monday, 8th July; Monday, 12th August; Monday, 9th September; Monday, 14th October; Monday, 11th November; and Monday. 9th December respectively and Monday, 9th December respectively.

The "Ordinary Sittings" of the said Courts for the other districts in the County of Cumberland, will commence on the undermentioned dates; and the "New Sittings" of the Courts for these districts respectively, shall commence after the termination of the "Ordinary Sittings," and shall respectively be continued by adjournment from day to day, as may be found necessary, that is to say :

At the Town of Campbelltown and for such portions of the police district thereof, as are situated in the County of Cumberland, and for such portions of the police districts of Camden and Narellan, as are situated in the County of Cumberland, as described in the aforesaid notice-on Monday, 21st January; Monday, 15th April; Monday, 15th July; and Monday, 21st October respectively.

At the Town of Liverpool and for the police district thereof, as described in the aforesaid noticeon Wednesday, 23rd January; Wednesday, 17th April; Wednesday, 17th July; and Wednesday, 23rd October respectively.

At the Town of Parramatta, and for the police district thereof, as described in the aforesaid noticeon Thursday, the 24th January; Thursday, 18th April; Thursday, 18th July; and Thursday, 24th October respectively.

At the Town of Windsor and for such portions of the police district thereof, as are situated in the County of Cumberland, as described in the aforesaid notice—on Monday, 28th January; Monday, 22nd April; Monday, 22nd July; and Monday, 28th Outbox representations. October respectively.

At the Town of Penrith and for such portions of the police district thereof, as are situated in the County of Cumberland, as described in the aforesaid notice-on Thursday, the 31st January; Thursday, 25th April; Thursday, 25th July; and Thursday, 31st October respectively.

COURT OF REQUESTS.

THE following additional Rule of practice and proceedings for the conduct of business in the Courts of Requests of the Colony, has been settled by me, with the assistance of the Commissioner of the Court of Requests, for the City of Sydney and County of Cumberland, pursuant to the Act of Council 6th Victoria, No. 15, Section 40.

In witness whereof I have hereunto set my hand, at Government House, Parramatta, this first day of November, in in the year of Our Lord one thousand eight hundred and forty-nine.

That the 55th Rule of practice and proceeding he hereby repealed, and the following substituted in lieu thereof:—Rule 61. There shall be Twelve Sessions in each year for the City and District of Sydney, which shall be called the "New Sittings" of the said Court, at which all cases from ten pounds to thirty pounds shall be tried; and the "New Sittings" for the City and District of Sydney, and for the several Districts in the County of Cumberland, shall be at such places and times as His Excellency the Governor shall by Proclamation from time to time appoint.

A LL persons having claims on the Colonial Treasury are requested to furnish their accounts through the proper channel, before the end of the year or as soon thereafter as practicable. The several Collectors and Officers in the receipt

The several Collectors and Officers in the receipt of public monies will pay over to the Colonial Treasurer, on or before the 31st of December, the amount of all collections remaining in their hands respectively up to that date, so that the entire Revenue collected by each may be credited in the accounts of the year within which it was received.

The Heads of Departments and other Officers who have received advances to enable them to defray expenses incurred under their superintendence, are requested to furnish to the Audit Office, as far as practicable, and with all convenient despatch, the accounts of the expenditure thereof, and on or before the last day of December to pay into the Colonial Treasury the unexpended balance of such advances, that the adjustment of the same may appear in the accounts to the 31st proximo.

They will also as soon as practicable, after the close of the year, bring forward all accounts of expenses incurred within the same which do not admit of being previously settled, so that if possible, all the expenses incurred in the present year may be finally adjusted and liquidated within one month after its termination.

The Colonial Treasurer is requested to use his endeavours to give effect to these directions, and to report through the proper channel, for the information of His Excellency the Governor, any instance of neglect in complying therewith on the part of the Government officers concerned.
