PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ Rov, Knight Companion of the Royal Hanoverian Guelphic Order, Captaiu-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c.

Legislative Council of New South Wales, passed in the fourth year of the reign of Her present Majesty Queen Victoria, intituled, "An Act to "provide for the more effectual administration "of Justice in New South Wales and its Dependencies," it was amongst other things enacted, that it should be lawful for the Governor of the said Colony, by Proclamation under his hand, issued and published from time to time, by and with the advice of the Executive Council of the same, to direct Circuit Courts to be holden in or at such Towns or places within the Colony, as he should, by the advice aforesaid, think fit to appoint; and to fix from time to time, and vary or alter, as occasion may require, the times and places for holding the said Courts respectively, and whereas it is expedient that a Circuit Court should be held at the Town of Geelong, in the District of Port Phillip: Now, therefore, I, the Governor aforesaid, by and with the advice of the said Executive Council, do hereby direct and appoint that a Circuit Court for the trial of Criminal as well as Civil Issues shall be holden at the Town of Geelong aforesaid, and that during

the year now next ensuing, and every following year until otherwise ordered, such Court shall be holden in the months of February, June, and October, commencing on the twenteeth day of each of such months unless the same shall happen to fall on a Sunday, in which the the said Courts shall commence on the Monday next following.

PROCLAMATION.

By His Excellency Sir Charles Augustus Fitz Roy, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

HEREAS by an Act of the Governor of New South Wales, with the advice of the Legislative Council, passed in the second year of His late Majesty's reign, intituled, "An Act for re"pealing so much of an Act, intituled, "An Act
"to continue until further provision shall be
"made, certain Duties, Tolls, Rates, Fees, or

" other sums of money imposed by the Governor | (No 97.) " of New South Wales, and for other purposes,
" as relates to the levying of Tolls in New South " Wales, and for raising a fund towards making, " 'repairing, and upholding Public Roads, Bridges, " and Ferries, and for regulating the collection of Tolls thereon," it is amongst other things enacted, that it shall and may be lawful for the Governor of the said Colony, for the time being, by any Proclamation, or Proclamations under his hand, from time to time to appoint places at which Tolls shall be collected, and to cause the same to be collected upon any line of road which has been, or shall be wholly or partly made, and which is repaired at the public expense; and to cause Toll to be collected at any Bridge built, purchased, or repaired at the public expense, and at any Ferry constructed or upheld at the same; and to cause such Gates, Bars, Chains, Rails, and Fences, to be built and set up, as shall be deemed necessary for preventing passengers, beasts, and carriages from passing, unless there shall be then paid such Toll as shall be due or demandable under the authority of the said recited Act; and whereas it has become necessary to appoint a place at the crossing of the Snowy River, at Janmingee, about four miles below the junction of the Bobundara Creek with the Snowy River, where the road from Cooma to Gipps' Land meets that River, for the purposes of the said recited Act; now, I, the Governor aforesaid, in pursuance of the authority vested in me by the said recited Law or Ordinance, do, by this my Proclamation, hereby appoint the said crossing of the Snowy River, at Janmimgee, to be a place at which a Ferry shall be established, and at which Tolls shall be collected, to the amount and under the regulations, restrictions, and provisions of the said recited Law or Ordinance, of which Ferry all persons concerned are hereby required to take due notice.

IS Excellency the GOVERNOR is pleased to direct the publication of the following Despatch from the Right Honorable the Secretary of State, having reference to the Act of the Colonial Legislature, 11 Victoria, No. 54, intituled, "An Act to remove doubts concerning the validity " of certain Grants of Land in the City of Sydney, together with the Act of Parliament alluded to in His Lordship's Despatch, which for the reason therein assigned, has been passed in substitution of the Local Act.

Amongst the twenty-three Acts transmitted to me for Her Majesty's allowance, with your Despatch No. 179, of 12th August last, is one intituled " An Act to remove doubts concern-"the validity of certain Grants of Land in the "City of Sydney," (11 Vict., No. 54.)

2. On looking into the Act it appeared to me that a serious doubt might arise as to its validity, and one which Her Majesty's confirmation could not remove. The grants of these allotments by Sir Ralph Darling were grants of Crown Land, and, according to your Despatch, it is questioned whether such of these grants as do not recite certain existing leases are good.

But if there is any foundation for this objection the allotments would revert to the Crown at the expiration of the leases. Consequently it appears at least extremely doubtful whether any enactment of the Local Legislature to confirm these titles would not be a violation of the provision of the Constitutional Act, -that no Law of the Legisgislature of New South Wales shall interfere in any manner with the sale or other appropriation of the land belonging to the Crown.

3. Considering, therefore, that this doubt existed, and that, as I have before stated, the simple confirmation of Her Majesty would not remove it, and consequently that these titles would remain insecure, it appeared to me that the best course to take was to confirm the grants in question by Act of Parliament. The Bill introduced for this purpose has now been passed into a Law, (12 Vict., No. 24) and I transmit it with this Despatch.

4. You will observe that it merely repeats the language of the Local Act, confirming the grants made between the date of Sir Ralph Darling's Proclamation and the 17th June, 1848, being the date of the Local Act.

5. The latter Act is, therefore, as I apprehend, now of no objection, and probably the most convenient course will be to disallow it, which I shall accordingly advise Her Majesty to do, unless I receive any suggestions from you to the contrary before the period for disallowance expires.

CAP. XXII.

An Act to remove doubts concerning the validity of certain Grants of Land in the Colony of New South Wales. [24th May, 1849.]

HEREAS by a Proclamation bearing date the eighth day of June, One thousand eight hundred and twenty-nine, made and published by His Excellency Lieutenant-General

Ralph Darling, then Captain-General and Governor-in-Chief of the Colony of New South Wales, reciting that much inconvenience had been occasioned by the want of sufficient titles for allotments of land in the Town of Sydney, and that such titles had not been issued by the Government, except in a few instances, since the thirtieth day of June, one thousand eight hundred and twentythree; in order to remedy the said inconvenience, and to give the necessary security to private property, it was thereby ordained and proclaimed. that, on application being made, a grant in fee simple should be issued, under the conditions in the said Proclamation specified, to every person, or his lawful representative, who on or before the said thirtieth day of June, one thousand eight hundred and twenty-three was bona fide in possession, by lease from the Government, whether such lease was then expired or not, or by mere right of occupancy, of any allotment of land in the Town of Sydney which had not theretofore been alienated by the Crown, and not specified in a certain Order of the Government, bearing even date with the said Proclamation number thirty, or otherwise notified theretofore as being required for public purposes, reserving, however, and keeping harmless, all rights of other private individuals which might be lawfully established at any time thereafter: And whereas since the issuing of the said Proclamation grants in fee simple of allot-ments of land in Sydney which had been before leased by the Government have from time to time been made and issued to divers persons claiming the said land, under the terms and conditions set forth in the said Proclamation: And whereas at the time of the making and issuing of divers of the said grants, leases which had been issued by the Government of lands comprised in such grants were unexpired, and the said leases were not surrendered nor cancelled, nor recited nor mentioned in the said grants: And whereas doubts have been entertained whether such grants are valid; and it is expedient that such doubts as aforesaid should be removed by authority of Parliament: Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Grants of lands authority of the same, That all in Sydney con- grants made and issued after the date and publication of the said Proclamation, and before the seventeenth day of June, one thousand eight hundred and forty-eight, by or in the name of the Governor or person administering the Government of the said Colony for the time being, or by or in the name of either of Her Majesty's predecessors King George the Fourth and King William the Fourth, or by or in the name of Her Majesty, of any lands situated in Sydney, shall (notwithstanding that the leases which had been issued of the same lands were at the time of the making and issuing of such grants unexpired, and that such leases were not recited in the said grants,) be and be deemed and taken to have been from the respective dates thereof as valid and effectual in the law to grant and convey such lands to all intents and purposes as if such leases had been recited and set forth in such

grants.

Saving as to II. Provided always and be it landserrone-enacted, That nothing in this Act outly grant-contained shall be deemed or taken to ed. affect or prejudice the rights of any person or persons to any lands or hereditaments which have been erroneously or wrongfully granted to any grantee thereof, contrary to the true intent and meaning of the said Proclamation, anything in any such grant or in this Act to the contrary notwithstanding.

HE descriptions of the following Grants of Land, which have been appropriated to the Wesleyan Church, as hereunder more particularly mentioned, are published for general information, in order that the parties concerned may have an opportunity of correcting any errors or omissions that may have been made inadvertently.

At the expiration of one month from the present date, if no caveat be lodged or other cause of uncertainty appear, a Deed of Grant of each will be prepared in favor of the approved Trustees, viz.:—

IPSWICH, Ir. 5½p., One rood five and a half perches, County of Stanley, parish of Ipswich, allotments Nos. 34 and 35 of section 8; commencing in Limestone-street at the south-east corner of allotment No. 33, and bounded on the south-east by that street 97 links north-easterly to Ellenborough-street; on the east by Ellenborough-street 2 chains 22 links northerly; on the north-west by a line parallel to Limestone-street 1 chain and 94 links south-westerly; and on the south-west by a line at right angles to the last line south-easterly to the point of commencement.
