## TWENTY POUNDS REWARD, OR A CONDITIONAL PARDON.

HEREAS it has been represented to the Government, that on the night of the 17th ultimo, a barn, containing about two hundred bushels of wheat, and five stacks of hay, containing from eighty to one hundred tons, the property of Mr. Thomas Barnaby, of Round Swamp, Mudgee Road, were maliciously set on fire and were totally destroyed, His Excellency the Governor directs it to be notified, that a Reward of Twenty pounds will be paid to any free person or persons, who may, within six months from the present date, give such information as shall lead to the apprehension and conviction of the party or parties guilty of the above outrage; and if the person giving such information be a prisoner of the Crown, application will be made to Her Majesty for the allowance to such prisoner of the Crown of a Conditional Pardon.

(4.) (5.) The principal will also be redeemable at par, at the option of the holder for the time being, after the expiration of five years from the date of the Debenture, on his giving three months' notice to that effect to the Colonial Agent General, in London; or the Colonial Treasurer, in Sydney, as the case may be.

(6.) At the expiration of the three months' notice, given either by the Government or the holder, the interest on the Debenture to which such notice shall apply, will cease and determine.

(7.) The principal and interest of each Debenture will be payable at the option of the holder for the time being, either in Sydney or London; any change which it may be desired to make in this respect being previously registered at the Colonial Treasury, in Sydney, and in the Office of the Colonial Agent General, in London, and endorsed upon the Debenture, which must be presented accordingly at both these Offices for that purpose.
