FORFEITED RUN.

(FORT PHILLIP.)

IT is hereby notified, that application having been made for the purchase of the Lease of the Run of Crown Lands, hereunder described, which, after having been occupied, has become vacant by forfeiture, Tenders in the prescribed printed form will be received at the Office of His Honor the Superintendent, Port Phillip, until noon of Monday, the 3rd day of December next, from the applicant, and from any other persons desirous to enter into competition with him for the purchase of the Lease of the said Run.

2. Every such Tender must state the term of years (not exceeding fourteen,) for which it is proposed to take the Run, and whether, in addition to the minimum rent required by Her Majesty's Order in Council, it is intended to offer any, and if any, what amount of yearly premium per thousand sheep, or equivalent number of cattle, for the Lease.

3. As the grazing capabilities of the Run have not yet been determined, it will be necessary that each Tender contain an estimate of the number of sheep or cattle that the Run will carry.

4. Until the Run has been regularly surveyed, and its grazing capabilities determined, the future Lessee will be required to pay rent according to his own estimate, as given in his Tenders and in the event of the rent so paid proving to have been less than that determined by valuation, he will be required

to make up the difference, previously to the execution of the Lease.

5. It is also to be distinctly understood, that the Government reserves to itsfle the right of excluding from the Lease of the Run any land which it may be deemed proper to reserve for any of the purposes referred to in the 9th section of chapter 2, of Her Majesty's Order in Council, dated 9th of March, 1847.

WHARFAGE AND TONNAGE RATES AT THE QUEEN'S WHARF.

AT TWELVE o'clock on Saturday, 8th December next, the Sub-Treasurer will put up to auction, at the Sub-Treasury, Melbourne, the Lease for one year, commencing the 1st January, 1850. of the Wharfage and Tonnage Rates, payable at the Queen's Wharf, Melbou ne, under the provisions of the Act of the Governor and Council 10th Victoria No. 11.

The Lessee will be entitled to the feer use of the Wharf, to collect dues, for depositing goods thereon, either for shipment or discharge, as well as for all other purposes appertaining to a Wharf.

The use of the Customs' shed near the Wharf will be allowed to the lessee of the Rates when not fully occupied by

the Customs Department.

The use of the Wharf will be reserved as a public thoroughfare, or of the landing or embarking passengers and other person at the same, free of any charge whatsoever; and the steps will have to be kept free from all goods or other obstructions.

The persons who shall be declared to be the highest bidder, if the bidding be accepted, must immediately enter into a Bond with two sufficient sureties, each of whom is to be present at the knocking down of the rates, and Warrant of Attorney, securing regular payment of the rent by equal monthly instalments, before the expiration of seven days after the termination of each month, containing an engagement binding them to a due observance of the conditions.

It is to be understood that this notice does not include the Wharfage and Tonnage rates at Geelong, but has refence to the Queen's Wharf at Melbourne solely.
