CAP. XCVI.

An Act to provide for the Prosecution and Trial, in Her Majesty's Colo-nies, of offences committed within the Jurisdiction of the Admiralty. [1st August, 1819.]

(10 & 11 W. 3, c. 7.)-(46 G. 3, c. 54.) (All persons charged in any Colony with offences committed on the Sea, may be dealt with in the same manner as if the offences had been committed on waters within the local Jurisdict on of the Courts of the Colony.)

WHEREAS by an Act passed in the eleventh year of the Reign of King. William the Third, intitituled, "An Act for the more effectual Suppression of Piracy," it is enacted, That all Piracies, Felonies, and Robberies committed on the sea or in any haven giver creek or Felonies, and Robberies committed on the sea, or in any haven, river, creek, or place where the Admiral or admirals have power, authority, or jurisdiction, may be examined, inquired of, tried, heard, and determined, and adjudged, in any place at sea, or upon the land in any of His Majesty's Islands, Plantations, Colonies, Dominions, Ports, or Factories, to be appointed for that purpose by the King's Commisson, in the manner therein directed, and according to the Civil Law and the method and rules of the Admiralty; And whereas, by an Act passed in and the method and rules of the Admiralty; And whereas, by an Act passed in the forly-sixth year of the Reign of King George the Third, initialed, "An Act for the speedy Trial of offences committed in distant parts upon the Sea," it is enacted. That all Treasons, Piracies, Pelonies, Robberies, Murders, Conspiracies, and other offences, of what nature or kind soever, committed upon the sea, or in any haven, river, creek, or place where the Admiral or Admirals have power, authority, or jurisdiction, may be inquired of, tried, heard, determined, and adjudged, according to the common course of the tried, heard, determined, and adjudged, according to the common course of the laws of this realm used for offences committed upon the land within this realm, and not otherwise, in any of His Majesty's Islands, Plantations, Colonies, Dominions, Ports, or Factories under and by virtue of the King's Commission or Commissions under the Great Seal of Great Britain, to be directed to Commissioners in the manner and with the powers and authorities therein provided: missioners in the manner and with the powers and authorities therein provided: And whereas, it is expedient to make further and better provision for the apprehension, custody, and trial in Her Majesty's Islands, Plantations, Colonies, Dominions, Forts, and Factories, of persons charged with the commission of such effects on the sea or in any such haven. sons charged with the commission of such offences on the sea, or in any such haven, river, creek, or place as aforesaid: Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by authority of the same, that if any person within any Colony shall be charged with the commission of any Treason, Piracy, Felony, Robbery, Murder, Conspiracy,

or other offence, of what nature or kind soever, committed upon the sea, or in any haven, river, creek, or place where the Admiral or Admirals have power, authority, or jurisdiction, or if any person charged with commission of any such offerce when the second properties. charged with commission of any such of-fence upon the sea, or in any such haven, river, creek or place shall be brought for trial to any Colony, then, and in every such case, all Magistrates, Justices of the Peace, public Prosecutors, Juries, Judges, Courts, public Officers, and other persons in such Colony shall have and exercise the same jurisdiction and autho-rities for inquiry of, trying, hearing, derities for inquiry of, trying, hearing, de-termining, and adjudging such ofiences, and they are hereby respectively autho-rised, empowered, and required to institute and carry on all such proceedings for the bringing of such person such reaches bringing of such person so charged as aforesaid to trial, and for and auxiliary to and consequent upon the trial of any such person for any such offence where with he may be charged as aforesaid, as by the law of such Colony would and ought to have been had and exercised, or instituted and carried on by them respectively, if such offence had been committed, and such person had been charged with having committed the same, upon any waters situate within the limits of any such Colony, and within the limits of the local jurisdiction of the Courts of Criminal Justice of such Colony.

(Persons convicted of such effences shall suffer the like Punishments as on conviction of like offences in England.)

II. Provided always and be it enacted, That if any person shall be convicted before any such Court of any such offence, such person so convicted shall be subject and liable to and shall suffer all such and and liable to and shall suffer all such and the same pains, penalties, and forfeitures as by any law or laws now in force, persons convicted of the same respectively would be subject and liable to in case such offence had been committed, and were inquired of, tried, heard, determined, and adjudged in England, any law, statute, or usage to the contrary notwithstanding. standing.

(Provision for the Trial of Murder and Man-elaughter where the Death only happens in the Colony or upon the Sea.)

III. And be it enacted, That where any person shall die in any Colony of any stroke, poisoning, or hurt, such person having been feloniously stricken, poisoned, or hurt upon the sea, or in any haven, river, creek, or place where the Admiral or Admirals have power, authority, or jurisdiction, or at any place out of such Colony, every offence committed in respect of any such case, whether the same shall amount to the offence of murder or of manslaughter, or of being accessory before the fact to murder, or after the fact to murder or manslaughter, may be dealt with, inquired of, tried, determined, and punished in such Colony III. And be it enacted. That where termined, and punished in such Colony in the same manner in all respects as if such offence had been wholly committed

in that Colony; and that if any person in any Colony shall be charged with any such offence as aforesaid in respect of the death of any person who having been feloniously stricken, poisoned, or otherwise burt, shall have died of such stroke, poisoning, or hurt upon the sea, or in any haven, river, creek, or place where the Admiral or Admirals have power, authority, or jurisdiction, such offence shall be held for the purposes of this Act to have been wholly committed upon the

(Jurisdiction of the Supreme Court of New South Wales and Van Diemen's Land preserved.—9 G. 4, c, 83.)

IV. Provided also and be it enacted, That nothing in this Act contained shall in any way affect or abridge the jurisdiction of the Supreme Courts of New South-Wales and Van Diemen's Land, as esta-blished by an Act passed in the ninth blished by an Act passed in the finith year of the Reign of King George the Fourth, initialed, "An Act to provide for the Administration of Justice in New South Wales and Van Diemen's Land, and for the more effectual government thereof, and for other purposes relating thereto."

(Interpretation of Terms.)

V. And be it enacted, That for the purposes of this Act the word "Colony" shall mean any Island, Plantation, Colony, Dominion, Fort, or Factory of Her Majesty, except any Island within the United Kingdom, and the Islands of Man, Guernsey, Jersey, Alderney, and Sark, and the Islands adjacent thereto respectively, and except also all such parts and places as are under the Government of the East India Company; and the word "Governor" shall mean the Officer for the time being administering the Governthe time being administering the Govern-ment of any Colony.

(Act may be amended, &c.)

VI. And be it enacted, That this Act may be amended or repealed by any Act to be passed during this present Session of Parliament.

IS Excellency the Governor is pleased to direct the publication of the following Despatch from the Secretary of State, with its enclosures, pointing out the advantage to vessels returning to England from the Pacific, of touching at the Falkland Islands.

By His Excellency's Command, E. DEAS THOMSON.

Sir,-I have the honor to transmit to you, for your information, the enclosed copy of a letter from the Admiralty, accompanied by one from Captain Max-well, R.N. containing some favorable

remarks on the Falkland Islands, and pointing out the great saving of time which he considers that Her Majesty's ship 'Dido' effected on her passage from the Pacific to England by calling at those Islands instead of at Rio de - Janeiro.

Considering the large number of vessels which return from the Australian Colonies round Cape Horn, I have deemed it right to put you in posession of: this information, and I shall be glad if you will communicate it to the Harbor Master, and take any other means which may appear to you suitable for making it known among the Comfor making it known among the Commanders of Shipping, leaving them of course, however, to exercise their own judgment, and without offering any recommendation for which the Government could be held responsible.

Sir,—With reference to your letter of the 24th ultimo, transmitting a Despatch from the Governor of the Falkland Islands, I am commanded by my Lords Commissioners of the Admiralty to send you herewith a copy of a Report on the state of those Islands, from Captain (Maxwell, late of the 'Dido,' dated the 12th of May last, and I am to acquaint you, that my Lords are sorry that this copy was not sent at the time. My Lords request that the same may be laid before Earl Grey.

Malvern Wells, Worcester, 12th May, 1849. Sir,—Conceiving that any information tending to shorten the voyage of Her Majesty's ships from the distant stations in the Pacific Ocean, may prove worthy the notice of the Lords Commissioners of the Admiralty, I beg leave to call their attention to the advantage which would be derived in such cases, from touching at the Falkland Islands for water and refreshment in preference to the Ports in the Brazil, which are generally resorted to for that purpose.

From recent experience, and having in command of Her Majesty's ship 'Dido,' returned from New Zealand by that route, and made the quickest passage on record, I am in a condition to state to their Lordships, that the 'Dido's passage from Cape Horn was shortened 20 days at least, by going to the Falkland Islands instead of Rio de Janeiro, and which will be evident, on a reference to that ship's log and track compared with Sir,-Conceiving that any information

those of any other of Her Majesty's ships which may have called at that port, in making the same voyage at the same season.

The 'Dido' left Fort William (East Falkland) on the 5th December, and arrived at Spithead in 49 days—an average passage from Rio de Janeiro at that period of the year being not less than 50 days, and as the Falkland Islands are in the direct route from Cape Horn to both places, it is manifestly fair to assume that the whole of the time that would have been occupied in the passage would have been occupied in the passage between those Islands and Rio was saved, and which passage is estimated, on the average, at 3 weeks.

The saving of three weeks' wear and tear, wages, and victualling of a ship returning home to be paid off, is, I need scarcely observe, an object of considera-

Their Lordships having access to the journals of numerous voyages, and the best sources of information as to the prevailing winds in these seas, I need only state that a ship coming home direct from the Falkland Islands, is enabled, in proceeding to the northward, to shape a course of the rest the seather. course so as to cross the southern Tropic about the Meridian of 25 degrees west, thereby deriving the full advantage of the south-east trades so as to pass rapidly through them; whereas, in sailing from Rio de Janeiro, a vessel is 20 degrees to the westward on the sense sould be as the south of the sout the westward on the same parallel, and is frequently compelled to proceed 6 or 8 degrees to the south before making sufficient easting to weather the Brazil

With respect to refreshments for With respect to refreshments for shipping, the Falkland Islands furnish abundant supplies of cattle, which can be obtained at a cheap rate at the Port of Stanley, the seat of Government, or at Port Louis in Berkeley Sound, and ships can water with facility at either of those ports; vegetables are scarce, but the Governor was giving every encouragement and assistance to the Colonists to grow them in sufficient abundance for the supply of shipping, which I have no ragement and assistance to the Colonists to grow them in sufficient abundance for the supply of shipping, which I have no doubt they will speedily accomplish, and in the meantime I found wild celery an admirable substitute when boiled in the soup for the ship's company; spirits, salt meat, and other articles of sea victualling, can be supplied from the Government Stores at Stanley; and if that Port was resorted to, private establishments, with supplies of naval stores, would soon be formed. A patent slip is expected to be sent out from England, a site for which had been already fixed upon in December last. It appears, therefore, very desirable that the admirable position of the Falkland Islands and the facilities afforded to navigation by the British Settlement there, should be made known extensively, and rendered, available for the mercantile marine as available for the mercantile marine as

, well as for Her Majesty's ships navigating 'to and from the Pacific.

All passengers who shall not be prevented by sickness, or other sufficient case, to be determined by the surgeon.

case, to be determined by the surgeon, or in ships carrying no surgeon, by the master, shall rise not later than seven o'clock a.m. at which hour the fires shall

be lighted.

2. It shall be the duty of the cook, appointed under the twenty-sixth section of the said "Passenger's Act, one thousand eight, hundred, and forty-nine; to light, the fires and to take care that they be kept alight during the day, and also to take care that each passenger, or family of passengers, shall have the use of the fire-place, at the proper hours, in an order to be fixed by the master.

3 When the passengers are dressed their beds shall be rolled up.

4. The decks, including the space under the bottom of the berths, shall be swept before breakfast, and all dirt thrown overboard.

5 The breakfast hour shall be from eight to nine o'clock a.m. : provided that, before the commencement of breakfast, all the emigrants, except as hereinbefore excepted, be out of bed and dressed, and that the beds have been rolled up, and the deck on which the emigrants live

properly swept.

6. The deck shall further be swept of the deck shall further be swept after every meal, and, after breakfast is concluded, shall be also dry holystoned or scraped. This duty, as well as that of cleaning the ladders, hospitals, and round houses, shall be performed by a party taken in rotation from the adult males above fourteen in the proportion party taken in rotation from the adult males above fourteen, in the proportion of five to every one hundred emigrants and who shall be considered as:sweepers for the day. But the single women shall perform this duty in their own compartment, where a separate compartment is allotted to them, and the occupant of each herth-shall see that his own berth is well brushed out. well brushed out.

7. Dinner shall commence at one o'clock p.m. and supper at six p.m.

8. The fires shall be extinguished as seven p.m. unless otherwise directed by the master, or required for the use of the sick, and the emigrants shall be in their berths at ten o'clock p.m. except under the permission or authority of the surgeon; or if there be no surgeon, of the master.

9. Three safety lamps shall be lit at dusk, and kept burning till ten o'clock' p.m., after which hour two of the lamps may be extinguished, one being nevertheless kept burning at the main hatch-

way all night.
10. No naked light shall be allowed at

10. No naked light shall be allowed at any time or on any account.

11. The scuttles and stemports, if any, shall, weather permitting, be opened at seven o'clock a.m. and kept open till ten o'clock p.m.; and the hatches shall be

kept open whenever the weather permits.
 12. The coppers and cooking utensils

shall be cleaned every day.

13. The beds shall be well shaken and aired on deck at least twice a week.

14. The bottom boards of the berths, if not fixtures, shall be removed and dry-scrubbed, and taken on deck at least twiceja week.

15. A space of deck-room shall be apportioned for a hospital, not less, for vessels carrying one hundred passengers, than forty-eight superficial feet, with two or four bed-berths erected therein: nor less for vessels carrying two hundred or more passengers, than one hundred and twenty superficial feet, with six bedberths therein.

16. Two days in the week shall be appointed by the master as washing days; appointed by the master as washing days; but no washing or drying of clothes shall on any account be permitted between decks.

17. On Sunday mornings the passen-

gers shall be mustered at ten o'clock a.m. and will be expected to appear in clean and decent apparel. The Lord's day shall be observed as religiously as circumstances will admit.

18. No spirits or 'gunpowder shall be taken on board by any passenger; and if either of these articles be discovered in the possession of a passenger, it shall be taken into the custody of the master during the voyage, and not returned to the passenger until he is on the point of

disembarking,
19. No loose hay or straw shall be allowed below for any purpose.
20. No. smoking shall be allowed

between decks.

between decks.

21. All gambling, fighting, riotons or quarrelsome behaviour, swearing and violent language, shall be at once put a stop to. Swords and other offensive weapons shall, as soon as the passengers embark, be placed in the custody of the

master.
22. No sailors shall be allowed to remain on the passenger deck, among the

passengers, except on duty.

23. No passenger shall go to the ship's cookhouse without special permission from the master, nor remain in the forecastle among the sailors on any account.

24. In vessels not expressly required by the said "Passengers' Act, 1849," to have on board such ventilating apparatus as therein mentioned, such other provision shall be made for ventilation as shall be required by the emigration officer, at the port of embarkation, or in his absence by the officers of customs.

25. And to prevent all doubts in the

eonstruction of this Order in Council, it is hereby further ordered that the terms
"United Kingdom" and "Passenger
Ship" shall herein have the same significations as are assigned to them respectively in the said "Passenger's Act,

And the Right Honorable Earl Grey, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

AMENDED REGULATIONS RE-SPECTING THE LIGHTS TO BE EXHIBITED BY STEAM VES-

THE Board appointed under the provisions of the Act of the Governor and Council, 11th Victoria, No. 3, for the Regulation of Sea-going Steam and other Vessels, carrying Passengers, having had under consideration a copy of an order issued by the Lords Commissioners of the Admiralty, regarding lights to be exhibited by Steam Vessels, with a view to prevent collisions, have, with the approval of His Excellency the Governor, determined that, from and after the expiration of one month from the date of the publication of this notice, the following conditions shall be observed with respect to the mast-head and paddle-box lights, at present carried by all Steam-going Vessels, under the amended Regulations published in the Government Gazette, of the 29th of December, 1848, No. 147, that it to say:—

1. The mast-head lights to be visible at a distance of, at least, five miles in a clear dark night, and the lantern to be so constructed as to show an uniform and unbroken light over an arc of the horizon of twenty points of the com-pass, viz,—from right a-head to the two points abaft the beam on each side of the

ship.
2 — Tue coloured side lights to be visible at a distance of, at least, two miles in a clear dark night, and the lanterns to be so constructed as to shew an uniform and unbroken light over an arc of the horizon of ten points of the compass, viz. from right a-head to two points abait the beam on their respective sides.

3.—The side-lights to be, moreover, fitted with inboard screens, of at least three feet long, to prevent them from being seen across the bow. The screens to be placed in a fore and aft line with the inner edge of the side lights.

A.—The lanter, used by Steam Vessels when at anchor, elsewhere than at their respective wharves at Sydney, or the Out Ports, to be constructed so as to show a good light all around the horizon.
