ITIS Excellency the Governor directs it to be notified, that the Stockade erected at the Village of Pentridge, near Melbourne, including the whole of the Government Reserve of forty-three acres three roods and nineteen perches, on which the Stockade is situated, has been appointed a place at which male offenders under order or sentence of transportation, or any order or sentence passed in pursuance of an Act of the Governor and Legislative Council, passed in the eleventh year of Her Majesty's reign, intituled, "An Act to substitute other punishments for transportation beyond the seas," shall be detained and be liable to be kept to hard labor.
