PROCLAMATION.

By His Excellency SIR CHARLES AUGUSTUS FITZ ROY, Knight Companion of the Royal Hanoverian Guelphic Order, Captain-General and Governor-in-Chief of the Territory of New South Wales and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act of the GOVERNOR of New South Wales, with the advice of the Legislative Council, passed in the second year of His late Majesty's reign, intituled, "*An Act for repealing so much of an Act, intituled, 'An Act to continue until further provision shall be made, certain Duties, Tolls, Rates, Fees, or other sums of money imposed by the Governor of New South Wales, and for other purposes as relates to the levying of Tolls in New South Wales, and for raising a fund towards making, repairing, and upholding Public Roads, Bridges, and Ferries, and for regulating the collection of Tolls thereon;*" it is, amongst other things enacted, that it shall and may be lawful for the Governor of the said Colony, for the time being, by any Proclamation, or Proclamations under his hand, from time to time to appoint places at which Tolls shall be collected, and to cause the same to be collected upon any line of road which has been, or shall be wholly or partly made, and which is repaired at the public expense; and to cause Toll to be collected at any Bridge built, purchased, or repaired at the public expense, and at any Ferry constructed or upheld at the same; and to cause such Gates, Bars, Chains, Rails, and Fences, to be built and set up, as shall be deemed necessary for preventing passengers, beasts, and carriages from passing, unless there shall be then paid such Toll as shall be due or demandable under the authority of the said recited Act; and whereas it has become necessary to appoint a place at the crossing of the River Clarence, between the Towns of North and South Grafton, for the purposes of the said recited

Act; now, I, the Governor aforesaid, in pursuance of the authority vested in me, by the said recited Law or Ordinance, do, by this my Proclamation, hereby appoint the said crossing of the River Clarence, between the Towns of North and South Grafton, to be a place at which a Ferry shall be established, and at which Tolls shall be collected, to the amount and under the regulations, restrictions, and provisions of the said recited Law or Ordinance, of which Ferry all persons concerned, are hereby required to take due notice.

Given under my Hand and Seal at Government House, Sydney, this nineteenth day of February, in the Year of Our Lord one thousand eight hundred and fifty-one, and in the fourteenth year of Her Majesty's Reign.

FAMILIES OF CONVICTS.

**R**EFERRING to the notice from this Office, dated 27th August, 1847, in which it was intimated that Her Majesty's Government had determined to revive the practice of forwarding to this Colony at the public expense, the wives and families of married Convicts who had become free by Pardon or otherwise, or had obtained Tickets of Leave, and who were recommended as worthy of that indulgence; His Excellency the GOVERNOR directs it to be notified, that Her Majesty's Government have seen fit so far to modify the Regulation on this head, as to direct that in all future cases, only one half the expense of conveying the wife and family of a Convict to this Colony shall be defrayed by the public, leaving the other moiety to be met from private sources.

2. As, however, it will not be possible to pre-determine the actual expense of providing passages for each such family, the applicants will be required to deposit in the Colony, such a sum of money as will cover one moiety of the probable expense, calculated according to the following scale, and the balance (if any) after paying a moiety of the actual expense incurred, will be returned to the parties, namely:—
