SHIPPING.—CUSTOMS NOTICE.

MUCH inconvenience having been felt by this Department, in the cleating of Vessels, from the hurried manner in which the Ship's papers are frequently put in by different persons at the same moment, it will in future be required, that Notice of intention to clear outwards, shall be given by the Master, Owner, or Agent, the day before such clearance is required.
