No. XLIX.

An Act to provide that the Revenue and other Laws and Regulations made in and for the Colony of New South Wales, shall, after the erection of the District of Port Phillip into the separate Colony of Victoria, continue in force within the last mentioned Colony until altered by the Legislature thereof. [Assented to, 2nd May, 1851.]

Preamble.—13 & 14 Vic. cap. 59.—Laws now in force for the collection of Customs in the Colony of New South Wales, including Port Phillip, to remain in force in the Colony of Victoria, until altered by Legislature of the last mentioned Colony.

WHEREAS by an Act of the Imperial Parliament, passed in the Session of the thirteenth and fourteenth years of the reign of her present Majesty Queen Victoria, entitled, "An Act for the better government of Her Majesty's Australian Colonies," it is amongst other things enacted, that after such provisions for establishing Electoral Districts as therein mentioned shall have been made by the Governor and Legislative Council of New South Wales, and upon the issuing of the writs for the first election in pursuance thereof, the Territories comprised within the District of Port Phillip shall be separated from the Colony of New South Wales, and that thereupon the powers of the Governor of New South Wales, over and in respect of the Colony of Victoria, shall cease: And whereas it is expected that such writs will shortly be issued, whereupon the Territories comprised within the said District of Port Phillip will cease to form part of the Colony of New South Wales: And whereas certain Acts of the Governor and Council of the Colony of New South Wales have provided for the levying of certain "duties upon spirits, wines, and other goods and merchandize imported into the said Colony of New South Wales and its dependencies:" And whereas also a certain other Act of the said Governor and Council has provided for the "General Regulation of the Customs in New South Wales:" And whereas also divers other Acts of the said Governor and Council, and various Government and other Public Regulations, made in pursuance of some of such

Acts, have made other provisions and provisions purporting to apply to the said Colony of New South Wales only: And doubts may arise whether after such separation as aforesaid, the said several duties upon spirits, wines, and other goods and merchandize, shall be legally leviable within the said Colony of Victoria, and also whether the said several Acts, and the said Government and other Regulations, will apply to and be in force in the said Colony of Victoria after such separation as aforesaid: And whereas it is desired to remove such doubts, and to provide that the said Laws and Rules and Regulations thereon, which now apply to the said Colony of New South Wales, shall, until altered by the Legislature of Victoria, continue to be in force in effect within the Territories comprised within the said District after their separation as aforesaid, in the same manner as if such separation had not taken place: Be it therefore enacted, That all and every the duties and duties now chargeable and payable within the Colony of New South Wales, upon all spirits, wines, and other goods and merchandize imported into the same, shall be charged and paid within the District of Port Phillip, after its erection into the separate Colony of Victoria, upon all spirits, wines, and other goods and merchandize, imported into the last mentioned Colony, in the same manner, in every particular, as if such separation had not taken place: and that all and every the Laws and Regulations now in force for the collection and regulation of the Customs in New South Wales, shall in like manner after such separation continue to be in force, and shall be applied to the said Colony of Victoria, as if such separation had not taken place, until such Duties, Laws, and Regulations, shall severally and respectively have been altered by the Governor and Legislative Council of Victoria.

All Laws and Government and other Public Regulations, now in force in the District of Port Phillip, to remain in force in the Colony of Victoria after separation, until altered as aforesaid.

II. And be it enacted, That all and every other the Laws and Government or other Public Regulations which have at any time been passed or made for the Colony of New South Wales, or for the District of Port Phillip, and now in force within the said District, shall after such separa-

tion as aforesaid, and until other provision shall have been made in respect of the same matters respectively, by the Governor and Legislative Council of Victoria, or other competent authority, severally and respectively continue to be in force within and shall be applied to the Territories comprised within the Colony of Victoria, and to all persons, matters, and things therein, in the same manner to all intents and purposes as if such separation had not taken place.

Duties to be paid on all imported goods in each Colony after separation.

And be it declared and enacted, That after the separation of the Colony of New South Wales and Victoria, all goods, merchandize, and articles now subject to duty on importation into the Colony of New South Wales, shall be liable to, and shall pay, duty in each of the said Colonies respectively, irrespective of the place at which they were first landed: Provided that if such goods, merchandize, or articles have paid the import duty in the one Colony, the usual drawback shall be allowed on its exportation to the other.

An Act to preserve the jurisdiction and authority
of Public Officers and Magistrates within the
Colony of Victoria until new Commissions
shall have issued. [Assented to 2nd May,
1851.]

*Preamble.—13 & 14 Vict., c. 59.—Jurisdiction
of Public Functionaries at Port Phillip to con-
tinue until new Commissions and appointments
shall have been issued and made under the
Government of the Colony of Victoria.*

WHEREAS by an Act of the Imperial Par-
liament, passed in the Session of the thir-
teenth and fourteenth years of the Reign of Her
present Majesty Queen Victoria, intitled, "An
Act for the better Government of Her Majesty's
Australian Colonies," it is amongst other things
enacted, that after such provisions for establish-
ing Electoral Districts as therein mentioned shall
have been made by the Governor and Legislative
Council of New South Wales, and upon the is-
suing of the Writs for the first Election in pur-
suance thereof, the Territories comprised within
the District of Port Phillip shall be separated
from the Colony of New South Wales, and that
thereupon the powers of the Governor of New
South Wales over and in respect of the Colony
of Victoria shall cease: And whereas by the
said recited Act it is provided that until a Court
of Judicature, to be styled "The Supreme Court
of the Colony of Victoria," shall be established by

Her Majesty within the said Colony of Victoria,
all the authorities, powers and jurisdictions of
the Supreme Court of New South Wales, and
of the Judges thereof, within and in respect of
the said Colony of Victoria shall remain as if the
said recited Act had not been passed, or until
the same shall be varied by an Act of the Go-
vernor and Council of the said Colony of Victoria.
And whereas no such or the like provision is
made by the said recited Act of Parliament in
respect of any other powers, authorities,
and jurisdictions, within the said Colony of
Victoria: And whereas doubts may arise whether
the authorities, powers, and jurisdictions, duties
and obligations, of Justices of the Peace and of all
Civil Officers within the said District of Port
Phillip holding Commissions and Appointments
under the Government of New South Wales,
will not, by reason of such separation, be there-
upon suspended until revived by new commis-
sions and Appointments under the future Go-
vernment of the said Colony of Victoria: And
whereas it is expedient to prevent such doubts,
and to make provision for the preservation of all
such jurisdictions, powers, authorities, duties,
and obligations; Be it therefore enacted, by His
Excellency the Governor of New South Wales,
with the advice and consent of the Legislative
Council thereof, That all Justices of the
Peace for the Territory of New South Wales,
who at the time when this Act shall receive the
Royal Assent, shall be commonly resident within
the District of Port Phillip; and all persons who
at the said time shall hold Commissions as
Justices of the Peace for the City of Melbourne
and for the Town of Geelong respectively, and
all and every Public Officer or Servant who at
the said time shall hold any office or employ-
ment within the said District of Port Phillip,
shall and may lawfully continue to act in their
several capacities, and to discharge their respec-
tive duties, and shall and may hold and exercise,
in the same manner and subject to the like obli-
gations as if the said recited Act had not been
passed, their several authorities, jurisdictions,
and powers within the Territorial limits now com-
prised within the said District of Port Phillip, or
within the said City of Melbourne and Town of
Geelong respectively, or at or within the places to
which their several duties relate or appertain, as
the case may require, until new commissions and
appointments shall have been issued under the
Government of the Colony of Victoria, in the
place of the previous commissions and appoint-
ments of such Justices, Officers, and Public
Servants, or whereby or by the effect whereof
such previous commissions and appointments shall
have been revoked, or until and unless any such
Justice, Officer, or Public Servant shall have
been removed from his office or place by the
Governor or Officer administering the Govern-
ment for the time being within the said Terri-
torial limits of the District of Port Phillip, any-
thing in any law contained to the contrary
notwithstanding.

HIS Honor the Superintendent desires to draw the attention of the several Benches of Magistrates, Assessors, and other persons, who have any duty imposed upon them by the Electoral Act recently passed, to the proceedings necessary to be taken for preparing and revising the Lists of Electors for the several Electoral Districts of the Colony.

2. It may perhaps be proper to remind the different Benches, that Collectors for the preparation of the Electoral Lists are to be appointed not later than the 1st of June next, and that the lists are to be completed between the 1st and twentieth day of June, in all Electoral Districts, except Corporate Towns, wherein they are to be prepared by the 25th of June.

HIS Excellency the Governor, with the advice of the Executive Council, having deemed it expedient to open and make a Parish Road, to be maintained at the expense of the Parish through which it is to pass, commencing at a point on the western boundary line of suburban allotment No. 1, section No. 20, of the parish of Barrarbool, 12 chains and 88 links north from the north-east angle of section No. 11 of the said parish of Barrarbool, (which point is the centre of the road,) and passing through section No. 25, purchased by Charles Hutton, and through sections Nos. 11 and 12, purchased by William Robertson, by the following bearings:—north 79 degrees, west 20 chains and 30 links; south 41 degrees, west 25 chains and 20 links; south 59 degrees, west 11 chains and 5 links; south 71 degrees 40 minutes, west 7 chains and 40 links; south 85 degrees, west 1 mile 27 chains and 56 links to a point 19 chains and 60 links south from the north-west angle of said section No. 12; thence through sections Nos. 13 and 14 purchased by Charles M'Lachlan, by the following bearings:—south 45 degrees, west 12 chains and 60 links; south 41 degrees, west 10 chains and 50 links; south 83 degrees, west 11 chains and 50 links; south 89 degrees, west 25 chains and 90 links north 64 degrees 40 minutes, west 26 chains and 80 links; south 87 degrees, west 7 chains and 10 links; south 63 degrees, west 21 chains and 50 links; north 64 degrees, west 6 chains and 50 links; north 23 degrees, west 2 chains and 30 links; north 70 degrees, west 15 chains and 30 links; south 57 degrees, west 27 chains and 80 links; north 78 degrees, west 12 chains and 75 links to a point 40 chains and 20 links north from the south-west angle of said section No. 14; thence through sections Nos. 15 and 16, purchased by Charles M'Lachlan, by the following bearings, viz.:—north 81 degrees, west 14 chains; south 83 degrees 20 minutes, west 81 chains and 50 links; south 64 degrees, west 71 chains and 50 links to a point 50 links north from the south-east angle of section No. 18, and at that distance parallel with the boundary line of sections Nos. 17 and 18, west 1 mile to the parish boundary.

The bearings are magnetic, and described from the centre of the Road, which is 1 chain wide throughout.
