PROCLAMATION.

By His Excellency Charles Joseph La Trobe, Esquire, Liegtenani-Governor of the Colony of Victoria and its Dependencies, &c., &c.

WHEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the Sixth Year of the Reign of Her present Majesty. Queen Victoria, intituled "An "Act to consolidate and amend the Laws relatives." "ing to Courts of Requests, and to extend the "Jurisdiction of such Courts in the County of "Cumberland" It is amongst other things enacted, That from and after the first day of January, one thousand eight hundred and fortythree. Courts of Requests shall be holden in and for such counties and districts, or other portions of the Colony of New South Wales and its dependencies, and at such places respectively as the Governor should by proclamation for that purpose from time to time appoint; AND WHERIAS by another Act passed in the eleventh year of the reign of Her said Majesty, intituled "An the reign of Her said Majesty, intituled "An "Act to amend the laws relating to Courts of Requests in the City of Sydney and County of "Cumberland, and in the Town of Melbourne" and County of Bourke respectively" It is enacted, that all Courts of Requests established, or to be established within the City of Sydney and County of Cumberland, and in the Town (now City) of Melbourne, and County of Bourke, shall respectively have power and authority to shall respectively have power and authority to hear and determine in a summary way all actions whatsoever, for the recovery of any debt, demand, or damage, whether liquidated or unliquidated, to an amount not exceeding Thirty Pounds: NOW I, the said Lieutenant Governor, in pursuance of the power and authority so vested in me by the said first recited Act, and of all other powers enabling me so to do, hereby direct and appoint that Courts of Requests in and for the City of Melbourne and County of Bourke, shall be holden during the year 1852 at the City of Melbourne, at the times hereinafter

respectively mentioned, that is to say—
The "Ordinary Sittings" of the Court of Requests for the trial of all cases not exceeding Ten Pounds, for the City of Melbourne and County of Bourke, shall be holden at the Court House, Melbourne, on the following days, and shall respectively be continued by adjournment shall respectively be continued by adjointment from day to day as may be found necessary, namely—Monday, 20th April; Monday, 19th March; Monday, 20th April; Monday, 18th May; Thursday, 11th June; Monday, 20th July; Monday, 17th August; Monday, 21st Septem-ber; Monday, 12th October; Thursday, 19th November; Monday, 14th December.

The New Sittings of the Court of Requests for the City of Melbourne and County of Bourke, for the trial of all cases from Ten to Thirty Pounds, shall commence and be holden at the Court House, Melbourne, on the following days, and shall respectively be continued by adjournment from day to day, as may be found necessary, namely—Thursday, 5th February; Thursday, 23rd April; Monday, 15th June; Thursday, 20th August; Thursday, 15th October;

Thursday, 17th December.

PROCLAMATION.

By His Excellency Charles Joseph La Trobe, Esquire, Lieutenant Governor of the Colony of Victoria and its Dependencies, &c. &c., &c.

THEREAS by an Act of the Imperial Parliament of Great Britain and Ireland, made and passed in the fifth and sixth years of the Reign of Her Majesty Queen Victoria, intituled "An Act for the Government of New South "Wales and Van Diemen's Land." It is amongst other things enacted, that there shall be within the said Colony of New South Wales a Legislative Council, to be constituted in the manner and for the purposes in the said Act mentioned. And that a portion of the Members of the said Council shall from time to time in the manner therein mentioned, be appointed by Her Majesty.
AND WHEREAS by the said recited Act of
Parliament, It is further enacted and provided
that it shall be lawful for Her Majesty by any warrant or warrants to be from time to time issued by Her Majesty under Her sign manual, and countersigned by one of Her Principal Secretaries of State, to nominate such part of the said Council as according to the said Act is to be appointed by Her said Majesty, and to designate such Non-Elective Members of the said Council either by their proper names or as holders for the time being of any public offices within the said Colony. And that it shall also be lawful for Her Majesty by any such warrant or warrants from time to time to delegate to the Governor of the said Colony the power of nominating and designating such Non-Elective Members of the said Council, either by their proper names or as holders for the time being of any such public offices as aforesaid, such delegated power being exercised by any such Governor provisionally only and until Her Majesty's pleasure shall be known, and not to be exercised until the return of the Writs for the Election of all the Elective Members. And provided always that not more than half the number of such Non-Elective Members shall hold any office of emolument under the Crown within the said Colony. AND WHEREAS by an Act of the said Parliament made and passed in the thirteenth and fourteenth years of the Reign of Her said Majesty, intituled "An Act for the better Government of Her Ma"jesty's Australian Colonics" It is amongst
other things enacted, that after the separation of
the said Colony of Victoria from the Colony of New South Wales there shall be within and for the said Colony of Victoria a separate Legislative Council, to consist of such number of mem-bers as shall be determined by the Governor and Legislative Council of New South Wales, and that such number of the members of the said Legislative Council of the said Colony of Vicnumber of members of such Council, or if such whole number be not exactly divisible by three, one third of the next greatest number which is divisible by three shall be appointed by Her Majesty, and the remaining members of the said Council shall be elected by the Inhabitants of the said Colony. AND WHEREAS by the afore-said recited Act of Parliament, It is amongst other things enacted and provided that subject to the provisions of the said first recited Act as explained and amended by certain Acts of Parliament therein mentioned, concerning amongst other things the appointment of Non-Elective Members of the said Legislative Council of the

said Colony of New South Wales, shall apply to and be in force in the said Colony of Victoria. AND WHEREAS by a certain Act of the said Governor and Legislative Council of New South Wales, passed in the fourteenth year of Her said Majesty's Reign, known as "The Victoria Electoral Act of 1851" It is amongst other things enacted that the Legislative council of the said Colony of Victoria shall consist of thirty members. AND WHEREAS in pursuance of the said recited Act Her Majesty has by a warrant under the sign manual, and countersigned by one of Her Majesty's Principal Secretaries of State, delegated to me as such Lieutenant-Governor as aforesaid (in the absence of Her Majesty's Captain General and Governor-in-Chief in and over the said Colony of Victoria and its dependencies), the power of nominating and designating the Non-Elective Members of the said Legislative Council of Victoria, subject to the provisions of the said Acts as hereinbefore recited. AND WHEREAS the Writs for the Election of all the Elective Members of the said Legislative Council of Victoria have been duly returned: NOW THEREFORE, I, Charles Joseph La Trobe, Esquire, as such Lieutenant Governor as aforesaid, do hereby proclaim that I have accordingly in pursuance of the power and authority so vested in me, appointed the following gentlemen to be the Non-Elective Members of the said Council, until Her Majesty's further pleasure shall be known, viz.-

PROCLAMTION,

By His Excellency Charles Joseph La Trobe, Esquire, Lieutenant Governor of the Colony of Victoria and its Dependencies, &c., &c., &c.

W HEREAS by an Act of the Imperial Parliament of Great Britain and Ireland, passed in the twelfth and thirteenth years of Her Majesty's Reign, intituled "An Act for re-"gulating the Carriage of Passengers in Merichant Vessels," it is amongst other things enacted, that it shall be lawful for the Governor of any of Her Majesty's possessions abroad, by any proclamation to be by him from time to time issued for that purpose, (which shall take effect from the issuing thereof) to declare the rule of computation by which the length of the voyage of any ship carrying passengers from such possession to any other place whatsoever, shall be computed for the purpose of the said Act, and

to substitute for the articles of food and provisions specified in the said Act such other articles of food and provisions as shall be a full equivalent for the same, and also to declare what medicines, medical instruments, and other matters, shall be deemed necessary for the medical treatment of the passengers during such colonial voyage; NOW THEREFORE I, Charles Joseph La Trobe, Esquire, the Lieutenant Governor aforesaid, by this my proclamation issued for that purpose, do declare that the following shall be the rule of computation by which the length of the voyage of any sailing vessel, auxiliary screw propelling vessel, screw steam vessel, or paddle wheel steam vessel, carrying passengers from any port or place in Victoria to the several places hereinafter enumerated, shall be respectively computed for the purposes of the said recited Act, that is to say:—

And I do hereby further declare that in addition to and irrespective of any provisions of their own which any passengers may have on board, the master of every such ship shall make to each passenger during the voyage, including the time of detention, if any, at any port or place before the termination of such voyage, the following issues of pure water, and sweetand wholesome provisions, being in accordance with the dietary scale fixed in the said recited Act (that is to say), of water at least three quarts daily, and of provisions after the rate per week of two and

a half pounds of bread or biscuit, not inferior in quality to what is usually termed navy biscuit, one pound of wheaten flour, five pounds of catmeal, two pounds of rice, two ounces of tea, half a pound of sugar, and half a pound of molasses, provided always that such issues of provisions shall be made in advance, and not les often than twice a week, the first of such issues to be made on the day of embarkation. Provided also, that potatoes when good and sound may be substituted for either the oatmeal or rice, in the proportion of five pounds of potatoes to one pound of oatmeal or rice. And lastly, I do hereby further declare that the medicines, medical instruments, and other matters necessary for the medical treatment of the passengers during any such voyage, shall be as follows, viz.:—

The Government will not necessarily accept the lowest or any Tender.

CONDITIONS.

- 1. All the articles above enumerated, are to be of the best quality of their several kinds, and must be (in cases where samples are required), equal to those provided and left with the tenders at the Treasury.
- 2. One price is to be stated for each article.
- 3. All orders for supplies under this contract must issue from the Colonial Storekeepers' department, to which office the supplies must be delivered for inspection an approval.
- 4. In the event of a difference of opinion between the contractor and the party receiving the supply, as to the quality, such difference is to be decided by a Board of Survey, to consist of the party receiving the supply, the contractor, and a party appointed by him, and a second Government officer.
- 5. If the Board shall decide that the article is not of proper quality it must be immediately replaced by the contractor, failing which it will be procured elsewhere, and the extra expense, if any, deducted from the amount then due to the contractor by the party requiring it.
- 6. In the event of any unnecessary delay or failure of the contractor to supply the articles when required, they will be otherwise procured and charged in like manner.
- 7. A repetition of irregularity in the quality or quantity of the supplies, or of any delay in delivering or replacing them when required, will subject the contractor to the forfeiture of his contract.
- 8. It will be in the power of either party to limit the duration of the contract, by giving in writing a notice of one calendar month to the opposite party, and to end the contract at the expiration of that period, it being understood that such notice can be given only on the first day of a month, and within the period for which the contract is made or agreed to be made.
- 9. Each supply must be accompanied by an invoice, shewing the quantity of the supply, which invoice must be signed by the party receiving the stores, and these receipts are to be produced with the contractors' quarterly accounts; no goods will be received unless accompanied by such an invoice.
