REGULATIONS RESPECTING CLERKS IN THE SERVICE OF THE COLONIAL GOVERNMENT.

IS Excellency the Lieutenant Governor has been pleased to direct that the Regulations of the 30th October, 1851, relative to the appointment, promotion, remuneration, and general duties of Clerks attached to the different departments of the Government of this Colony shall be revised, and that the following Regulations shall be in force from this date.

APPOINTMENT.

No person shall be taken into the service of the Government as a Clerk, until the Head of the Department to which he is to be attached, has taken the proper steps to ascertain his fitness in every respect, and has forwarded a certificate to this effect to the Colonial Secretary, and that His Excellency's sanction for the appointment has been given.

REMUNERATION.

The system of classing Clerks, and granting an Annual Increase of Salary, as directed by the former regulations, being now found to be inoperative, is cancelled, and the salaries voted for the Clerks of each Department, from time to time, are to be dealt with in the following manner.

All Clerks, on their first entering the service, are to be placed on the lowest rate of Salary, unless they should be appointed to some particular office of trust or responsibility, or requiring more than ordinary talents or acquirements, and all such cases are to be specially reported for the Lieutenant Governor's decision, before any increased rate can be granted to a Clerk entering the service of the Government.

The Salaries for other Clerks will be regulated

The Salaries for other Clerks will be regulated according to the positions which they may occupy in their respective departments, and as far as can be, by their length of service.

The rates of Salary will for the present graduate in sums of £50 a year from £200 to £400, which latter will be the highest salary, except for First or Chief Clerks, who will receive from £500 to £600 a year. In the Post Office the lowest rate of Salary is £300 a year.

Whenever Boys can be employed with advantage, they will receive from £75 to £100 a year, but no one of this class is to be taken into the service, unless he is fully competent for the work required of him.

It does not follow because certain rates of salary are voted by the Legislature, that they must of necessity be all granted, as Junior Clerks may have entered the Department subsequently to the Estimate having been made, who would not be entitled to the rates voted.

Promotion.

It is to be distinctly understood when a vacancy occurs in any of the senior grades, or among those Clerks receiving more than the lowest rate of salary, that no one can claim to occupy the vacancy solely on account of length of service, which however, will always have its due influence and consideration; but it must be coupled with the indispensable requirements of capacity, character,

and conduct, for the advanced position; and of general intelligence and industry in the performance of his duty.

When the Head of a Department wishes to recommend any one of his Clerks for promotion, he must do so in the form annexed, which is to be submitted for the Lieutenant Governor's approval.

REMOVAL FROM OFFICE.

It must be distinctly understood, that should a Clerk be found to be incompetent, or should he contract habits which would render his further employment undesirable, he will subject himself to immediate removal from the service without any claim for compensation. His habitual infringement of any of the following general rules would also subject him to the same penalty.

GENERAL RULES.

The hours of attendance at the Post Office, are from 9 A.M. to 6 P.M., at all the other offices from 9 A.M., to half-past 3 P.M., except on Saturdays, when the offices will close at half-past 12 of clock

Should, however, a Clerk be in arrears with his work, or the requirements of the service demand a longer attendance at some particular period, it is to be understood that such must be given

The whole of the time above specified must be entirely devoted by the Clork's of all Departments to their public duties, neither must they permit any one to visit them during office hours to occupy their attention upon private affairs.

No fee, or anything else by way of remuneration, can under any pretence be allowed to be taken by a clerk, for the performance of anything connected with the office to which he is attached.

No information out of the usual course of duty is ever to be given from an office, unless by the express sanction of the Head of the Department.

All public property, as Furniture, Stationery, &c., in the charge of, or used by clerks, is to be taken the strictest care of.

HOLIDAYS.

The fixed Holidays to be observed by the several Departments, with the exception of the Post Office, are, New Year's Day, Christmas Day, Good Eriday, Easter Monday, the Queen's Birthday, and the 1st July, being the anniversary of the foundation of the Colony.

RULES AND REGULATIONS

For admission to practise as Barristers, and as Attorneys, Solicitors, and Proctors, in the Supreme Court of the Colony of Victoria, of persons not previously admitted as Barristers or Advocates, or as Attor-neys, Solicitors, or Writers to the Signet, in the Superior Courts of Westminster, Dublin and Filinkanah Dublin, and Edinburgh.

HEREAS by an Act of the Lieutenant Governor and Legislative Council of the Colony of Victoria, passed in the fifteenth year of the Reign of Her Majesty Queen Victoria, in-tituled, "An Act for the better Administration of Justice in the Colony of Victoria," it was amongst other things enacted, "That it shall be "lawful for the Supreme Court of the Colony of " Victoria, from time to time to make such Rules " for regulating the admission of Barristers and " of Attorneys, Solicitors, and Proctors, to prac-" tise therein; and also the Qualification of Can-"didates to practice as Barristers, and as Attor-" neys, Solicitors, and Proctors, in the said Court; " and for regulating the Examination or further " or renewed Examination of such Candidates, " and the several departments of Literature, " Science, and Law, in which, respectively, such "Candidates are to be examined; and for fixing the amount of Fees and Costs to be paid by "them, and the mode of application of the same, as to the said Court shall seem meet; "and such Rules, from time to time to repeal, "vary, and alter, as occasion may require." We, the Judges of the said Court, do make and promulgate the following Rules for regulating the admission, qualification, and examination of Candidates to practise as Barristers, and as Attorneys, Solicitors, and Proctors, in the said Court, and the amount of Fees and Costs to be paid by them, and the mode of application of the same.

Rule I.—Boards of Examiners for Barristers and Attorneys.

There shall be two Boards of Examiners in the Supreme Court of the Colony of Victoria, which shall be respectively called "The Board of Examiners of the Supreme Court for Barristers," and "The Board of Examiners of the Supreme Court for Attorneys.

Rule II .- Constitution of Board of Exami-

ners for Barristers.
"The Board of Examiners of the Supreme Court for Barristers," shall consist of all the Judges of the said Court, Her Majesty's Attorney General of the said Colony, and two practising Barristers of the said Court, who shall be elected annually in the month of December in each year, by the practising Barristers of the said Court; and for the year ending the 31st December, 1852, and until such Election, it shall be competent for the said Judges to nominate such practising. Barristers.

Rule III.—Election of Practising Barristers.

Each practising Barrister of the said Court desirous to vote, shall, on or before the 10th day December in each year, signify in writing, signed by him, and addressed to the said Board, the names of the two practising Barristers who he proposes shall act for the ensuing year as Mem-bers of the Board, and the Board shall nominate as such Members those for whom the highest number of votes is given.

Rule IV.—Meeting of the Board—Adjourn-ment—Quorum.

The Board shall meet as often as occasion may require, and may adjourn its Meetings if deemed necessary.

Three Members shall form a Quorum for the transaction of business, and the majority of the Members present shall decide all questions which may arise

RULE V.—Board or its Appointees may ex-amine Candidates.

The said Board may either by all or any number of its Members, or by any competent person or person appointed by it, conduct the examination of all candidates, in such order, and on such days and times as may be fixed.

Rule VI .- Qualification of Candidates not previously admitted.

Every person applying to be admitted to practise as a Barrister, or as an Attorney, Solicitor, or Proctor in the said Court, not previously admitted as a Barrister or Advocate or as an Attorney, or Solicitor, or Writer to the Signet, in any of the superior Courts of Westminster, Dublin, or Edinburgh, must be a natural born or naturalised British subject of the full age of twenty-one years, of good fame and character; and such person shall, one calendar month before the time when he proposes to submit to be examined, cause to be left with the Secretary of the Board of Examiners for Barristers, satisfactory proof thereof, with a certificate in the form hercunto annexed, and shall, if required, attend the said Board for the purpose of giving further explanation touching the same.
Rule VII.—Candidates to be admitted as

Barristers to be examined.

Every such person applying to be admitted to practise in the said Court as a Barrister must submit to be examined in the Ancient Greek and Latin Classics, in Mathematics, History, and Law, and in such other branches of Knowledge and Science as "The Board of Examiners of the Supreme Court for Barristers" may from time to time direct; and he shall at the time of giving the notice above required, also cause a list in writing to be left with the Secretary of the said Board, setting forth the names of the works (from amongst those hereafter mentioned), in which he is desirous to submit to be examined.

RULE VIII .- Appointment of Time, &c., for Examination.

The Board, when satisfied as to the character of the candidate, shall name the persons to conduct the examination, and fix a place, day, and hour for the same, of which one week's notice in writing shall be given to the candidate, who shall attend the Examiners as directed thereby, and the Examiners shall have power to adjourn

from time to time, as may be necessary.

RULE IX.—Subjects in which Candidates are to be Examined.

2. Common Law, Pleading, and Practice.

3. Equity and Insolvency.

4. Criminal Law.

5. Evidence and the Law of Contracts, and each shall contain not fewer than twelve nor more than eighteen questions; and not more than two hours will be allowed to the candidate for answering one examination paper.

RULE X .- Mode of Examination.

The examination shall be conducted by questions in writing, given to the candidates and answered by them in writing, in the presence of the Examiners or one of them. The candidate shall sign his name to the answers of the examination papers, and the Examiners shall enclose and seal the same, and submit them without delay to the Board; and report to the Board as to each branch of the examination, whether the candidate has answered satisfactorily or not.

RULE XI .- Board to determine on Admission,

Rejection, or further Examination.

The Board or the major part of them, shall determine as to the admission or rejection of the candidate, or direct that he submit to a new or additional examination at some future day. If he be approved of, he may be admitted and sworn in on his own motion, or that of any Barrister of the said Supreme Court, on the next Banco day after the determination of the Board.

Rule XII.—Board of Examiners for Attorneys.
