PROCLAMATION

By His Excellency CHARLES JOSEPH LA TROBE, Esquire, Licutenant Governor of the Colony of Victoria and its Dependencies.

In accordance with the provisions of the Acts of the Governor and Council of New South Wales, 3rd William 4th, No. 1, and 5th Victoria, No. 12, I, by this Proclamation, declare and order that the Quarantine Station, at Point Nepean, shall be that portion of the county of Mornington, in the said Colony of Victoria, commencing at the Flagstaff, on Observatory Point, about one and a half miles east of Point Nepean, which Flagstaff bears from the Lighthouse at Shortland's Bluff, south thirty-four degrees east; and bounded on the north by the shores of Port Phillip Bay, eastward, to a Flagstaff, bearing from the Lighthouse, south forty-eight degrees east, Flat Island being south forty degrees west; on the east by a line south to the Sea Coast; on the south by Bass's Straits westerly; and on the west by a line bearing north to the commencing point: And I do hereby strictly prohibit all persons not being themselves under Quarantine, or duly authorized for the purpose of necessary communication with persons under Quarantine, or the Quarantine Station, from going, under any pretence whatever, within the limits herein-No. 32.—June 8th, 1853.—1.

before described, when any persons, goods, wares, or merchandize, are undergoing Quarantine within the said limits, under the pains and penalties prescribed by law.

PROCLAMATION

By His Excellency CHARLES JOSEPH LA TROBE, Esquire, Lieutenant Governor of the Colony of Victoria and its Dependencies, &c., &c., &c.

N accordance with the provisions of the Acts of the Governor and Legislative Council of New South Wales, 3 William IV, No. 1, and 5th Victoria, No. 12, I, by this Proclamation, do declare and order that the Quarantine Anchorage of the Port of Melbourne to be that portion of the Harbor commencing at a point one mile distant from Observatory Point, and bearing south from it, from thence extending in an easterly direction at the same distance from, and parallel to the line of coast leading to Point King, to a point bearing north one mile from a Flagstaff erected midway between Point King and Observatory Point. The magnetic bearings of the extreme points of the Quarantine Ground at Point Nepean are as follows, namely, the Flagstaff on Observatory Point, marking the western end of the Quarantine Ground bears S. 85° E. from the Flagstaff on Point Lonsdale, and S. 34° E. from the Lighthouse. The Flagstaff on Ticonderago Point which marks the

eastern end of the Quarantine Ground bears from the Lighthouse S. 48° E., and the south end of Flat Island N. 40° E. And I do hereby strictly prohibit all persons, not being themselves under Quarantine, or duly authorised for the purposes of necessary communication with vessels under Quarantine, from going, under any pre-tence whatever, within the limits hereinbefore described, when any ship or vessel is performing Quarantine, or any persons goods, wares, or merchandize, are undergoing Quarantine within the said limits, under the pains and penalties prescribed by law.

WHEREAS by an Act of the Governor and Legislative Council of New South Wales, passed in the fourteenth year of the Reign of Her Majesty Queen Victoria, called "The Vic"toria Eiectoral Act of 1851," it was amongst
other things enacted, that such other Polling
Places should be Polling Places for the several
Electoral Districts in the said Act more cartier Electoral Districts in the said Act more particularly mentioned, as should be appointed for that purpose by the Governor by Proclamation, to be issued by him and published in the Government Gazette of the Colony: Now therefore I, the Lieutenant Governor aforesaid, in pursuance of the power and authority so vested in me by the said recited Act, do by this my Proclamation hereby appoint that the following shall be a Polling Place for the Electoral District specified in connexion therewith, in addition to the Polling Places appointed by the said Act, that is to say : THE UNITED COUNTIES OR REPUTED COUNTIES OF TALBOT, DALHOUSIE, AND ANGLESEY-Melbourne.

T is hereby notified that application having been made for the purchase of the Lease of the Run of Crown Lands hereunder described, which, after having been occupied, has become forfeited, Tenders in the prescribed printed form will be received at this Office until noon of Wednesday, the third day of August next, from the applicant, and from any other person desirous to enter into competition with him, for the purchase of the lease of the said Run.

2. Every such Tender must state the term of years (not exceeding eight) for which it is proposed to take the Run, and whether, in addition to the minimum rent required by Her Majesty's Order in Council, it is intended to offer any, and if any, what amount of yearly premium per thousand sheep, or equivalent number of cattle, for the Lease.

3. As the grazing capabilities of the Run have not yet been determined, it will be necessary that each Tender contain an estimate of the sheep or cattle that the Run will carry, which must in no instance be less than four thousand sheep, or six

hundred and forty head of cattle.

4. Until the Run has been regularly surveyed, and its grazing capabilities determined, the future lessee will be required to pay rent according to his own estimate as given in his Tender; and in the event of the rent so paid proving to have been less than that determined by valuation, he will be required to make up the difference previously to the issue of the Lease.

5. It is also to be distinctly understood that the Government reserves to itself the right of excluding from the Lease of the said Run any land which it may be deemed proper to reserve for any of the purposes referred to in the 9th section of chapter 2 of Her Majesty's Order in Council, dated 9th March, 1847.
