## NORTHERN LIGHTHOUSES.

### NOTICE TO MARINERS.

#### *Whalsey Skerries, Shetland.—Temporary Lighthouse.*

The Commissioners of Northern Lighthouses hereby give notice that they are at present engaged in erecting a Lighthouse on the Out-Skerries of Whalsey, on the eastern coast of the Shetland Isles, and that until the completion of the permanent Lighthouse, a Light will be shewn from a temporary tower, and will be exhibited for the first time on the night of Friday, the 15th September, and every night thereafter, from the going away of day-light in the evening till the return of day-light in the morning.

The following is a specification of the Lighthouse, and the appearance of the Light, by Mr. DAVID STEVENSON, Engineer to the Commissioners:—

The Lighthouse is situated on the eastern part of the Island of Gruna, in N. lat. 60° 25' 24", and W. long. 0° 44' 20", the Bound Skerry of Whalsey bearing from the Lighthouse about E. by compass. The outer or seaward extremity of the Bound Skerry is about half a mile or thereby from the site of the Lighthouse, so that vessels in rounding the Light must give it a wide berth.

The Whalsey Light will be known to mariners as a Revolving Light, which shews a bright white Light once in every minute.

The temporary Light will be exhibited from a tower of timber frame work, and is elevated about 108 feet above the level of high water of ordinary spring tides, and may be seen at the distance of about 16 nautic miles, and at lesser distances according to the state of the atmosphere. To a near observer, in favorable circumstances, the Light will not wholly disappear between the intervals of greatest brightness.

The Commissioners further give notice that by an Order in Council, dated the 3rd day of July last, the following tolls are authorised to be levied in respect of the said Lighthouse, viz:—

For every vessel belonging to the United Kingdom (the same not belonging to Her Majesty, her heirs or successors, or being navigated wholly in ballast), and for every foreign vessel privileged to enter the ports of the United Kingdom upon paying the same duties of tonnage as are payable by British vessels which may pass or derive benefit from the Light, the toll of two-sixteenths of a penny per ton of the burthen of every such vessel for every time of passing or deriving benefit therefrom, if on a coasting voyage.

For every time of passing or deriving benefit on an oversea voyage, one penny per ton for every such vessel.

For every vessel not navigated wholly in ballast, and not privileged in manner before specified, double the respective tolls above set forth.

Which tolls are liable to the following abatements on payment:—For a coasting voyage, ten percent.; for an oversea voyage, twenty-five percent.

## CONDITIONS.

1. All the articles required by this notice are to be of the best quality of their several kinds.

2. The flour and bread must be the produce of clean sound Colonial wheat, from which, on the rations of emigrants, surveying parties, border police, 20 per cent., and on the rations to prisoners of the Crown 10 per cent. has been extracted in bran and waste.

7. Vegetables to be supplied in reasonable proportions of potatoes, greens, pumpkins, onions, &c., &c.

8. The supplies for road parties and surveying parties are to be delivered at the nearest fixed stations to the places where the party may be employed, on the requisition of the officer in charge.

9. The supplies (not specified in the preceding paragraphs) are to be delivered direct to the parties or establishment entitled thereto, on the written order of the person duly authorised for the purpose.

10. Provisions, when required by rations, according to the scales under their respective heads, the tenders are to express the price per ration only.

11. In the event of a difference of opinion between the contractor and the party receiving the supplies, as to the quality, the same is to be decided, in cases where the article is not of a perishable nature, by a Board of Survey, according to the practice of the service. But, in country districts, where a Board of Survey cannot be conveniently assembled, the party objecting will name one person as arbitrator, the contractor or his agent another, and these two will (previously to any other proceeding on their part) concur in naming a third as umpire, who, in the event of the arbitrators not agreeing in opinion, will be called upon for his decision, which shall be final.

12. If the Board, arbitrators, or umpire shall decide that the article is not of proper quality, it must be immediately replaced by the contractor, failing which it will be procured by the party requiring it, and the expense charged to the contractor.

13. In the event of any unnecessary delay or failure of the contractors to supply the articles when required, they will be otherwise procured, and charged in like manner.

14. In cases where the article is of a perishable nature, or from some other cause, injury would be sustained, either by the parties to whom the rations are due, or to the contractor by waiting for a Board of Survey, the Civil Commissariat Officer, the head of the department or officer in

charge of the party or parties for whom the rations are to be received, shall have the power to reject such article or articles as are obviously of inferior quality; it being distinctly understood that he will be responsible to the Government for so doing; and that the contractor will have a right of appeal to the Governor, although in the meantime he must take back the rejected article, and supply good in its stead, failing which it will be obtained by the officer or party requiring it, and the expense charged to the contractor.

15. A repetition of irregularity in the quantity or quality of the supplies, or of any delay in delivering or replacing them when required, will subject the contractor, upon report of the officer in charge of the parties or establishments, to such mulct, not exceeding one-fourth the amount of his monthly account, as the Governor may direct. 16.
