MUNICIPAL DISTRICT OF EAST COLLING-WOOD ENLARGED.

PROCLAMATION

By His Excellency SIR CHARLES HOTHAM, Knight Commander of the Most Honorable Military Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

HEREAS by a Proclamation bearing date the twenty-third day of April, in the year One thousand eight hundred and fifty-five, under the hand of the Lieutenant Governor and Seal of the Colony, it was declared and appointed that the several districts therein named should be Municipal Districts, and amongst others, the boundaries of the Municipal District of East Collingwood, in the County of Bourke, were thereby defined: And whereas it is deemed expedient to alter the boundaries of the said Municipal District of East Collingwood, by uniting thereto the portion of land hereinafter described, in pursuance of the authority of two several Acts of the Lieutenant Governor and Legislative Council of the Colony of Victoria, passed in the eighteenth year of the Reign of Her present Majesty, intituled, respectively, "An Act for the Establishment of Municipal "Institutions in Victoria," and "An Act to "amend an Act intituled 'An Act for the Establishment of Municipal Institutions in "Victoria:'" Now, therefore, I, the Governor of the said Colony, do, by this my Proclamation, with the advice of the Executive Council, and under the authority of the said Acts, alter the said Municipal District of East Collingwood and the limits thereof, and with the advice aforesaid,

I do declare and appoint that the portion of land, the boundaries and limits whereof are hereinafter defined, shall be united to and form part of the said Municipal District of East Collingwood, that is to say:—

Commencing at the intersection of Smithstreet and Reilly-street; thence by the western side of Smith-street to the main Heidelbergroad; thence by the south side of that road to a bridge on the Merri Creek, thirty chains, more or less, south-east from East-street, Northcote; thence by the western side of the Merri Creek to a point due east from the south side of Reilly-street; thence by a line bearing west, and the south side of Reilly-street aforesaid, to the commencing point, except that piece or portion of land known as the Corporation Quarry Reserve, and situate as follows:—Commencing at a point bearing east twenty-seven chains and fifty links, and thence north three chains and fifty links from the north-west angle of allotment 2 portion A, parish of Jika Jika; thence north six chains and sixty-six links; thence esset fifteen chains; thence west fifteen chains, to the commencing point.

Given under my Hand and the Seal of the Colony, at Melbourne, this fourteenth day of September, in the year of Our Lord One thousand eight hundred and fifty-five, and in the nineteenth year of Her Majesty's Reign.
