# POSTPONEMENT OF THE NEXT GENERAL SESSIONS FOR GIPPS LAND.

PROCLAMATION

By His Excellency Sin Henry Barrly, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act passed in the sixteenth year of the Reign of Her present Majesty, intituled, "An Act to make pro"vision for the better administration of Justice in Courts of General Sessions in the Colony of Victoria," it is lawful for the Governor, from time to time, to define and appoint by Proclamation the times at which such courts shall be holden, and such times to alter and vary as the said Governor shall think fit: And whereas it is expedient to alter the time already appointed for holding the next Court of General Sessions of and for the district of Gipps Land: Now therefore I, Sir Henry Barkly, the Governor of Victoria, do hereby alter the time appointed for holding the next Court of General Sessions for Gipps Land as follows, that is to say:—At Alberton, from Wednesday, the first day of September now next ensuing, to Wednesday, the eighth day of the same month of September.
