DIVISIONS OF THE MINING DISTRICT OF MARYBOROUGH.

At the Government House, Melbourne, the fourth day of October, 1858.

PRESENT:

His Excellency the Governor

Major-General Macarthur, C.B. | Mr. Harker
Mr. O'Shanassy | Mr. Miller

WHEREAS by an Act passed in the twenty-first year of the reign of Her present Majesty, intituled, *An Act for amending the Laws relative to the Gold Fields*, it is amongst other things enacted that it shall be lawful for the Governor in Council to split any mining district as thereinafter mentioned into any number of divisions, and to define the limits and boundaries thereof respectively, and also to determine the number of members of the mining board of such district which shall be elected within and for every such division, and from time to time to alter any such division and the limits and boundaries thereof, and to vary the number of members which shall be elected within and for every such division, but so that the total number of members elected for such district shall in no case exceed or be less than ten: And whereas it is expedient to reduce the number of divisions into which the mining district of Maryborough has been split to four divisions, and to incorporate the Amherst

division of the said mining district with the Maryborough division thereof: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order alter the divisions into which the mining district of Maryborough was divided by an Order of the Governor in Council, bearing date the first day of February, One thousand eight hundred and fifty-eight, and doth hereby split the said mining district into the four divisions named in the first column of the schedule hereunto annexed, and doth define the limits and boundaries of each such division to be those set opposite thereto respectively in the second column of the same schedule, and doth determine that the number of members of the mining board of the said mining district which shall be elected within and for each such division shall be that set immediately under the name of each such division respectively in the first column of the said schedule.

THE SCHEDULE.

Names of the Four Divisions.	Limits and Boundaries.
KORONG ... <i>One member.</i>	As described in the Order of the Governor in Council of the first day of February, A.D. 1858.
DUNOLLY ... <i>Three members.</i>	As described in the same Order.
MARYBOROUGH ... <i>Five members.</i>	Commencing at the junction of the Bet-bet Creek and the River Loddon; thence by the River Loddon and the Deep Creek to the northern boundary of the parish of Carisbrook; thence by the northern and eastern boundaries of the said parish to the Deep Creek; thence by the Deep Creek to its junction with the Bullarook Creek; thence by a line bearing west to Mount Greenock Creek; thence by that creek to its source in the main dividing range; thence by the dividing range to the source of the Burnbank Creek, and thence by that creek and the Bet-bet Creek to the commencing point.
AVOCA ... <i>One member.</i>	As described in the Order of the Governor in Council of the first day of February, A.D. 1858.

POLLING PLACES FOR THE MARYBOROUGH MINING DISTRICT.

WHEREAS by an Act passed in the twenty-first year of the reign of Her present Majesty, intituled, *An Act for amending the Laws relative to the Gold Fields*, it is enacted that a poll shall be taken for the election of members for each division of every mining district, at such places within such division as the Governor in Council shall from time to time direct: And whereas by an Order of the Governor in Council, bearing even date herewith, certain alterations have been made in the divisions of the mining district of Maryborough, and it is expedient to re-arrange the polling places for taking the poll at any election of members of the Mining Board of the said district: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order direct that in lieu of all places previously appointed for taking the poll at elections for the several divisions of the mining district of Maryborough, the poll shall be taken for the said elections at the several places named in the last column of the schedule hereunto annexed, within and for the divisions respectively set opposite thereto in the second column of the same schedule, that is to say:—

District.	Divisions.	Polling Places.
Maryborough	Korong Dunolly Maryborough Avoca	Korong and Kooyoorra. Dunolly, Cochrane's, and Sandy Creek. Maryborough, Havelock Flat, Alma, Amherst, and McCallum's Creek. Avoca and St. Arnaud.
