THE NOMINATION PLACE FOR THE EASTERN PROVINCE ALTERED.

PROCLAMATION

By His Excellency **SIR HENRY BARKLY**, Knight Commander of the Most Honorable Order of the Bath, Captain-General and Governor-in-Chief of the Colony of Victoria, and Vice-Admiral of the same, &c., &c., &c.

IN pursuance of an Act of the Governor and Legislative Council of the Colony of Victoria, passed in the nineteenth year of Her Majesty's reign, intituled, *An Act to provide for the Election of Members to serve in the Legislative Council and Legislative Assembly of Victoria respectively*: I, Sir Henry Barkly, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation abolish the place already appointed for the nomination of Candidates to serve in the Legislative Council of Victoria for the Eastern Province, and I do hereby appoint that Seymour B. shall be the place of nomination as aforesaid for the said Eastern Province.

Given under my Hand and the Seal of the Colony, at Melbourne, this third day of September, in the year of Our Lord One thousand eight hundred and sixty, and in the twenty-fourth year of Her Majesty's Reign.
