TEMPORARY STOPPAGE OF TRAFFIC ON PORTIONS OF THE SYDNEY ROAD DURING THE PROGRESS OF WORKS.

THE Governor, with the advice of the Executive Council, has confirmed the following Order made by the Board of Land and Works.

ORDER of the Board of Land and Works relative to stopping traffic on two several portions of the Sydney road, between Violettown and Benalla.

It is ordered by the Board of Land and Works, acting under the powers conferred by the Act 27 Victoria No. 176, § 247, and 16 Victoria No. 40, § 44, that all traffic be stopped, until further notice, from passing over the two portions below named of the Sydney road, between Violettown and Benalla.

Persons infringing this Rule and Order will subject themselves to a penalty not exceeding Twenty pounds.

Portion 1. Commencing at 7 miles 37 chains south of Benalla toll-gate (or at the north end of Baddaginnie bridge), and extending towards Benalla 1 mile and 78 chains.

Portion 2. Commencing at 2 miles 27 chains south of Benalla toll-gate, and extending towards Benalla 1 mile and two chains.

WHEREAS by an Act passed in the seventeenth year of the reign of Her Majesty Queen Victoria, intituled, An Act for Electric Telegraphs, it is amongst other things enacted, that it shall be lawful for the Governor, with the advice of the Executive Council, to appoint the amount of fees, rates, or dues to be demanded or received for the transmission or conveyance of any despatch, message, or communication by means of any such line, and for the due delivery thereof respectively, and for No. 123.—DRECHMERE 9, 1863.—1.

copies of any such despatch, message, or communication; and also, with the advice aforesaid, to make rules and regulations for the transmission and conveyance of all despatches, messages, or communications by means of any such line, and for the payment of such fees, rates, and dues, and generally for the conduct, management, working, and maintenance of any such line of communication, and any such fee, rate, or due, rule, or regulation to increase, lower, repeal, alter, or vary respectively, and appoint and make such others as may be deemed expedient:

Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order appoint that telegraphic reports of the arrival of ships or vessels at any port in the colony, or off any part of the coast thereof, shall, if they contain no further or other information or intelligence, be deemed to be press messages within the meaning of the Order in Council of the 11th day of March, 1861, and be charged for accordingly.

And the Honorable Thomas Howard Fellows, Her Majesty's Postmaster General for Victoria, shall give the necessary directions herein accordingly.

WHEREAS by The Local Government Act, 1863, it is amongst other things enacted, that in and for each original district within thirty days after the commencement of this Act, and in and for each single proclaimed district within fifteen days after the constitution thereof, the Governor in Council shall, and from time to time afterwards if it shall seem fit may on the application of the board of any such district, appoint a sufficient number of polling places for every such district at which the poll shall be taken at all elections held for the same, and may from time to time on the like application alter and vary the same: And whereas by an Order of the Governor in Council, made on the thirtieth day of last September, polling places were appointed for elections in original districts: And whereas it is expedient to alter and vary the polling places in certain districts: Now therefore His Excellency the Governor, by and with the advice of the Executive Council,

doth by this present Order appoint the polling places mentioned in the first schedule hereunto annexed to be additional polling places for the districts opposite to which respectively such additional polling places are mentioned; and, with the advice aforesaid, doth further appoint that the polling places mentioned in the second schedule hereunto annexed shall be substituted polling places for the districts opposite to which respectively such substituted polling places are mentioned, in lieu of the polling places appointed for the same districts by the Order in Council of the thirtieth day of September aforesaid, viz.:—
