THE THIRD SESSION OF THE THIRD PARLIAMENT OF VICTORIA.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Constitution Act* it is amongst other things enacted, that it shall be lawful for the Governor to fix such places within Victoria, and (subject to the limitation in the said Act contained) such times for holding the first and every other session of the Legislative Council and Legislative Assembly of Victoria, and to vary and alter the same respectively as he may think fit: And whereas it is expedient to fix the time for holding the next Session of the said Legislative Council and Legislative Assembly now called "The Parliament of Victoria," which stands prorogued to Friday, the eighteenth day of December instant: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, do hereby further prorogue the said Parliament from Friday, the eighteenth day of December instant, to the day hereinafter mentioned; and, in pursuance of the power and authority in me vested as aforesaid, I do hereby appoint and proclaim that the Third Session of the Third Parliament of Victoria shall commence and be holden, for the despatch of business, on Tuesday, the twenty-sixth day of January, One thousand eight hundred and sixty-four, at Two of the clock in the afternoon, in the Parliament Houses, situate in Parliament Place, Spring Street, in the City of Melbourne: And the Members of the said Legislative Council and Legislative Assembly respectively are hereby required to give their attendance at the said time and place accordingly.

Given under my Hand and the Seal of the Colony, at Melbourne, this fourteenth day of December, in the year of our Lord One thousand eight hundred and sixty-three, and in the twenty-seventh year of Her Majesty's reign.

RULES OF THE RICHMOND COMPANY V.V.R.F.

1. The senior officer present at any meeting under these rules shall be the chairman.
2. The commanding officer shall call a meeting upon requisition, in writing, of not less than twelve members; notice of such meeting to be given on parade, and also posted in the orderly room, at least seven days prior to such meeting being held.
3. A debit and credit account shall be opened with every member, wherein all monies paid on his behalf and fines incurred by him shall be debited to him, and all monies received on his account or from him shall be credited.
4. If on the first of January in each year the debit exceed the credit by more than Ten shillings, such amount, not exceeding the sum of Two pounds, shall be considered as a fine due to the corps, and posted as provided in rule 6.
5. It shall, however, be in the discretion of the officer commanding to withhold the enforcement of any such fine so incurred for the whole or any portion of the current year.
6. All fines incurred under the Government Regulations during any month shall be posted in the orderly room on the first day of the succeeding month, and the same must be paid during the then current month.
7. Any member appearing on parade or in uniform in a dirty state shall be liable to a fine of One shilling for the first offence, and Two shillings and sixpence for every subsequent offence.
8. All members, whether in or out of uniform, attending the orderly room or at the butts, during the hours of drill or practice, shall be considered on duty, and as such shall be amenable to the orders of the officer or non-commissioned officer in charge for the time being; provided always that such attendance shall not be credited to any member unless he actually takes part in such drill; and any member either swearing or making use of foul or obscene language, or behaving himself in an improper manner, shall be reported to the commanding officer, and shall be liable to a fine of One shilling for the first offence, and for any subsequent offence to a fine of Two shillings and sixpence, and may render himself liable to be dismissed.
9. Any member reported as wearing a *part only* of his uniform shall be liable to a fine of One shilling for the first offence, and for every subsequent offence Two shillings and sixpence.

The foregoing rules were adopted by the members of the Richmond Company of the Victorian Volunteer Rifle Force, at a general meeting, duly convened, held on Monday, 2nd November, 1863.

RULES OF THE BALLARAT VOLUNTEER RANGERS.

1. The regiment shall be styled "The Ballarat Volunteer Rangers," and every member shall be subject to the following rules.
2. The monthly subscription shall be Two shillings, payable on the first day of each month.
3. No member shall wear the regulation uniform as adopted by the corps unless on duty, or by permission of the officer commanding the corps.
4. Any member having any complaint to make against any other member of the corps, whether commissioned officer, non-commissioned officer, or private, shall make the complaint in writing to the captain of his company, by whom it shall be

placed in the hands of the commanding officer, who shall decide what action shall be taken in the matter.

5. Any member desiring leave of absence exceeding twenty-eight days, shall apply in writing for such leave of absence to the officer in command of the corps, shall return his rifle and accoutrements into store properly cleaned and in good repair, and shall leave his address. All members changing their permanent address shall give notice of the same in writing to the secretary within fourteen (14) days of the same, under a penalty of Two shillings and sixpence.

6. Should occasion require the corps to be called together on any emergency, any member having obtained leave of absence shall hasten at once to headquarters, and consider his leave of absence cancelled.

7. Members shall be accountable for the good and serviceable order of their arms and accoutrements, clothing, &c., and shall make good any damage thereto that may be occasioned by negligence.

8. All fines collected shall be appropriated to such uses as the committee appointed under these rules shall decide; and at every general meeting of the corps (which general meeting shall be held half-yearly, viz., after the first parades in the months of January and July), the secretary shall submit a statement of all fines and subscriptions, and of their appropriation, for the information of the corps.

9. All members who may be three months in arrears with their subscriptions and fines, shall be proceeded against under the Volunteer Act for the recovery of the same.

10. The committee shall consist of thirteen members, viz., the commanding officer and three senior officers, the secretary and treasurer to be *ex officio* members, and seven members to be elected by ballot, five to form a quorum. The election of the committee, secretary, and treasurer to take place at the half-yearly meetings of the corps.

11. The officer commanding shall fix the time and place for drill, parade, and practice, and meetings not otherwise provided for by these rules.

12. If on the 1st January in any year a member's debit exceeds his credit by £1 or upwards, he shall be fined the amount of such difference; provided always that the amount of such fine shall not in any case exceed £2, and that the officer commanding may, at his discretion, enforce only one-half the fine.

13. If any member at any time desire to quit the corps under the provisions of the Act, he shall be fined the amount, if more than Ten shillings (10s.), whereby the debit exceeds his credit; provided that no such fine shall exceed £2, and that the whole or the half may, at the discretion of the officer commanding, be remitted.

Each applicant should furnish, in addition to the above, any documentary evidence which he may consider important.

Unless the above information is placed in the hands of the board on or before the 22nd January, 1864, the claim will not be considered.

Claims for rewards for discoveries made in 1863 cannot be entertained, a previous board having been appointed for their consideration; neither will discoveries be considered for which any reward has been paid by the colony.

COMMON-TOLL ROAD.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS the Boards of the Berwick and the Cranbourne road districts have complained to the Governor in Council that they ought, by reason of the traffic passing along the road hereinafter mentioned being common to their own respective districts with the district in which tolls are payable upon such road, to have a share of such tolls in the manner provided in the 254th clause of *The Local Government Act, 1863*: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the road extending from the western boundary of the Dandenong road district to the River Bunyip, at the eastern boundary of the Berwick Road District, to be a Common-toll road of the Berwick Road District, the Cranbourne Road District, and the Dandenong Road District, for the purposes and within the meaning of the provisions of the said Act relating to common-toll roads.

COMMONS ALTERED.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act, 1862*, it is amongst other things enacted, that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold field, or in or within five miles of any town not contained in any municipal district, or within any agricultural area of which at least one-fourth part has been selected, the Governor in council may proclaim such land to be a municipal common, or a gold fields common, or a town common, or a farmers' common respectively, as the case may be; and it is also enacted that the Governor in Council may at any time increase, diminish, alter, or abolish any common proclaimed before or after the passing of the said Act: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby alter the commons hereinafter mentioned in accordance with the above-recited provisions of the said Act, that is to say:—

NEWHAM FARMERS' COMMON, described amongst others in a Proclamation bearing date the fourth day of March, 1861, is hereby altered by deducting from said common allotments 64, 65, 66, 69, 70, and 71, parish of Rochford, and adding to the said common allotments 7, 8, 10, 12, 19, 20, and 21, section 2, parish of Newham, as shown on plan deposited in the Crown Lands Office, Melbourne. Approximate area of common, being the unsold and unappropriated land within the boundaries, 9000 acres, more or less.—(63.H.10530.)

SAGO HILL AND CAMPBELL'S GULLY GOLD FIELD COMMON, described in two several Proclamations bearing date respectively the twenty-first day of October, 1861, and the twenty-seventh day of November, 1862, is hereby altered by deducting therefrom nine hundred and ninety acres, more or less, described as follows:—Commencing at the south-east angle of allotment 5, section 17, parish of Cardigan; thence east to a point on the west side of allotment 1, section 8, same parish; thence south to the south-west angle of last-named allotment; thence east to the south-east angle thereof; thence south to the south-west angle of allotment 2, section 8, same parish; thence by a road south-westerly about ten chains, more or less; thence west to the south-east angle of allotment 3, section 18, parish aforesaid; thence north to the point of commencement, being the unappropriated land within the above-described area. 2. The flour and bread must be the produce of prime wheat, from which twenty per cent. has been extracted in bran and waste for second quality, and twelve per cent. for third quality of bread.

3. Fresh meat (except when ordered for the Lunatic Asylum free from bone) is to be supplied in such proportions as may be required, and when the quantity admits, to be delivered in fore and hind quarters alternately. When shins of beef form a portion of the supply, a fair proportion of the bone, not less than five inches, must have been cut off.

4. The supplies are to be delivered direct to the establishment entitled thereto, on the written order of the officer in charge, or at the Government Stores, on the order of the Government Storekeeper.

5. Should the contractor fail to supply any articles when required within twenty-four hours, they will be otherwise procured, and the expense over and above the contract price will be deducted from his account.

8. If the board shall decide that the article is not of proper quality, it must be immediately replaced by the contractor, failing which, it will be procured by the person requiring it, and the expense charged as in clause 5.

9. In cases where the article is of a perishable nature, or when from some other cause injury would be sustained either by the person to whom the rations are due, or to the contractor, in waiting for a board of survey, the head of the department, or officer in charge of the station, will have power to reject such article or articles as are obviously of inferior quality, it being understood that he will be responsible to the Government for so doing, and that the contractor must take back the rejected article and supply good in its stead, failing which, it will be obtained by the officer requiring it, and the expense charged as in clause 5.

10. A repetition of irregularity in the quantity or quality of the supplies, or of delay in delivery or replacing them when required, will subject the contractor, upon report of the Government Storekeeper, to such mulct, not exceeding one-fourth the amount of the monthly account, as the Government may direct; it will also be in the power of the Government to terminate the contract forthwith.

11. It will be competent for the Government Storekeeper on behalf of the Government, or the contractor on his own behalf, to terminate the contract, by giving in writing a notice of three full calendar months; it being understood that such notice can be given only from the first day of a month, and within the period for which the contract is made.
