REGULATION AS TO FEES FOR CROWN GRANTS AND LEASES, ETC.

THE Governor in Council has, in exercise of the power given by the 133rd section of *The Land Act*, 1862, made the following Regulation:—

The fees for Crown Grants and Leases, and also the contribution to the Assurance Fund payable under the Real Property Act on Crown Grants, are to be paid to the Receiver and Paymaster, Melbourne. Notification of the grants and leases with such Receiver and Paymaster, and awaiting the above payments, will be published in the *Government Gazette*.

Grantees or lessees can have their deeds made deliverable at any particular Receipt and Pay Office in the colony, on notifying their wish to the Receiver and Paymaster, Melbourne, at the time of making the above payments. The receipt for the fee on the grant or lease will have to be produced on delivery of deeds.

WHEREAS the Council of the Borough of Castlemaine and the Newstead District Road Board have complained to the Governor in Council that they ought, by reason of the traffic passing along the road hereinafter mentioned being common to their own respective districts with the district in which tolls are payable upon such road, to have a share of such tolls in the manner provided in the 25th clause of *The Local Government Act, 1863*: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the Castlemaine to Newstead (*vide* Campbell's Creek) road to be a Common-toll road of the Borough of Castlemaine, the Campbell's Creek Road District, and the Newstead Road District, for the purposes and within the meaning of the provisions of the said Act relating to common-toll roads.

THE FRANKLIN AND YANDOIT ROAD DISTRICT
ADDED TO.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Local Government Act, 1863*, it is amongst other things enacted, that it shall be lawful for the Governor in Council from time to time, if it shall seem fit, to add to any district not divided into subdivisions, or to any subdivision, or separately to two or more subdivisions of a district so divided, any portion of the colony actually adjoining to such district or subdivision, as the case may be, and not lying within the limits of the city of Melbourne or town of Geelong, or of any municipal or road district; and every such portion so added shall thereupon become and be part of such first-mentioned district to all intents and purposes, and of the subdivision, if any, to which the same shall have been added: And whereas by a Proclamation under the hand of the Governor and the seal of the colony, bearing date the tenth day of December, 1860, the boundaries of the Franklin and Yandoit road district were altered and defined as therein mentioned: And whereas it has seemed fit to the Governor in Council to make an addition to the said district by the extension of its southern boundary: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the said addition to the Franklin and Yandoit road district by the extension of its southern boundary, in accordance with the above-recited provisions of the said Act; and do hereby re-define the whole of the said road district added to as aforesaid, in manner following, that is to say:—

Commencing at a point one chain east of the south-east angle of portion 6 of section VIII. of the parish of Wombat; and

thence by a line bearing north along the west boundaries of portions 4 and 3 of section VII. of the said parish; thence northwards to the south side of block 19, in the parish of Holcombe; thence westerly along the south boundary of the said block 19 to the centre line of Middleton's Creek; thence northerly along the centre line of Middleton's Creek to a point north of the northern extremity of block 2 of the said parish of Holcombe, the boundary line thus far being conterminous with the west boundary of the Glenlyon road district; thence further on the east by a line bearing north to a point on the south boundary of the parish of Fryers; thence west by the said boundary to the south-west angle of the said parish of Fryers; thence north to the north-east angle of the parish of Yandoit; thence on the north and west by the north and west boundaries of the parish of Yandoit, and the west boundary of the parish of Franklin continued south to the centre line of the Glengover or McLachlan's Creek; thence southwards by the centre line of the said creek and by the eastern boundary of the Creswick road district to the southern boundary of the county of Talbot; thence north-easterly by the said county boundary to a point due south of the south-east angle of the borough of Daylesford; thence by a line north to the south-east angle of the said borough; thence west, north, and east by the south, the west, and part of the north boundaries of the said borough to the commencing point.—(63.2432.)

EXTENSION OF THE 11TH CLAUSE OF THE FISHERIES ACT TO LAKE BOLOKE AND THE CREEKS RUNNING THEREINTO AND THEREFROM, AND THE MORDIALLOC CREEK AND ITS EMBOUCHURE.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by an Act of the Parliament of Victoria, passed in the twenty-fifth year of the reign of Her present Majesty, intituled, *An Act to amend and consolidate the laws for the protection of the Fisheries of Victoria*, it is amongst other things enacted that if any person shall set, lay down, use, or fish with any kind of net in the Yarra Yarra, Plenty, Werribee, or Saltwater Rivers, in the colony of Victoria, or in any or either of their respective tributaries, or in any other river, lake, creek, stream, or pond, in which the Governor, with the advice of the Executive Council, shall, by proclamation duly published in the *Government Gazette*, extend the provisions of the 11th clause of the said Act, he shall forfeit such net, and also such sum not exceeding Ten pounds, as the convicting justice shall think fit: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby extend the above-recited provisions of the said Act, being the eleventh clause thereof, to Lake Boloke, and the creeks running thereinto and therefrom, and the Mordialloc Creek and its embouchure.

RULES OF THE NO. 2 CORPS OF THE BALLARAT VOLUNTEER RANGERS.

- The corps shall be styled "The 2nd Ballarat Volunteer Rangers," and every member shall be subject to the following rules.
- The monthly subscriptions shall be One shilling (1s.), payable on the first day of each month.
- No member shall wear the regulation uniform, as adopted by the corps, unless on duty or by permission of the officer commanding the corps.
- Any member having any complaint to make against any other member of the corps, whether commissioned officer, non-commissioned officer, or private, shall make the complaint in writing to the captain of his company, by whom it shall be placed in the hands of the commanding officer, who shall decide what action shall be taken in the matter.
- Any member desiring leave of absence exceeding twenty-eight (28) days, shall apply in writing for such leave of absence to the officer in command of the corps, shall return his rifle and accoutrements into store properly cleaned and in good repair, and shall leave his address. All members changing their permanent address shall give notice of the same in writing to the secretary within fourteen (14) days of the same, under a penalty of Two shillings and sixpence (2s. 6d.).
- Should occasion require the corps to be called together on any emergency, any member having obtained leave of absence shall hasten at once to headquarters, and consider his leave of absence cancelled.

- Members shall be accountable for the good and serviceable order of their arms and accoutrements, clothing, &c., and shall make good any damage thereto occasioned by negligence.
- All fines collected shall be appropriated to such uses as the committee appointed under these rules shall decide; and at every general meeting of the corps (which general meeting shall be held half-yearly, viz., after the first parades in the months of January and July), the secretary shall submit a statement of all fines and subscriptions, and of their appropriation, for the information of the corps.
- All members who may be three months in arrears with their subscriptions and fines, shall be proceeded against under the Volunteer Act for the recovery of the same.
- The committee shall consist of ten (10) members (viz.), the commanding officer and three senior officers, the secretary and treasurer to be *ex officio* members, and four members to be elected by ballot; four to form a quorum. The election of the committee, secretary, and treasurer to take place at the half-yearly meetings of the corps.
- The officer commanding shall fix the time and place for drill, parade, and practice, and meetings not otherwise provided for by these rules.
- If on the 1st January in any year a member's debit exceeds his credit by £1 or upwards, he shall be fined the amount of such difference; provided always that the amount of such fine shall not in any case exceed £2, and that the officer commanding may, at his discretion, enforce only one-half the fine.
- If any member at any time desire to quit the corps under the provisions of the Act, he shall be fined the amount, if more than Ten (10) shillings, whereby the debit exceeds his credit; provided that no such fine shall exceed £3, and that the whole or the half may, at the discretion of the officer commanding, be remitted.

These rules were read over to No. 2 Corps, on the 28th November, 1863, and agreed to.

BRIGHTON VOLUNTEER RIFLE CORPS.

1. All members changing their permanent address must, within thirty (30) days, give notice of the same in writing to the officer commanding, under a penalty of Two shillings and sixpence (2s. 6d.)
2. Every member will be responsible for the good and serviceable order of his arms, accoutrements, and clothing, and any damage done thereto shall be made good by him.
3. Any member who, after having been supplied with uniform, shall attend parade or drill not dressed in accordance with the established regulations, or whose arms, accoutrements, or clothing shall be dirty or in any way unserviceable from neglect, may be fined by the officer commanding in a sum not exceeding One shilling (1s.) for each offence.
4. Any member who shall be guilty of inattention, talking, or other unsteadiness at any parade or drill, shall be liable to be ordered to fall out and put to instruction drill under a non-commissioned officer.
5. Any member will be liable to be sent to instruction drill by the officer commanding for want of knowledge occasioned by absence or other cause.
6. An account of all fines as incurred and received shall be kept in a book, which shall be open for inspection in the orderly room.
7. A list of all fines imposed in any month shall be signed by the officer commanding, and be posted in the orderly room, or other place appointed, on the first of the following month.
8. All fines must be paid to the sergeants in charge of squads within the month on the first of which they were posted.
9. An annual meeting of the corps shall be held in the month of January in each year, of which one (1) week's notice shall be given by circular.
10. At every annual meeting four (4) persons shall be chosen, who, with the officer commanding and four (4) senior officers of the corps, shall form a committee (of whom five (5) shall be a quorum), to audit and settle the accounts, and generally to take into consideration any matters connected with the corps that may be referred to them by the officer commanding.
11. The officer commanding may at any time convene a special meeting of the corps, and must do so on the written requisition of twelve (12) members. No such special meeting shall be duly convened unless notice of it shall have been given at a parade of the corps, and it shall have been called by an advertisement inserted or circular issued to every member four (4) days previous to the day of meeting.
12. At any meeting of the corps the senior officer present shall take the chair.
13. An account shall be kept with each member of the corps, in which he shall be debited with all sums charged to the corps on his behalf for uniform and drill instruction, and credited with all amounts earned by him as an effective.
14. If on the first day of January in any year a member's debit exceed his credit by Ten shillings (10s.), he shall be fined the amount of such difference: Provided always that the amount of such fine shall in no case exceed Two (2) pounds, and that the officer commanding may remit such fine or defer the payment of it for one (1) year. Any payment made under this rule shall be carried to the member's credit.
15. Any member desirous to quit the corps under the provisions of the Act, shall be fined the amount, if any, by which his debit exceeds his credit: Provided that such fine shall not exceed Two (2) pounds, and that the whole or any part of such fine may be remitted at the discretion of the officer commanding.
16. Any member desirous of altering or rescinding any of the foregoing rules, or of adding any new rule, must give fourteen (14) days' notice of the same in writing to the officer commanding, who shall cause a copy of such proposed alteration, rescission, or addition, to be posted in the orderly room.

PRAHRAN AND SOUTH YARRA RIFLE COMPANY.
RULES.

1. The affairs of the company shall be conducted by a committee of seven, to be elected annually, four to form a quorum; the commanding officer and the secretary for the time being to be *ex officio* members of all committees. Committees for 1863-4 to be appointed at the first general meeting held after the passing of these rules, and annually in December at such dates as the officer commanding the company may fix by public

advertisement: the secretary to the company to be appointed annually at such general meeting.

2. Every candidate for admission to the corps shall make a written application to the officer commanding, stating name, place of abode, occupation, age and height; the names of all applicants to be posted in the orderly room for a week (subsequent to date of application), and at the next general meeting or parade of corps an election shall take place by show of hands, and a majority present at such meeting or parade may elect or refuse such candidate.

3. All members changing their permanent address must, within thirty days, give notice of the same in writing to the commanding officer, under a penalty of Two shillings and sixpence.

4. Any member of the company intending to be absent from his permanent address for a period of more than thirty days must give notice of such intention in writing to the commanding officer, who shall, at his discretion, direct the deposit of his arms, accoutrements, and uniform in a place to be appointed by the said officer commanding. Penalty for non-compliance with this rule, Ten shillings.

5. At every parade, on the roll being called, any member not answering to his name shall be deemed absent. Any member coming late and assigning a reason for so doing which is deemed sufficient by the officer commanding shall be considered as having been present at that parade. The corps will fall in at time fixed for parade.

6. Every member will be responsible for the good and serviceable order of his arms, accoutrements, and clothing (fair wear and tear excepted), and any damage done thereto shall be made good by him.

7. Any member, when off duty, wearing the uniform issued to him by the Government, or any portion thereof, without the permission of the officer commanding, shall be fined for the first offence One shilling, and for every subsequent offence Two shillings and sixpence.

8. No member to compete in any of the company rifle matches unless he has qualified as an effective, and duly liquidated any claims recorded against him.

9. Should circumstances prevent any member from attending a parade called for an inspection of arms, he must forward his rifle, sword, and accoutrements to such place and at such time as may be appointed by the commanding officer. A fine of Two shillings and sixpence will be incurred for non-compliance of this rule.

10. The officer commanding the company may at any time convene a special general meeting at his own instance, or shall do so upon receiving a requisition signed by ten members of the company, stating the object of the meeting; but no rule or by-law shall be made, altered, or rescinded unless seven days' notice shall have been given by advertisement or circular stating the business of such meeting; senior officer present to preside.

11. Any member who may be fined must pay the amount of such fine to the non-commissioned officer or others duly appointed by the commanding officer to receive the same, within fourteen days of its notification to him, and in default of such payment will be proceeded against according to law.

12. On the first of January in each year a Dr. and Cr. account shall be opened with every member, wherein all moneys received on his account, and all moneys paid on his behalf, and fines incurred by him, shall be debited and credited respectively.

13. All fines incurred during each month shall be posted in the orderly room (if not liquidated within the time specified in clause 11) as soon after the beginning of the following month as practicable.

14. An account shall be kept by the officer commanding of all moneys received from whatever source on behalf of the company, and on the second Monday in the months of July and January he shall exhibit to the company a statement showing the receipts and disbursements for the past six months; January statement to show also the individual value of each effective for the past year.

15. Any member wishing to transfer to another company will be allowed to do so on conditions the commanding officer of the company to which transfer is desired will pay to the credit of this company the value of his uniform at the time of transfer, or in default thereof the member so desiring to be transferred shall, previous to transfer, be made to pay a proportionate amount for same, according to length of time such uniform shall have been worn.

16. Every member joining the company to be supplied with a copy of these rules and regulations.

Printed forms of tender may be obtained from the Government Storekeeper, Melbourne, or from the officer in charge of police at each station, by whom also any information or explanation will be afforded to persons tendering.

The tenders for each station will be accepted or rejected separately.

Tenders may be for either of the supplies required, oats, bran, hay, or straw only; and if all be included in one tender, it will be accepted for one article only, if advisable.

As much forage as the storage will accommodate will be drawn at a time for the convenience of contractors.

The price must be per ton for hay and straw, and per bushel of 40 lbs. for oats, 20 lbs. for bran, and 54 lbs. for maize, including delivery at the stations and all charges; bags to be returned when empty.

The net weight only after deducting the tare is to be charged.

The names and addresses of the tenderers and of their proposed sureties must be stated at full length.

All tenders must be enclosed in a separate envelope, marked "Tender for ——" (as the case may be), and deposited in the box at the Government Stores, King street; or if sent by post they must be addressed to the Government Storekeeper, Melbourne.

The Government will not necessarily accept the lowest or any tender.

The decision of the Government will be made known by *Gazette* notice and by letter to accepted tenderers.

CONDITIONS.

1. The hay to be oaten, good, sound, and sweet; the straw to be wheaten, and both to be in all respects of the best quality; oats (colonial grown) and bran and maize to be sound and sweet and of the best description.

2. The supplies to be delivered on the requisition of the officer in charge of the district or station, the quantities stated in schedule being, however, only approximative, and it must be understood that the Government will draw either more or less than stated. The excess over the estimate will not, however, exceed during the whole year 50 per cent. of the estimated quarterly consumption.

3. The contracts entered into under this notice are not to be considered as being infringed or vitiated by any contracts made by the military commissariat.

4. The forage, when delivered, must be accompanied by an invoice of quantity, showing the gross weight, the tare, and the net weight (this should be on the back of the requisition or order), which, when signed by the officer in charge of the station for the net quantity received, will be returned to the contractor, and by him rendered in support of his account.

5. Each contractor will be required to prepare his own account in the prescribed form, and on presentation thereof to the officer in charge of the station or district, it will be forwarded for payment at the Treasury, Melbourne, or the Pay Office of the District, as may be indicated by the contractor on the account.

6. Should forage duly ordered under these contracts not be delivered within forty-eight hours from a reasonable time to be fixed on the order, it will be competent for the department (should circumstances require it) to purchase the same at the risk of the contractor, from whose account any expense over and above the contract price is to be deducted.

7. In the event of a difference of opinion between the contractor and the officer receiving the forage as to quality of the same, it is to be decided by a board of survey composed of persons named by the head of a department, and the decision of the board is to be considered final.

8. If the board shall decide that the forage is not of proper quality, it must be immediately replaced by the contractor, failing which it will be procured elsewhere, and the extra cost, if any, will be charged as in clause 6.

9. When a board of survey cannot be conveniently assembled, or when from some other cause injury would accrue either to the public service or the contractor by waiting for a board of survey, the officer in charge will have the power to reject such supplies as are obviously of inferior quality, it being understood that he will be responsible to the Government for so doing; and the contractor must take back the rejected forage, and supply good in its stead, failing which it will be obtained by the officer requiring it, and the expense will be charged as in clause 6.

10. A repetition of irregularity in the quantity or quality of the forage, or of delay in delivering or replacing it when required, will subject the contractor, upon report from the Government Storekeeper, to such mulct, not exceeding one-fourth of the monthly account, as the Government may direct. It will also be in the power of the Government, upon such repetition, to terminate the contract forthwith.

11. It will be competent for the Government Storekeeper on behalf of the Government, or for the contractor on his own behalf, to terminate the contract, by giving in writing a notice of three full calendar months to that effect, it being understood that such notice only can be given from the first day of a month, and provided that no such notice can be given before the 30th June, 1864.

At a meeting of the council of the city of Melbourne, held in the Council Chamber in the Town Hall, Swanston street, in the said city, this 30th day of November, 1863, at which were present—The Right Worshipful the Mayor, Alderman John Thomas Smith, presiding; Aldermen Richard Eades, Richard Evans Hill, John Harbison, and Michael Keesley; Councillors William Bayles, Henry Donovan Brown, Joshua Cowell, Edward Cohen, John Edwards, John George Goldsmith, William Grant, Michael Gallagher, George Hughes, Charles Edwin Jones, Isaac Lyons, Joseph Story, Samuel Thorp, James Weedow, and George Wrauge, being more than one-third of the members of the said council, it was resolved and ordered: That whereas by an Act of the Governor and Legislative Council of New South Wales, 14 Victoria No. 20, intituled, *An Act for regulating the formation, drainage, and repair of streets, courts, and alleys on private property within the city of Melbourne*, it is amongst other things enacted that where any street, court, or alley on private property in the city of Melbourne, shall not be, or shall not have been, sufficiently paved, flagged, macadamised, levelled, drained, and sewered, or otherwise completed or repaired to the satisfaction of the council of the said city, it shall be lawful for the said council at any time, and from time to time, by any order under the hand of the mayor or town clerk of the said city for the time being respectively, to order that any such street, court, or alley, or any part thereof, shall be freed from obstruction, paved, flagged, macadamised, levelled, drained, and sewered, or otherwise completed or repaired, in such manner and within such time as to the said council may appear expedient; and thereupon the owners of the tenements adjoining or abutting upon such street, court, or alley, on each side thereof, shall, in such manner and within such time as shall be expressed in such order, at their respective costs, charges, and expenses, remove all obstructions, and well and sufficiently pave, flag, macadamise, level, drain, and sewer, or otherwise complete or repair, so much of the said street, court, or alley, to the centre thereof, as may be opposite to and co-extensive with their respective tenements adjoining or abutting on such streets, courts, or alleys respectively:

And that the apportionment of the expenses incurred by the council of the city of Melbourne, in the formation, drainage, and repair of every such street, court, or alley on private property, shall be made proportionate to the extent of the area of the land of each of the several owners which shall be so situated as to have or be capable of obtaining access to such street, court, or alley, at the time of or in consequence of the formation or repair of such street, court, or alley:

SCHEDULE B, REFERRED TO IN THIS ORDER.

Manner in which the Streets, Courts, and Alleys enumerated in Schedule A, referred to in this Order, are ordered to be freed from obstruction, paved, kerbed, flagged, macadamised, levelled, drained, and sewered.

The natural soil is to be reduced or made up as the case may require, so that the longitudinal section of the whole street, court, or alley shall in no part have an inclination of less than one (1) in eighty (80), and where practicable the entire length is to form one incline.

In laying on any stuff it is to be spread in layers of not more than one foot thick.

The transverse section of the street, court, or alley (where the water-channels are on the sides) is to show a roadway whose crown shall be one inch above the kerbs of the footways, and the fall from the crown to the water-channels shall not be less than one (1) in twenty-five (25).

Each street, court, or alley shall have a bluestone pitched water-channel, either at each of its sides or in its centre, of sufficient capacity to meet the required drainage for the same, the width of said channel or channels in no instance to be less than two (2) feet.

The pitchers to be nine (9) inches wide, and from six (6) to nine (9) inches deep, and from nine (9) to fourteen (14) inches long, with upright sides set in sand, and well rammed down to such section as the city surveyor may direct.

The bottom of the channel is to be seven (7) inches below the kerb-stones of footpaths.

On either side of the roadway there is to be, where practicable, a footpath not more than three (3) feet wide, and these are to be separated from the roadway by a neatly dressed bluestone kerb from two (2) to four (4) feet long, six (6) inches wide, and fifteen (15) inches deep.

The footways are to be covered with a coat of gravel three (3) inches thick, and the surface is to fall towards the channel at the rate of one (1) in ten (10).

The roadway is to be covered with a coat of clean bluestone metal, 2½ inch gauge, nine (9) inches deep in the centre, and six (6) inches deep on the sides, and this, when necessary, covered over with a coat of good loam, two (2) inches thick, and rolled with corporation iron roller.

Whenever private entrances lead from the streets, courts, or alleys, they are to be paved to the full width (of building line) with bluestone pitchers, similar to those used in the channels.

All entrances from adjoining street shall be pitched and kerbed either with four (4) inch bluestone cubes or nine (9) inch pitchers, as the city surveyor may direct, the sides being well supported with eight (8) inch stone kerbing.

The whole of the work must be done under the inspection and subject to the approval of the city surveyor, who is authorised to order any deviation from these general principles which the peculiarities of any case may require.
