PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862* it is amongst other things enacted that when any Crown land remains unsold in or within five miles of any municipal district, or upon or within five miles of any gold field, or in or within five miles of any town not contained in any municipal district, the Governor in Council may proclaim such land to be a municipal common, or a gold fields common, or a town common respectively, as the case may be: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the area hereinafter described to be a Town Common for all householders in the town of Caulfield, in accordance with the above-recited provisions of the said Act, viz.:—Three hundred and forty-four acres, more or less, county of Bourke, parish of Prahran, being portions 81, 92 and 94, and the unsold and unappropriated land within the following boundaries, viz.: Commencing at the north-west angle of a reserve, being a point one chain south from the south-west angle of portion 23; thence by the north boundary of that reserve east twenty-eight chains seventy links; thence by a line crossing a road and by the east boundary of portion 31 north ten chains forty-eight links to the Dandenong road; thence by that road south-easterly to the north-east angle of portion 98; thence by the north boundary of that portion and a line crossing

a road west twenty chains forty-six links; thence by a road south thirty-eight chains ninety links; thence by a road west thirty-nine chains; thence by a road north fifty-five chains, more or less; thence by the road forming the north-east boundaries of portions 63 and 62, bearing N. 63° 20' W. twenty-three chains, more or less, to the south boundary of the reserve aforesaid; thence by the south and west boundaries of that reserve bearing west thirty chains and north sixteen chains to the point of commencement.—(65.K.8950.)

PETITION FOR A NEW BOROUGH.

STEIGLITZ.

NOTICE is hereby given, in accordance with the provisions of *The Municipal Corporations Act 1863*, section 11, that a petition has been presented to the Governor, signed by one hundred and sixty-nine inhabitant householders resident within the township of Steiglitz and its vicinity, praying His Excellency to constitute their locality, whereof the boundaries are hereinafter set forth, a Borough.

The boundaries of the proposed borough are described in the petition as follows, viz.—"Commencing from a point on the road leading south from the present township of Steiglitz to Geelong below that known as the Red Hill cutting to a point north of the Quartz Gold Reefs known as 'the Buckingham' and 'the Homeward-bound,' a distance of four and a half miles

north by one mile west of the Court House on the present township of Steiglitz by one mile east of the same; a centre line passing through the said Court House to the point on the road south and to the point on the before-mentioned Quartz Gold Reefs north measuring four and a half miles shall be the length of the said area of the municipality; and one mile east and one mile west of this line through its whole length shall be the breadth of the said municipality east and west."

Every tender must bear the *bond fide* signatures and addresses of the tenderer, and of two responsible persons willing to become bound for the fulfilment of the same in such sum as the Government may direct, not exceeding the gross amount of the contract.

Every tender must be accompanied by a bank deposit receipt for a sum equal to twenty per cent. of the amount for which the tenderer is willing to undertake the service; the money to be lodged to the credit of the Deputy Postmaster General, and to be absolutely forfeited to the Government in case the person whose tender may be accepted shall fail to complete, within ten days of the date of notice being given of the acceptance of his tender, the usual bond and contract to the satisfaction of the Government. The notice of acceptance if delivered at the address named in the tender shall be deemed sufficient.

The money deposited by unsuccessful tenderers will be returned to them on application, and on their signing receipts for the respective amounts, but not otherwise.

Persons tendering are requested to state the description of the vehicle they intend to use, and the number of horses by which it is to be drawn.

GENERAL RULES OF THE MARYBOROUGH HOSPITAL.

OBJECT.

THE institution shall be for the purpose of affording surgical and medical aid to destitute persons in cases of accident and disease.

CONTRIBUTORS.

2. Every benefactor of £10 and upwards, and every annual contributor of £1 and upwards, shall be and be alone regarded as "contributors for the time being" under the second section of the Act of Incorporation, and be eligible to be members of committee.

3. Benefactors and annual contributors shall, if the funds and accommodation of the hospital permit, be at liberty to recommend in every current year free patients, as follows:—That every benefactor of £20 and upwards be eligible for life to be a member of committee, and have the privilege of recommending in each year one in-door and two out-door patients.

4. Every executor paying to the institution a bequest of £50 or upwards, and every person (not being a paid collector) raising in any one year the sum of £50 or upwards, and every other person elected at an annual meeting at the recommendation of the outgoing committee, in consideration of special services rendered to the institution, shall be entitled to recommend annually two in- and four out-door patients.

5. Every benefactor of £10 or contributor of £1 per annum, shall be entitled to one vote; every benefactor of £30 or contributor of £3 per annum, shall be entitled to two votes; and every benefactor of £50 or contributor of £5 and upwards per annum, shall be entitled to three votes at all general meetings of contributors.

6. The current year shall, with respect to each benefaction, be reckoned from the day of payment; and with respect to each annual contribution, from the day on which such contribution was first made.

7. Every firm or partnership becoming contributors, shall exercise their privilege through some one member of the same only.

8. No person shall hold or be eligible for any honorary office, or have any vote or exercise any privilege connected with the institution, during the current year for which his annual contribution shall not have been actually paid.

9. At the annual meeting of contributors in January, all honorary offices, as president, vice-president, treasurer, medical officers, auditors, and referees, shall be chosen, and all matters pertaining to the hospital shall be open to discussion; and resolutions may be passed approving or disapproving of all or any of the things done during the year just terminated, recommending any future procedure which may appear desirable, and deciding absolutely on any business brought before it which may, consistently with the Act of Incorporation and the bye-laws, be transacted at it.

10. It shall be competent for the general committee by vote, or any forty or more contributors by writing under their hands, to require the secretary to summon a general meeting of contributors at any time or times between the annual meetings;

the occasion of calling every meeting shall be specified in the requisition, and no other business shall be transacted thereat; and every such meeting shall, with an intelligible reference to its object, be called by the secretary, by advertisement in one or more of the public newspapers of the colony, local if possible, at least one week before the day of meeting.

11. At all general meetings of contributors ten shall constitute a quorum, and as soon as a quorum is present the chair shall be taken; but if no quorum be present within half an hour of the time named, the meeting shall stand adjourned to the following week at the same day and hour, and so on from week to week until a quorum be formed.

12. All votes at the annual and other meetings of the contributors shall be taken by a show of hands, unless a ballot shall have been previously determined on by a majority present, in which case the vote or votes referred to shall be by ballot. Voting by proxy be permitted, providing such proxy is in the form of schedule A appended to these rules.

13. If the validity of any election at the annual meeting, or at any meeting of the general committee for filling up any vacancy during the year, shall be disputed, the question in dispute shall be referred to five referees, to be chosen at the annual meeting, of whom three shall be a quorum, whose decision shall be final. The office of any of the referees may be declared by the general committee vacant by his neglecting to attend four meetings in succession, to which he shall have been summoned by three days' previous notice, or in any of the ways, except absence, in which the office of any ordinary member of committee may become vacant under the twelfth section of the Act of Incorporation.

GENERAL COMMITTEE.

14. The administration of the affairs of the hospital shall be entrusted to a general committee, to be elected according to the provisions of the Act of Incorporation and bye-laws, and shall consist of ten members, including the president, vice-president, and treasurer.

15. The president, vice-president, and treasurer shall hold office for one year only, which shall become vacant in any of the ways in which the office of ordinary members of the general committee may become vacant under the twelfth section of the Act of Incorporation; and the president, vice-president, and treasurer shall go out of office (but may nevertheless be re-elected) on the second Thursday in the month of January in every year, at which time a fresh election shall be made by contributors.

16. If it shall happen that any member or members of the general committee, whose retirement may require to be determined by lot, shall be absent from the meeting at which it shall be necessary to determine by lot who shall go out of office, then the chairman of the meeting, if need be, shall inscribe the name or names of him or them so absent on the paper, and shall do all things necessary to be done on behalf of the absentee or absentees for determining the issue of the said lot, and the retirement or otherwise, and the decision then arrived at shall be valid and effectual as if such party or parties were present.

17. The secretary shall keep a collected list for each year of the attendance and non-attendance at ordinary meetings of the various members of the general committee, and a similar but distinct list in relation to special meetings; and in the event of any member of general committee or any honorary officer becoming disqualified, and his office becoming vacant, it shall be necessary, before the remaining members proceed to fill up the vacancy, that one month's notice of motion to that effect be given by some member of the general committee.

18. The general committee shall direct the general business of the hospital, frame rules for its internal regulation (the same not being repugnant to the bye-laws), alter, repeal, amend, and make new rules, enter into contracts for the supply of provisions and other articles for the use of the hospital, direct payment to be made for the same, fill up all vacancies in all honorary offices, as those of president, vice-president, treasurer, secretary, medical officers, auditors, referees, and visiting committee, between the annual meetings in January, and appoint and discharge all servants and paid officers of the institution. They shall meet during the first week of every month, and on such other days as they may appoint by way of adjournment. As soon as a quorum shall be present, the chair shall be taken by the president, or in his absence by the vice-president, or in their absence by a chairman appointed by the members then present; but if no quorum shall be present within thirty minutes of the time named, such meeting, as well as every special meeting herein-after authorised, shall stand adjourned to the following week at the same day and hour, and so on from week to week until the next monthly meeting. They shall superintend and give all necessary directions for the admission, discharge, and dismissal of patients, in accordance with the terms and spirit of the bye-laws.

19. No proposition to enact or amend a bye-law, or frame or vary any rule, shall be entertained unless one month's previous notice has been given of such; and no motion to rescind a resolution shall be submitted within three months after such resolution has been passed, unless one month's notice of the same be given, and such motion be passed by an absolute majority of the whole general committee.

20. All ordinary meetings of the general committee shall be notified to the members thereof by circular, by the secretary, three days at least before the day of meeting, but no member thereof absents himself for four consecutive ordinary meetings shall be at liberty to plead any insufficiency; or even entire lack of such notification against the cessation of his office under the twelfth section of the Act of Incorporation.

21. No person shall be a member of the general committee and a salaried officer of the hospital at the same time, nor shall any salaried officer or servant be present at any committee meeting, except when required. And no member of committee shall be allowed either directly or indirectly to contract for any supplies required by the hospital.

22. The general committee by vote, or three members thereof by writing under their hand, shall be at liberty at any time to require the secretary to summon a special meeting of the general committee, to be held within two weeks from the delivery thereof. Three days' notice at least of such meeting shall be given to each member by circular by the secretary, and the occasion for calling the meeting shall be stated both in the requisition and summons, and no other business than that so stated, or clearly indicated, shall be transacted at such meeting. But non-attendance at special meetings shall not in itself or in conjunction with any other induce a vacancy of office under the twelfth section of the Act of Incorporation.

23. The general committee shall present a general report of the affairs of the hospital at the annual meeting in January, which report shall be prepared by the treasurer, secretary, and medical officers, and be presented at a special meeting for revision and approval at least one week before the day appointed by the committee for the annual meeting.

VISITING COMMITTEE.

24. A house visiting committee consisting of four members shall be elected for six months by, from, and subject to the general committee. It shall be their duty to visit the hospital at least once a week, to examine the buildings, inspect the wards, make enquiries respecting the quality and quantity of the rations, enforce rules, investigate accounts, and bring up a report at the next monthly meeting of the same, and all other things connected with the management of the institution, and requiring attention for the consideration of the general committee. The office of any member of the visiting committee shall cease by his ceasing to be a member of the general committee, or by neglecting to attend to his duties for three months in succession.

HONORARY TREASURER.

25. The duties of the honorary treasurer shall be to receive all moneys from the collector, the Government, and any others; pay all accounts of the hospital passed by the general committee and those amounting to £1 and upwards by bank cheque, which cheques shall be signed by the president and secretary as well as by the honorary treasurer; to keep proper accounts of receipts and disbursements in a book provided for the purpose; lay the book or a summary of accounts before the general committee at every monthly meeting, and furnish a balance-sheet every year duly audited.

26. He shall deposit all moneys received by him whenever the same shall amount to £10 in such bank as the general committee shall from time to time direct, and shall cause the different sums so deposited to be paid to the account of the Maryborough Hospital.

SECRETARY.

27. The duties of the secretary are to keep proper minutes of all meetings and attendances, and record them in a book provided for the purpose; to call all meetings, to introduce and explain the business to be transacted, and to conduct and record all such correspondence as may be directed by the general committee; and to prepare, in conjunction with the honorary treasurer and medical officers, the report for the annual meeting.

The common seal of the corporation shall be kept in a proper safe at the hospital. The common seal shall not be affixed to any deed or other instrument except by order of the general committee at a meeting at which four members at least shall be present.

COLLECTOR.

28. The collector shall canvass for contributions and afford clerical assistance, &c. He shall give a receipt for every sum he receives, and keep a counterpart of such receipt. He shall hand over to the treasurer in the first week of every month the moneys received by him during the preceding month, and at the same time supply the treasurer with a statement of the contributors and the respective sums paid by them; and he shall enter into a bond with one surety jointly and severally in the sum of £100, or give some other security equivalent thereto, for the due fulfilment of his office.

AUDITORS.

29. The auditors shall, in the first week of January in every year, or as soon after as conveniently may be, examine the collector's books, and also the treasurer's balance-sheet, with all accounts, vouchers, and documents relating thereto, and shall report thereon to the general committee at the meeting appointed by them. The office of any auditor shall become vacant by neglecting to attend four meetings in succession, to which he may have been summoned three days previously, or in any of the ways except that of absence, in which the office of any ordinary member of committee may become vacant under the twelfth section of the Act of Incorporation.

MEDICAL OFFICERS.

30. The number of honorary medical officers shall be two, who shall hold office for one year only, and shall go out of office (but may nevertheless be re-elected) on the second Thursday in the month of January in every year, at which time a fresh election shall be made by the contributors.

31. The honorary medical officers and the resident surgeon, all of whom shall be legally qualified practitioners, shall constitute the medical staff of the hospital.

32. The resident surgeon shall receive the certificates from applicants for admission, examine the nature of their cases, and decide on their fitness for admission, either as in-door or out-door patients, subject to the approval of the house committee; and he shall discharge all patients as soon as he considers them fit to be discharged.

33. He shall have charge of patients in the hospital, and of their treatment; but in all cases of difficulty or danger, or long continuance in the hospital, he is requested to consult the honorary surgeons.

34. The honorary medical officers shall have admission at all times to the institution, they shall assist the resident surgeon in the performance of all capital surgical operations; but no such operation shall be performed without previous consultations of the medical staff; and they shall regularly consult in

all cases of importance or of protracted continuance in the hospital.

35. If any honorary medical officer and resident surgeon shall differ upon the mode of treatment in any case, the resident surgeon shall call a consultation of the medical staff, at which the treatment shall be decided by the majority present.

36. The medical staff shall hold a consultation on every contemplated surgical operation of a capital nature, except in great emergency; also upon every other case of importance or protracted continuance in the hospital; and also upon every suggested post-mortem examination, save such as may be directed by the coroner of the district.

37. A consultation of the medical staff shall take place in all cases of capital surgical operations; but if any honorary medical officer shall not attend within a reasonable time after being duly summoned, or if, in the opinion of the house surgeon, the safety of the patient may be endangered by delay, the latter may forthwith perform the duty.

38. The honorary medical officers shall make a daily report in a book to be provided for the purpose.

PATIENTS.

39. Every person claiming the benefit of the hospital, whether as in-door or out-door patient, must produce a recommendation from a contributor. Accidents, however, and such cases of decided emergency as in the opinion of the resident surgeon admit not of delay, may be attended to, and if necessary admitted at any time, whether recommended by a contributor or not.

40. No pregnant female for the purpose of confinement, no child under three years of age, no person insane or having a contagious, infectious, or other disease which in the opinion of the honorary medical officers, or in their absence, of the resident surgeon, ought not to come within the operation of the charity, shall be admitted to the hospital as an in-patient, nor any person who in his opinion may receive equal benefit as an out-patient.

In the absence of satisfactory reasons to the contrary being offered to the house committee, no person shall be allowed to remain in the hospital who, in the opinion of the medical staff, may receive equal benefit as an out-patient. Every person obtaining the benefits of the institution under a plea, expressed or implied, of destitution, who shall, in the estimation of the general committee, upon a representation being made to them of the fact, be well able to pay for such benefits, shall be liable for the same after the rate of Two pounds per week; and every person admitted on the ground of emergency to the benefits of the hospital, and well able, in the estimation of the general committee, to pay for them, will also be required to pay for the same after the same rate.

41. The general committee shall, if necessary, make provision for the reception and treatment of patients laboring under contagious, infectious, or other diseases excluded under clause 40, on the hospital ground, but at a suitable and safe distance from the hospital itself.

42. Ministers of religion shall have access to sick persons of their respective denominations at such times as shall be appointed by the committee, and any minister may attend any patient at any time when requested by such patient, and that in cases of the death of any patient, a notice shall be forwarded to the clergyman of the denomination the deceased patient is supposed to belong, stating the hour of burial.

VISITORS.

43. That Sunday, Monday, and Friday in each week, between the hours from Two to Five o'clock p.m., be the days and hours set apart for persons desirous of visiting the hospital or any patient; but in cases of extreme danger, the friends of such patient may obtain admission to the hospital by an order signed by a member of committee or permission of the resident surgeon.

OUT-PATIENTS.

44. Out-patients will receive attendance on Mondays and Wednesdays, between the hours of Ten and Twelve o'clock, and on Saturdays between the hours of Ten to Twelve and Two to Four.
