ACTS OF PARLIAMENT LEFT TO THEIR OPERATION.

THE Principal Secretary of State for the Colonies has, in a Despatch bearing date the 25th day of July, 1865, intimated to the Governor that Her Majesty will not be advised to exercise Her power of disallowance in respect of the Acts of the Parliament of Victoria, passed in the 28th year of Her Majesty's reign, the numbers, titles, and dates, of which are hereto subjoined, viz.:-

No. 236. An Act to apply out of the Consolidated Revenue the sum of Sixty thousand pounds to the service of the year One thousand eight hundred and sixty-four, and Five hundred thousand pounds to the service of the year One thousand eight hundred and sixty-five. [Assented to 31st January, 1865.]

No. 238. An Act to remove doubts as to the validity of certain Mining Bye-laws. [Assented to 23rd March, 1865.]

WHEREAS by *The Electoral Act 1865*, it is amongst other things enacted that where any accidental or unavoidable impediment, misfeasance, or omission shall have happened in the preparation or transmission or printing of any general roll or supplementary roll or ordinary electoral roll or roll of rate-paying electors, the Governor in Council may take all such measures as may be necessary for removing such impediment or rectifying such misfeasance or omission, or may declare any such roll valid as to and notwithstanding such impediment, misfeasance, or omission, and every such Order in Council shall state specifically the nature of the impediment, misfeasance, or omission, and shall be forthwith published in the *Government Gazette*: And whereas, in the instances hereinafter particularised, the Rolls of Rate-paying Electors were omitted to be transmitted to the registrars on or before the day named for the purpose in the said Act: Now therefore His Excellency the Governor, by and with the advice of the Executive Council, doth by this present Order declare that, notwithstanding such omissions as aforesaid, the Rolls transmitted after the day named for the purpose in the instances set forth in the schedule hereunto subjoined, are valid, that is to say:—

THE SHIRE OF BELLARINE.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Local Government Act 1863* it is amongst other things enacted that if at any time in any district, whether single or united, which shall contain an area of not less than one hundred square miles, the total amount actually paid in respect of the general rate then last made shall have amounted to One thousand pounds, it shall be lawful for the Governor in Council to proclaim, if it shall seem fit, such district, by such name as in and by such Order in Council may be assigned thereto, to be a shire within the meaning of the said Act, and such district shall thereupon be and be called such shire accordingly; and no district, after the proclamation thereof as such shire, save as therein provided with regard to the adjustment of boundaries to those of electoral districts, shall be united with any other shire or district, or with any borough or municipal district: And whereas by a Proclamation under the hand of the Governor and the seal of the colony, bearing date the twenty-ninth day of October, 1860, a Road District was proclaimed under the designation of "The Indented Heads Road District." And whereas by another Proclamation bearing date the eighth day of July, 1861, the said Road District was altered as therein mentioned: And whereas by an Order of the Governor in Council made on the twenty-seventh day of February, 1865, the said Road District was divided into the three electoral subdivisions therein defined: And whereas the area of the said district and the amount of the last general rate therein are not less than the area and amount in the said Act mentioned, and it seemed fit to make an Order in Council this day to proclaim the said district to be a shire accordingly: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the district heretofore proclaimed and called the Indented Heads Road District to be a Shire within the meaning of the said Act, by the name in and by such Order in Council assigned thereto, that is to say:—

SECTIONS V. TO X. OF "THE POLICE OFFENCES STATUTE 1865" EXTENDED.

PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by an Act of the Parliament of Victoria, passed in the session held in the twenty-eighth year of Her Majesty's reign (No. 265), called *The Police Offences Statute 1865*, it is amongst other things enacted that the Governor in Council may by Proclamation in the *Government Gazette* extend all or any of the provisions contained in Part I. of the said Statute to any city, town, district, or place in Victoria, and may define the limits of any such city, town, district, or place, and vary and alter such limits, and may revoke any such Proclamation; and upon any such Proclamation the provisions so proclaimed shall extend to and be in force in such city, town, district, or place: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, do, with the advice of the Executive Council, by this my Proclamation extend the provisions contained in sections V., VI., VII., VIII., IX., and X. of Part I. of the said Statute to the Road District hereinafter mentioned, that is to say:—

THE CAMPBELL'S CREEK ROAD DISTRICT.

The deaths in August exceeded by 19 those in July. They were also more numerous than those reported in any previous month of August. The mean temperature was within a tenth of a degree of the average.

Males and females died in the proportions of 58 and 42 per cent. respectively. The mortality of children under five was 49 per cent. of the whole, against 34 per cent. in August, 1864, 38 per cent. in August, 1863, 43 per cent. in August, 1862, 49 per cent. in August, 1861, and 49 per cent. in August, 1860.

Twenty-two deaths occurred on the 12th, fifteen on the 4th, and fourteen on the 21st of the month; on no other day was there a greater mortality than twelve; only two deaths were reported for the 15th, and three for the 31st.

A male aged 80 died during the month, also a female of 78 and a female of 83. The deaths of these persons were all referred to old age.

The number of violent deaths which occurred was thirteen, of which the following are the particulars:-A boy of 14 and a woman of 39 were drowned, the former at Brighton, the latter in the River Yarra. An infant of 5 weeks and another of 11 weeks

were suffocated, the former in bed, the latter in a manner not stated; a boy aged 6 years was suffocated in night-soil. A boy of 5 years old died of injuries received from the wheel of a waggon, a boy of 9 from a fall in a gymnasium, a boy of 11 from a fall from a horse, a laborer aged 30 from his arms being crushed under the wheel of a dray, a gentleman aged 56 from fractured ribs and internal injuries, and a solicitor aged 63 from accidental injuries to the brain. A squatter aged 37 committed self-destruction by cutting his throat, and a chemist aged 19 by taking prussic acid.

The deaths in public institutions numbered 78, or 27 per cent. of the whole. Of these 39 took place in the Melbourne Hospital, 2 in the Benevolent Asylum, 12 in the Yarra Bend Asylum, 4 in the Lying-in Hospital, 5 in the Immigrants' Home, and 16 in the Industrial Schools.

NOTE.—The Melbourne Hospital is in Melbourne Proper, the Benevolent Asylum in North Melbourne and Carlton, the Yarra Bend Lunatic Asylum in Jika-jika parish (remainder of), and the Industrial Schools in South Yarra and Prahran.

Of the 144 children dying under five years of age, 78, or rather more than 54 per cent., were males, and 66, or not quite 46 per cent., were females; 87 were under one year of age, 22 were between one and two years, 15 were between two and three, 9 were between three and four, and 11 were between four and five.

Of the 145 persons whose deaths occurred at a more advanced age than five years, 90, or about 62 per cent., were males, and 55, or nearly 38 per cent., were females; 12 were between five and ten years, 7 were between ten and fifteen, 5 were between fifteen and twenty, 9 were between twenty and twenty-five, 13 were between twenty-five and thirty, 17 were between thirty and thirty-five, 23 were between thirty-five and forty, 14 were between forty and forty-five, 10 were between forty-five and fifty, 10 were between fifty and fifty-five, 4 were between fifty-five and sixty, 8 were between sixty and sixty-five, 4 were between sixty-five and seventy, 6 were between seventy and seventy-five, and 3 were seventy-five and upwards.

As compared with that shown in the previous month's report, the mortality from zymotic diseases increased from 25 to 26½ per cent. of the total, caused principally by whooping-cough having resulted fatally in 30 instances against 19 in July. Deaths from constitutional diseases also increased in numbers, especially those from phthisis, which caused 26 deaths in July, and combined with hæmoptysis, occasioned 34 deaths in August. Most deaths were caused by local diseases in both months; but the number under this head was less by four in August than it was in July.

ARARAT OLD CEMETERY.

RULES AND REGULATIONS OF THE ARARAT OLD CEMETERY, MADE UNDER THE PROVISIONS OF 27TH VICTORIA No. 201.

ALL the charges must be paid when orders are given, or before the ground is broken, or a vault re-opened.

2. On application for permission to make a vault or erect a monument in the cemetery being made to the trustees, a certificate of permission will be granted on payment of the proper fees.

3. All orders for interment to be given at the office of the trustees on the previous day, when a form of instruction, according to schedule A, must be filled up and given to the sexton.

4. The sexton shall dig all ordinary graves, on payment of the proper fees; parties requiring brick graves or vaults will be required to construct them under the direction of the trustees or any two of them.

5. The time fixed for the funeral must be the time the procession is to be at the cemetery, and the same must be punctually observed.

6. The usual hours for the performance of funerals shall be from 10 a.m. to 6 p.m. from September to April inclusive, and from 10 a.m. to 4 p.m. in the other four months.

7. All monuments, vaults, graves, and gravestones must be kept in repair and proper condition, at the expense of the owners.

8. Plans of every headstone or monument must be submitted to the trustees for their approval.

9. All persons destroying the fences, defacing the monuments, or in any way injuring the cemetery, will be prosecuted as the law directs.

10. Every coffin in a vault must be bricked in or cemented, or covered with a slab of stone, slate, or iron.

11. A plan of the ground and a register will be kept, which may be examined on payment of the charges set forth in the scale of fees.

12. The ground will be open on Sundays from sunrise to sunset; persons desirous of visiting the cemetery at other times can do so by applying to the sexton.

13. The trustees reserve to themselves the right of making any alterations from time to time in these regulations and charges, subject to the approval of His Excellency the Governor in Council.

Tenders are required to be written on a form, printed copies of which may be had gratuitously on application at any post office in the colony, and may be forwarded (if by post, prepaid) addressed to the Deputy Postmaster General, with the words "Tender for the Conveyance of Mails" endorsed on the cover, or placed in the Tender Box at the General Post Office.

Tenderers are requested to describe, by their numbers, as below, the mail services for which they tender, and every tender will be taken to include the entire service as called for.

Every tender must bear the *bona fide* signatures and addresses of the tenderer, and of two responsible persons willing to become bound for the fulfilment of the same in such sum as the Government may direct, not exceeding the gross amount of the contract.

Every tender must be accompanied by a bank deposit receipt for a sum equal to twenty per cent. of the amount for which the tenderer is willing to undertake the service; the money to be lodged to the credit of the Deputy Postmaster General, and to be absolutely forfeited to the Government in case the person whose tender may be accepted shall fail to complete, within ten days of the date of notice being given of the acceptance of his tender, the usual bond and contract to the satisfaction of the Government. The notice of acceptance if delivered at the address named in the tender shall be deemed sufficient.

The money deposited by unsuccessful tenderers will be returned to them on application, and on their signing receipts for the respective amounts, but not otherwise.

Persons tendering are requested to state the description of the vehicle they intend to use, and the number of horses by which it is to be drawn.

A separate tender must be sent in for each service, but notwithstanding this condition any offer will be entertained for the performance of any number of services for a lump sum. The number of the service or services tendered for must be plainly endorsed on the outside of the cover.
