## NOTICE TO MARINERS.

### PORT PHILLIP BAY.

A SUNKEN wreck has been discovered in Port Phillip Bay, lying in five fathoms at low water, about midway between Point Cook and Prince George Buoy.

The only part visible is the end of the main boom, which shows about two feet above water in the hollow of the sea when there is any swell on.

A buoy colored green has been placed near the spar, where it will remain until the wreck has been removed or destroyed. The buoy lies in the following position:—

## THE TOWNSHIP OF MATLOCK.

## PROCLAMATION.

By His Excellency SIR CHARLES HENRY DARLING, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief of the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Amending Land Act 1865* it is amongst other things enacted that the Governor in Council may from time to time, before or after the proclamation of any agricultural area, proclaim as a road or as a town or village any portion or portions of such area not selected, purchased, or leased, and not exceeding, if proclaimed as a town or village, six hundred and forty acres of the lands comprised in such area, and the lands in such town or village shall be sold by auction in the manner provided for the sale by public auction of lands not reserved for proclamation in such areas: Now therefore I, Sir Charles Henry Darling, the Governor of Victoria, with the advice of the Executive Council, do hereby proclaim the land hereinafter described to be a town under the designation prefixed thereto, that is to say:-

THE TOWNSHIP OF MATLOCK-Commencing at a point on the west boundary of the township, bearing west eight chains forty links from the north-west angle of allotment 1 of section 1A; thence by a line bearing north nineteen chains twenty links; thence by a line bearing east one hundred and forty-two chains; thence by a line bearing south fifty-six chains; thence by a line bearing west fifty-two chains; thence by a line bearing N. 83° 24' W. ninety chains eighty links; and thence by a line bearing north twenty-four chains eighty links to the point of commencement.

Given under my Hand and the Seal of the Colony, at Melbourne, this twenty-fifth day of September, in the year of our Lord One thousand eight hundred and sixty-five, and in the twenty-ninth year of Her Majesty's reign.
