FARMERS' COMMONS ALTERED.

PROCLAMATION

By His Excellency the Honorable SIR JOHN HENRY THOMAS MANNERS SUTTON, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Colony of Victoria, &c., &c., &c.

WHEREAS by *The Land Act 1862*, it is amongst other things enacted, that the Governor in Council may at any time increase, diminish, alter, or abolish any common proclaimed before or after the passing of the said Act: Now therefore I, the Governor of Victoria, with the advice of the Executive Council, do hereby alter the Farmers' Commons hereinafter mentioned in manner following, that is to say:—

FRANKLIN FARMERS' COMMON—The Franklin Farmers' Common, described in a Proclamation bearing date the 4th of March, 1861, is hereby increased by adding thereto the unappropriated Crown lands within the boundaries hereinafter described, viz.: Commencing at the south-west angle of allotment 16 of section 5, in the parish of Yandoit, the said angle being a point on the north boundary of the existing common; thence by the said boundary of that common, bearing west one hundred and thirty-five chains, more or less, to the north-west angle thereof; thence by a line bearing north sixty chains to the south-west angle of the Yandoit Gold Field Common; thence by the south boundary of that common bearing east one hundred and thirty-five chains, more or less, to the north-west angle of allotment 21 of section 5, parish of Yandoit; and thence by the west boundaries of allotments 21, 20, 19, 18, 17, and 16 to the point of commencement. Area, 810 acres, more or less.—(65.M.4384.)

BUNG BONG FARMERS' COMMON—The Bung Bong Farmers' Common, described amongst others in a Proclamation bearing date the 14th of December, 1863, is hereby altered by deducting therefrom the portion thereof lying on the west of the Bet-bet Creek, and adding thereto 2100 acres, more or less, being the unappropriated Crown lands within the boundaries hereinafter described, viz.: Commencing at the north-east angle of the portion of the existing common lying on the east of the Bet-bet Creek; thence by a line bearing east seventy-two chains; thence by a line bearing south three hundred and thirty-seven chains, more or less, to the northern side of the road from Amherst to Avoca; thence by that road bearing north-westerly to its junction with the road from Maryborough to Avoca; thence by the last-named road bearing north-easterly thirty-two chains, more or less, to a point bearing south from the south-east angle of the portion of the existing common lying on the east of the Bet-bet creek; thence to that angle, and thence by the east boundary of that portion bearing north two hundred and seventy-one chains, more or less, to the point of commencement.—(66.N.7011.)

By virtue and in pursuance of *The Transfer of Land Statute*, I, John Carter, Esquire, the Commissioner of Titles, with the consent of the Governor in Council, do hereby make the regulation hereinafter set forth respecting the parcels of land that may be included in one certificate of title.

REGULATION.

The parcels of land to be in the same parish, and not to comprise more than one Crown section, block, or portion, or one section, block, or portion of a private subdivision. Contiguous country lands not exceeding altogether one thousand nine hundred and twenty acres, whether in the same parish or not, and whether comprising more than one Crown section, block, or portion, or not, may, however, be included in the same certificate. A road not to be considered a break in the contiguity.

Tenders are required to be written on a form, printed copies of which may be had gratuitously on application at any post office in the colony, and may be forwarded (if by post, pre-paid) addressed to the Deputy Postmaster General, with the words "Tender for the Conveyance of Mails" endorsed on the cover, or placed in the Tender-box at the General Post Office.

Tenderers are requested to describe by their numbers, as below, the mail services for which they tender, and every tender will be taken to include the entire service as called for.

Every tender must bear the *bond fide* signatures and addresses of the tenderer, and of two responsible persons willing to become bound for the fulfilment of the same in such sum as the Government may direct, not exceeding the gross amount of the contract.

Every tender must be accompanied by a bank deposit-receipt for a sum equal to twenty per cent. of the amount for which the tenderer is willing to undertake the service; the money to be lodged to the credit of the Deputy Postmaster General, and to be absolutely forfeited to the Government in case the person whose tender may be accepted shall fail to complete, within ten days of the date of notice being given of the acceptance of his tender, the usual bond and contract to the satisfaction of the Government. The notice of acceptance, if delivered at the address named in the tender, shall be deemed sufficient.

The money deposited by unsuccessful tenderers will be returned to them on application, and on their signing receipts for the respective amounts, but not otherwise.

Persons tendering are requested to state the description of the vehicle they intend to use, and the number of horses by which it is to be drawn.

In cases where vehicles are intended to be used, tenderers are requested to state what additional charge, if any, would be made for the free conveyance of Members of Parliament along the line of road between the districts they represent and Melbourne.

A separate tender must be sent in for each service, but notwithstanding this condition, any offer will be entertained for the performance of any number of services for a lump sum. The number of the service or services tendered for must be plainly endorsed on the outside of the cover.

The tender of any person failing to comply with the foregoing conditions will not be entertained.
